ACTION

Monkey Mia Reserve (\$\psi\$1686) formerly comprised Lots 60 & 80 on Deposited Plans 218229 & 186168 (see map at p. 136). The reserve has been amended, first to comprise Lots 102, 103 & 106 on Deposited Plan 219786 (see map at p. 137), and then Lots 123 & 132 on Deposited Plan 54332 (see map at p. 123).

Total Area: 469.2363 ha (changed from 475.7104 ha before either of the amendments)

REASON FOR ACTION

The change in area results from both the excision of areas near Monkey Mia Resort (Reserve 40727) and the survey of unsurveyed lines along the reserve's western and parts of its southern boundaries, as well as along the section of the Denham-Monkey Mia Road through the reserve.

The excisions were in response to proposals agreed to by the State Cabinet in 1997 for the future development of tourism. They comprise the following areas, shown on page 123:

- Lot 500 on Deposited Plan 55359, now Reserve 49107, for "Tourism", with a management order to the Shire of Shark Bay;
- Lot 131 on Deposited Plan 54332, now Reserve 49144, for "Conservation Park and Visitor Centre", vested in the Conservation Commission of W.A.;
- Edel Lot 106, intended to be reserved for "Aquaculture and Associated Tourism Activities", with a management order to the Shire of Shark Bay.






