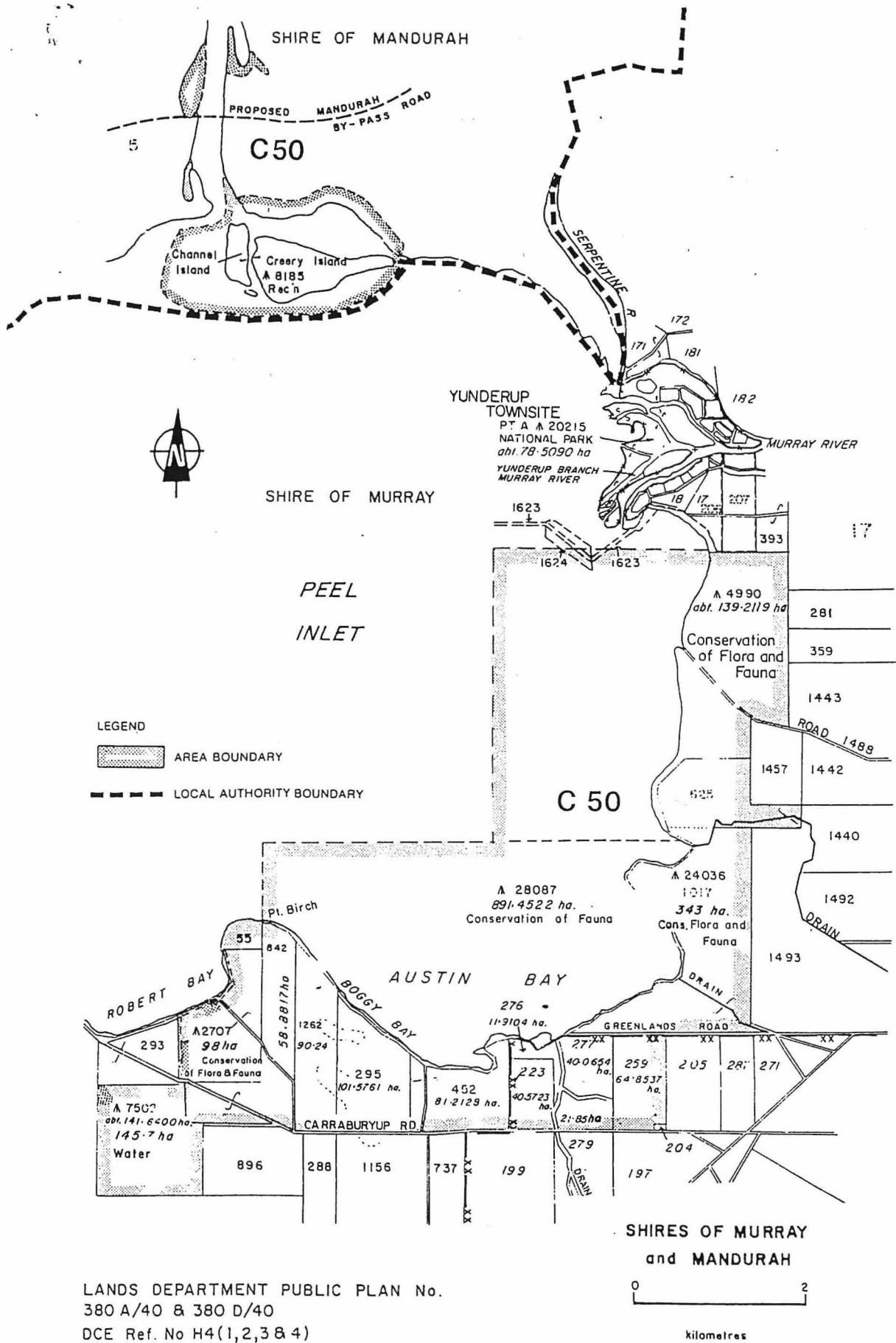

Further to my memo of 1 July 1991 the Department of Mines now has no objections to the cancellation of Reserve 7502 and its inclusion into Carrabungup Nature Reserve 2707 (see enclosed).

Once the two reserves have been amalgamated 2707 should be upgraded to A class.

Also to proceed is the inclusion of reserves 24036 and 28087 in Austin Bay Nature Reserve 4990. Reserve 4990 should then also be upgraded to A class.

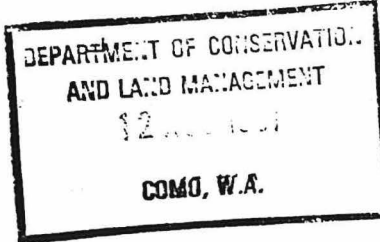

SYSTEM SIX REC C50 RESERVES 24036, 2707, 7502 AND 4990


I refer to your memo of 1 March 1991 to the Department of Land Administration concerning the implementation of the above recommendation. Whilst no objection was raised to the amalgamation of the above reserves the stipulation was that the resulting reserve be C class.

I note, however, that the upgrading of nature reserves 24036, 2707, 4990 and 28087 to A class has already been approved by Cabinet (lists 2 and 4).

Reserve 7502 is a water reserve adjacent 2707. This Department's current proposal is that reserves 24036 and 28087 be amalgamated into 4990, Austin Bay Nature Reserve, and upgraded to A class. Reserve 7502 is to be added to 2707, Carrabungup Nature Reserve. Presumably you have no objection to the amalgamation and upgrading of 24036, 28087 and 4990 as each reserve has previously been individually approved for A class status.

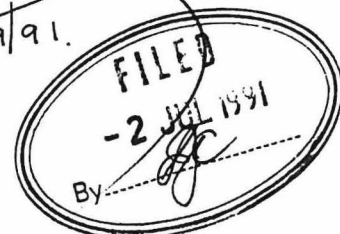
Reserve 7502, however, has not previously been considered by your department for A class status. Would you please advise whether you support the inclusion of reserve 7502 into 2707 and the subsequent upgrading of 2702 to A class. Alternatively, 2707 will proceed to A class and 7502 will have its purpose changed to C class nature reserve.

I would appreciate your early response.


Further to my memo of 19 June. It has come to my attention that upgrading of nature reserves 2707, 4990, 24036 and 28087 to A class has previously been agreed to by the Mines Department and endorsed by Cabinet as a consequence of the Bailey review of C class nature reserves.

As this apparently contradicts the Mines Department memo to you of 1 March, I would be grateful if you would defer action on:

1. Upgrading of reserve 2707 to A class
2. Cancellation of reserve 7502 and its inclusion into 2707

until such time as I can clarify the matter with DOMWA.

Reserves 24036 and 28087 can be cancelled, these respective areas added to 4990 and 4990 upgraded to A class.

I refer to your memo of 5 April. I cannot agree to the down grading of existing B class nature reserves, however I would be grateful if you would proceed to cancel unvested "water" reserve C7502 and include its area in adjacent nature reserve C2707.

This will meet the intent of Red Book Recommendation 6 C 50.4 with subsequent amalgamation and upgrading of the nature reserves to A class to be pursued further at a later date.
