Lot 500 on Deposited Plan 40430 is part of Hamlin Bay West Road. This portion of road is within the Hamlin Bay Caravan Park. DEC leases this park and the responsibility for maintenance of this portion of road lies with DEC and the lease holder.

Lot 300 on Deposited Plan 8114 is part of Skippy Rock Road. The road is maintained by DEC.

These road portions were closed and added Leeuwin Naturaliste National Park to rationalise management of DEC roads within the park.






