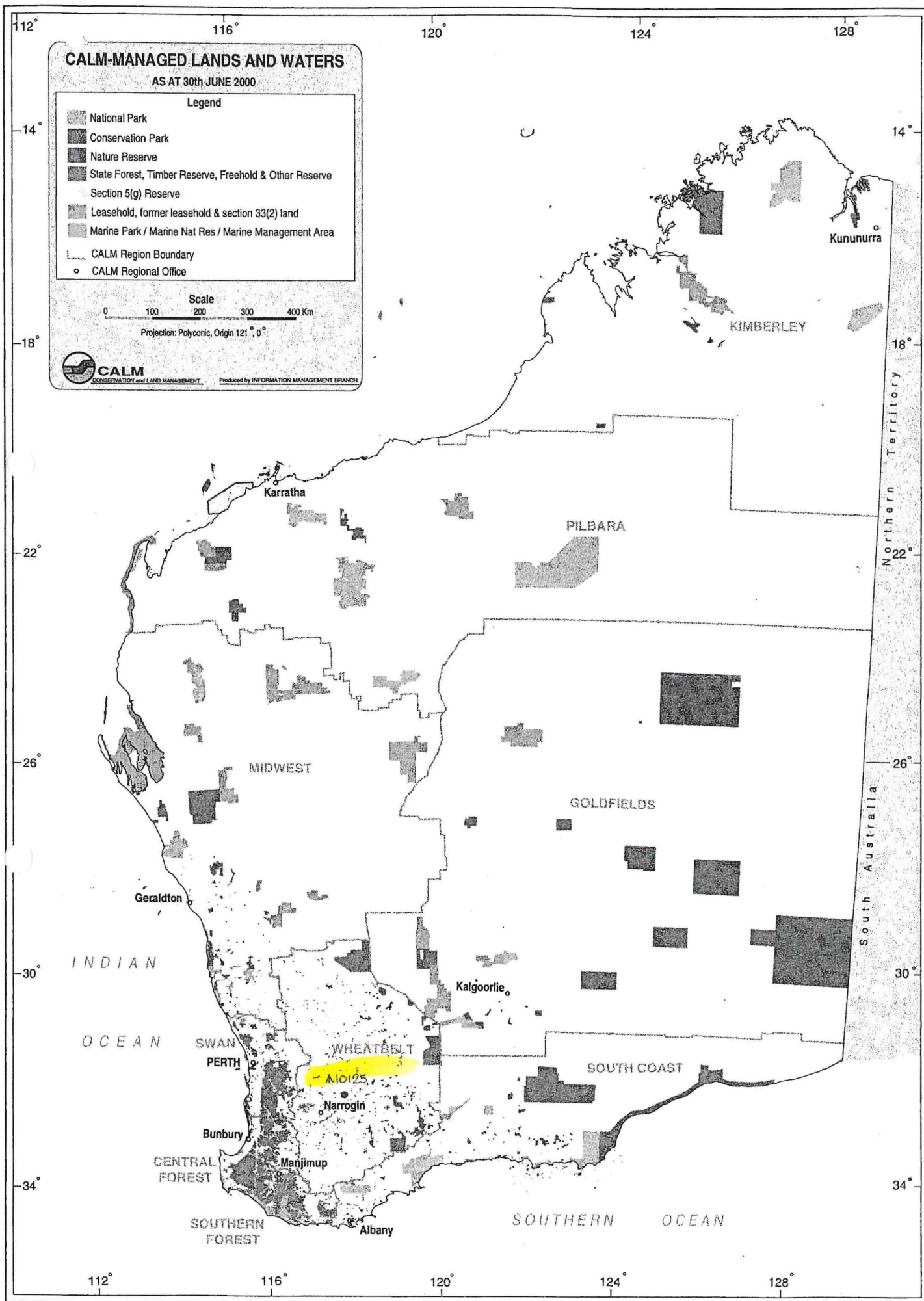
REASON FOR ACTION

Change of purpose of reserve 10125 from "Water" to "Conservation of Flora and Fauna" with a management order issued to the Conservation Commission (previously vested in the Minister for Water Resources). Area: 32.84 hectares

Reserve 10125, in the Shire of Corrigin, contains four different vegetation types; 32 naturally occurring plant species have been recorded. The reserve is of high value for conservation particularly because there are very few conservation reserves in the Shire.

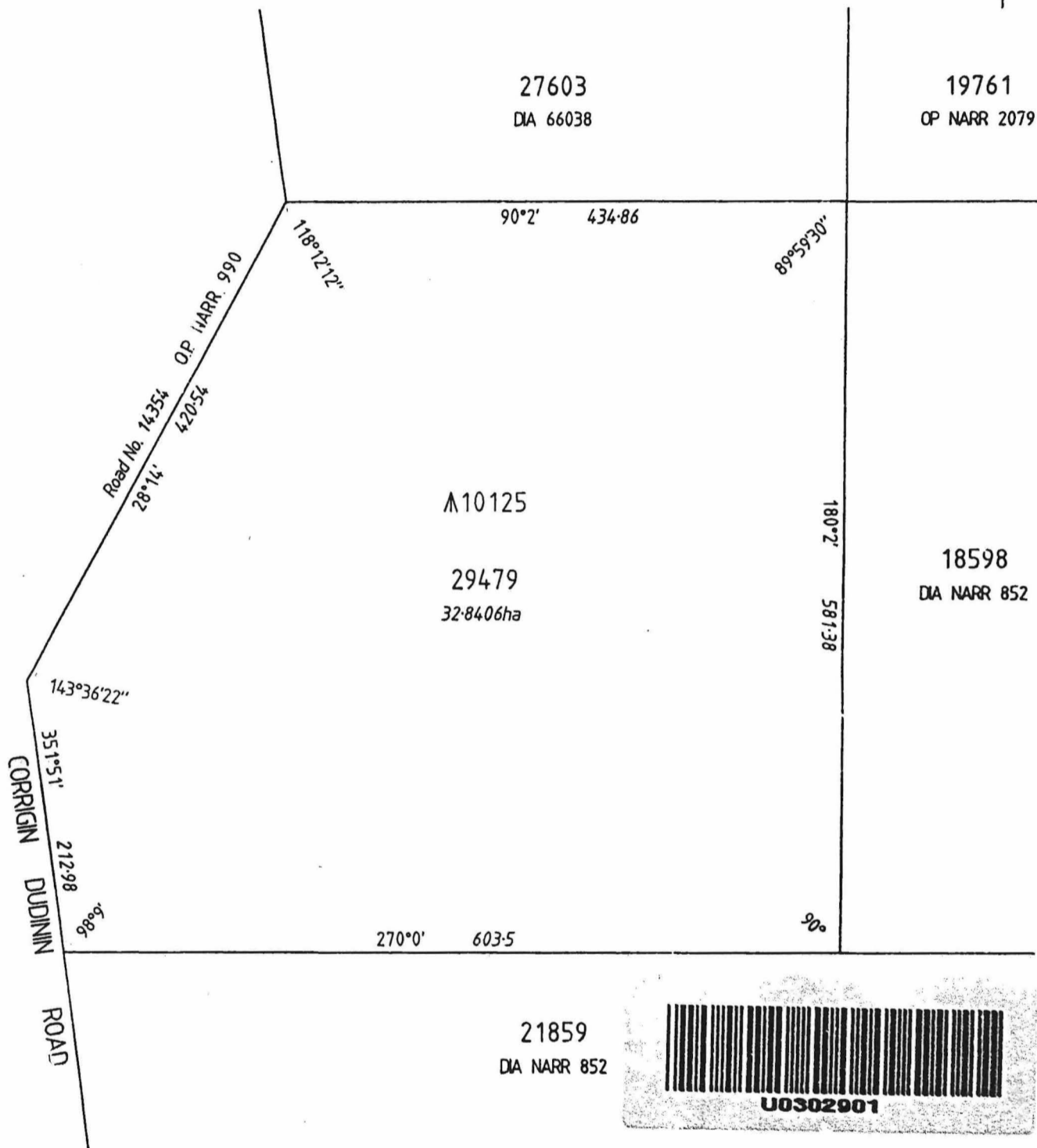
