It is hereby notified for public information, that as of 19 November 1997, the following actions were assented to and enacted.

1. Class A Reserve 2682 (Albany Lot 1373) "Public Park" is amended by excising that portion now described as Lot 1449 as surveyed on Land Administration Diagram 92968, and of its area being reduced to 114.8927 hectares accordingly.

All that portion of Bolganup Road (Road No 11946) as surveyed and shown on Diagrams 2871 and 2872, comprising 2.8859 hectares or thereabouts, starting from the prolongation southerly of the eastern boundary of the northern severance of Porongurup Estate Lot 13 and extending generally north-easterly through Lots 14 and 15 of that Estate and north-easterly along the boundary of Lot 16 of that Estate to the prolongation south-easterly of the southernmost south-western boundary of Lot 17 of that Estate.

- 10 6. The purpose of Reserve No. 12397, classified as of Class A, comprising 3.710 9 hectares set apart for "Water" and vested in the Minister for Water Resources, is changed to "Conservation of Flora and Fauna, and Water".

CLAUSE 6

Reserve No. 12397 was proclaimed Class 'A' in April 1960 and vested in the Minister for Water Supplies for the purpose of "Water". The reserve comprises Avon Location 28942 and contains an area of 3.7109 hectares.

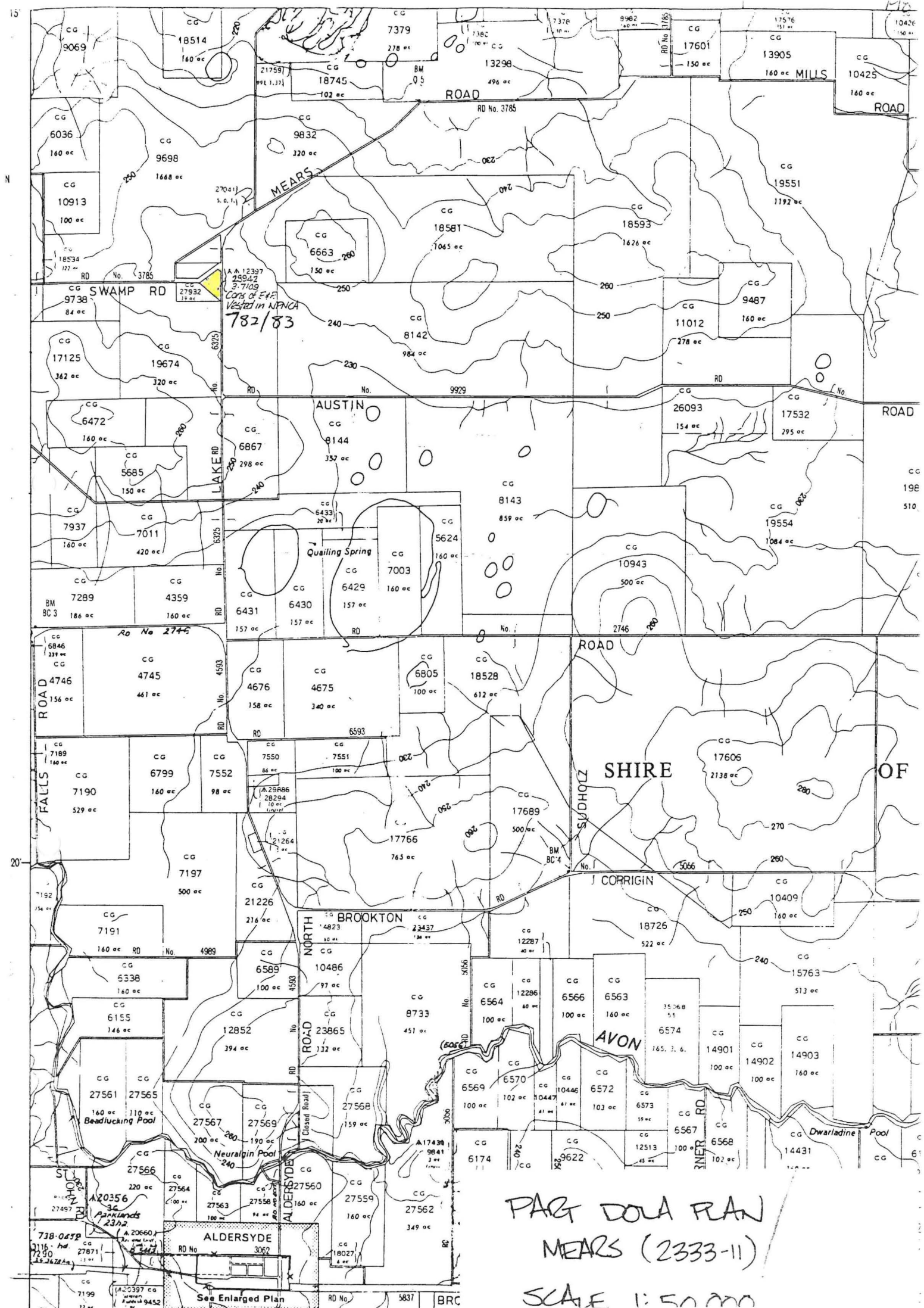
The reserve is now no longer required for water supply purposes by the Water Corporation. Despite its small size the reserve has been determined to be of conservation value by the Department of Conservation and Land Management and it is proposed to amend its purpose to "Conservation of Flora and Fauna and Water". This will allow the reserve to vest in the National Parks and Nature Conservation Authority pursuant to Section 7 of the Conservation and Land Management Act 1984.

The Shire of Brookton supports this proposal subject to local farmers being allowed continued access to water from the well situated in the western corner in drought conditions. This proviso has been included in the proposed amended purpose by CALM and "Water" has been left in the proposed amended purpose to reflect this undertaking.

It is considered that this proposal can proceed without reference to the provisions of the Native Title Act 1993 as it is unlikely to further impair any existing native title rights or interests.

In view of the 'A' Classification of Reserve No. 12397, this clause seeks the approval of both Houses of Parliament to amend the purpose of the reserve.
