Child Welfare Act 1947 ORDER IN COUNCIL

WHEREAS by section 19(2)(a) of the Child Welfare Act 1947, it is provided that the Lieutenant-Governor and Administrator may appoint such persons, male or female, as he may think fit, to be members of any particular Children's Court and may determine the respective seniorities of such members and whereas by section 19(1)(b)(ii) of the said Act, the Lieutenant-Governor and Administrator may amend, vary or revoke any such appointment: Now therefore His Excellency the Lieutenant-Governor and Administrator by and with the advice and consent of the Executive Council and with the advice and consent of the Executive Council doth hereby appoint the person named in the First Schedule hereto to be a member of the Children's Court at the place mentioned and doth hereby revoke the appointment of the person named in the Second Schedule hereto to be a member of the Children's Court at the place mentioned.
