Notice to this effect was published in the Government Gazette dated 14 October 1994 and I enclose a print showing the said reserve.

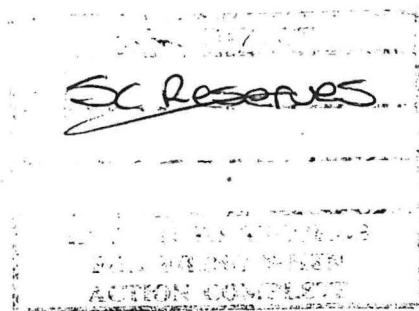

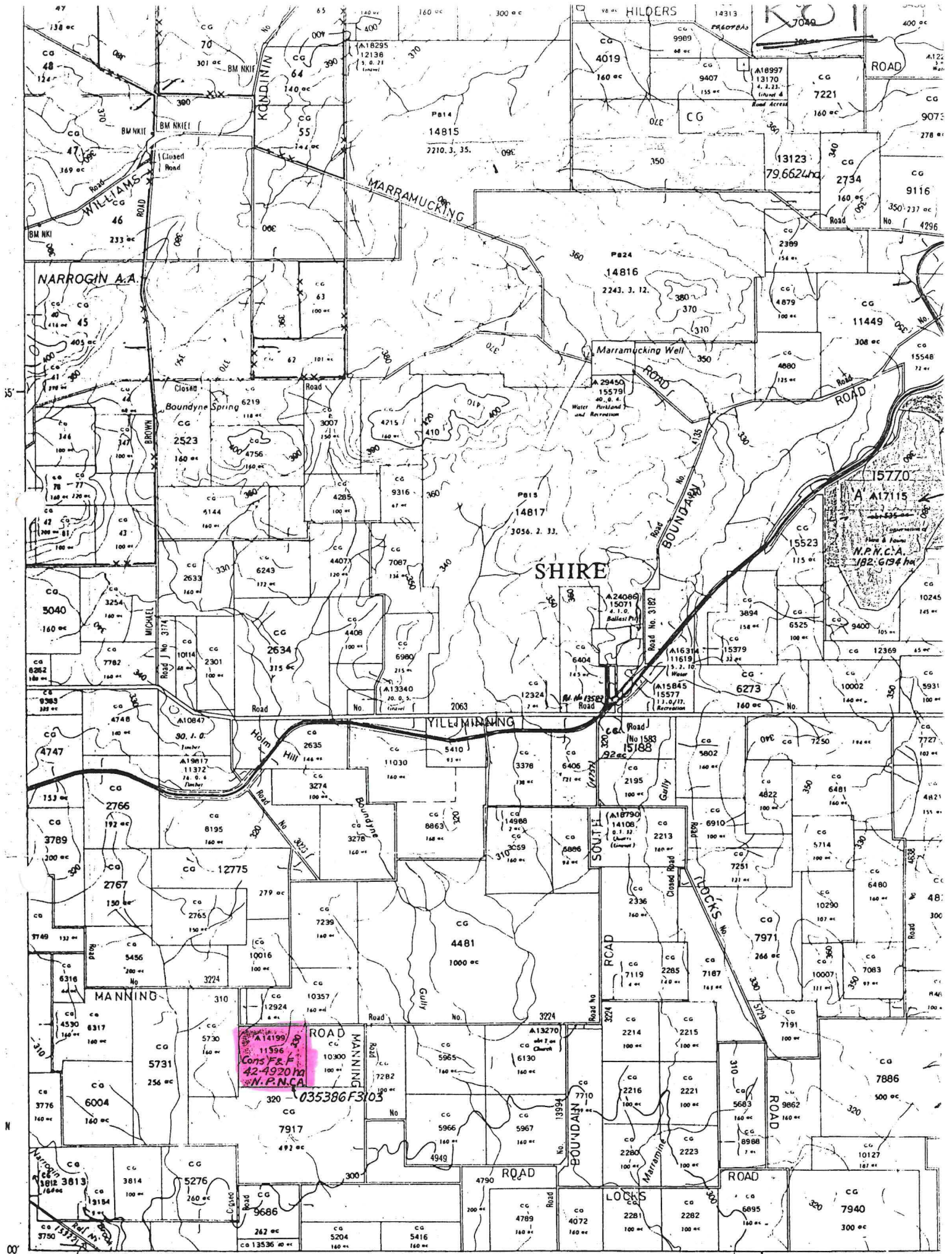
