I advise for your information that Executive Council has:-

1. issued an Order in Council under Section 34B(1) of the "Land Act, 1933" revoking the Order in Council dated August 7, 1984 whereby Reserve No. 14920 was vested jointly in the Western Australian Wildlife Authority and the Shire of Wyalkatchem in trust for the purpose of "Conservation of Flora and Fauna" and approve the cancellation of the relevant Vesting Order accordingly.
2. approved under Section 37 of the said Land Act of the amendment of Reserve No. 14920 (Avon District) "Conservation of Flora and Fauna" to comprise Location 28910 in lieu of Location 20874 and of its area being recalculated accordingly.
3. issued an Order in Council under Section 33 of the said Land Act directing that Reserve No. 14920 (Avon Location 28910) shall vest in and be held jointly by the National Parks and Nature Conservation Authority and the Shire of Wyalkatchem in trust for the purpose of "Conservation of Flora and Fauna".

Notice to this effect was published in the Government Gazette of 2 August, 1988 and I enclose a print showing the said Reserve and the relevant Vesting Order.

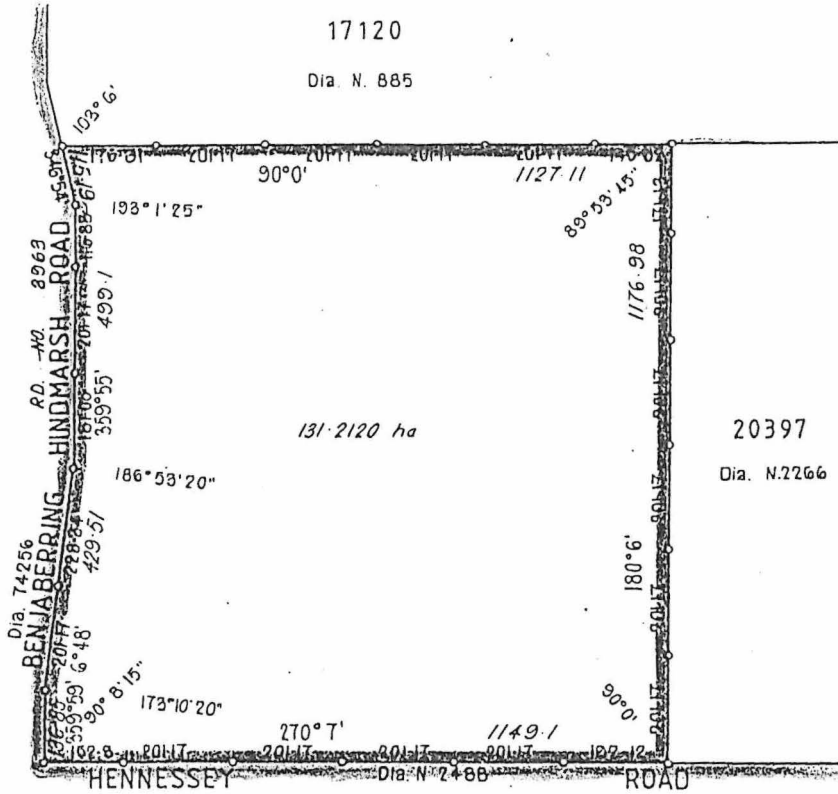

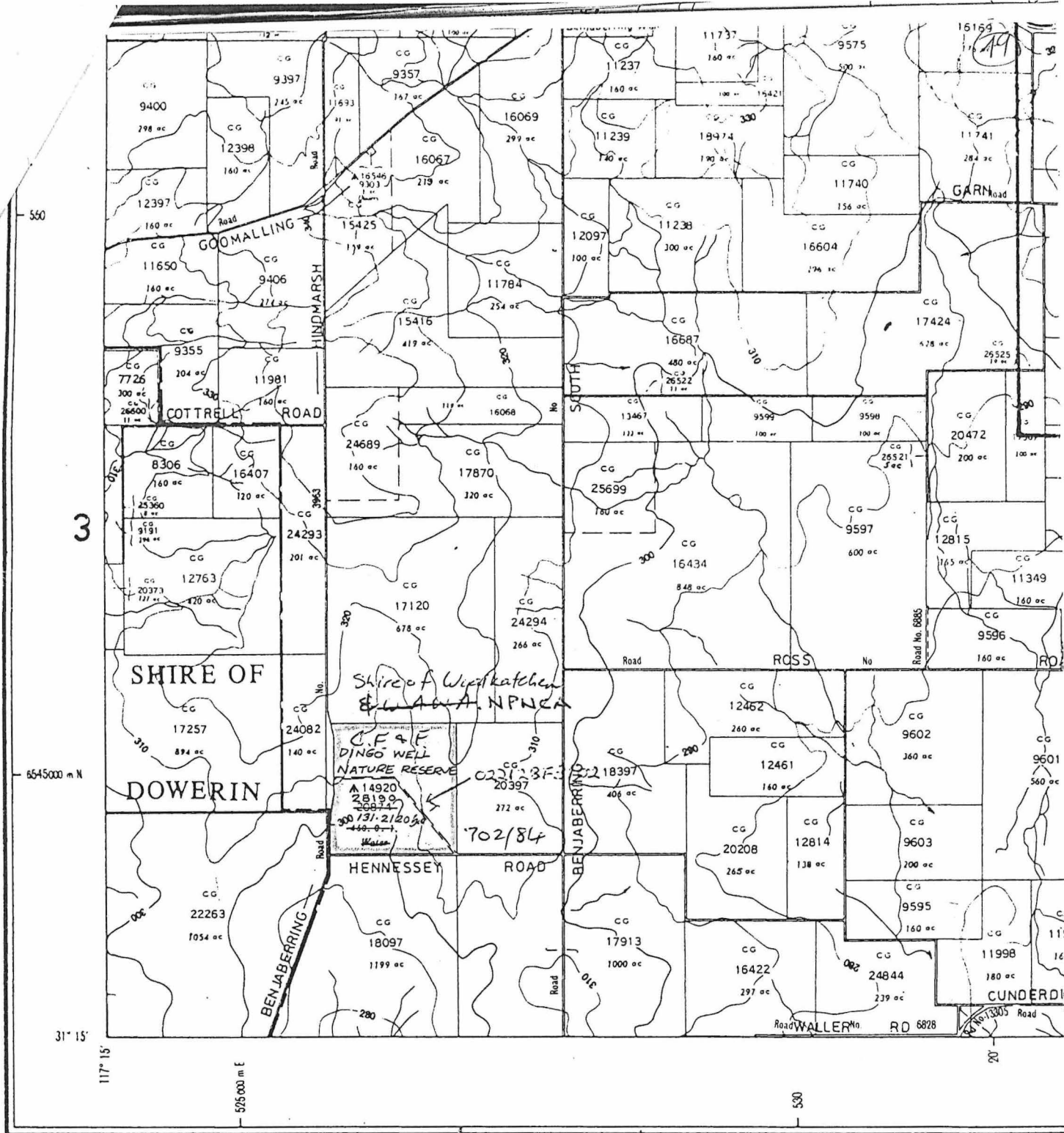
