RE: RESERVES 11221, 16553 & 12329

In reference to our letter of March 7, 1986 I advise for your information that the Executive Council has:-

1. issued Orders in Council, revoking:-
 - a) the Order in Council dated June 6, 1963 whereby Reserve No. 11221 was vested in the Minister for Water Supply, Sewerage and Drainage in trust for the purpose of "Water and Timber" and approved the cancellation of the relevant Vesting Order accordingly.
 - b) that portion of the Order in Council dated November 22, 1916 whereby Reserve No. 16553 was vested in the Hon The Minister for Water Supply, Sewerage and Drainage in trust for the purpose of "Water" and approve the cancellation of the relevant Vesting Order accordingly.
 - c) the Order in Council dated April 17, 1984 whereby Reserve No. 12329 was vested in the Western Australian Wildlife Authority in trust for the purpose of "Conservation of Flora and Fauna" and approve the cancellation of the relevant Vesting Order accordingly.
2. approved of:-
 - a) the cancellation of:-
 - i) Reserve No. 11221 (Avon Location 12208) "Water and Timber".
 - ii) Reserve No. 16553 (Avon Location 9309) "Water and Timber".
 - b) the amendment of Reserve No. 12329 (Avon Location 12182 and 16470) "Conservation of Flora and Fauna" to include Avon Locations 9309 and 12208 and of its area being increased to about 160.1761 hectares.

- 3. issued an Order in Council directing that Reserve No. **12329** (Avon locations 9309, 12182, 12208 and 16470) shall vest in and be held by the National Parks and Nature Conservation Authority in trust for the purpose of "Conservation of Flora and Fauna".

Notice to this effect was published in the Government Gazette of May 30, 1986 and I enclose a print showing the said Reserves and the relevant Vesting Order. Would you please return to this Office the superseded Vesting Order dated April 17, 1984 for cancellation.

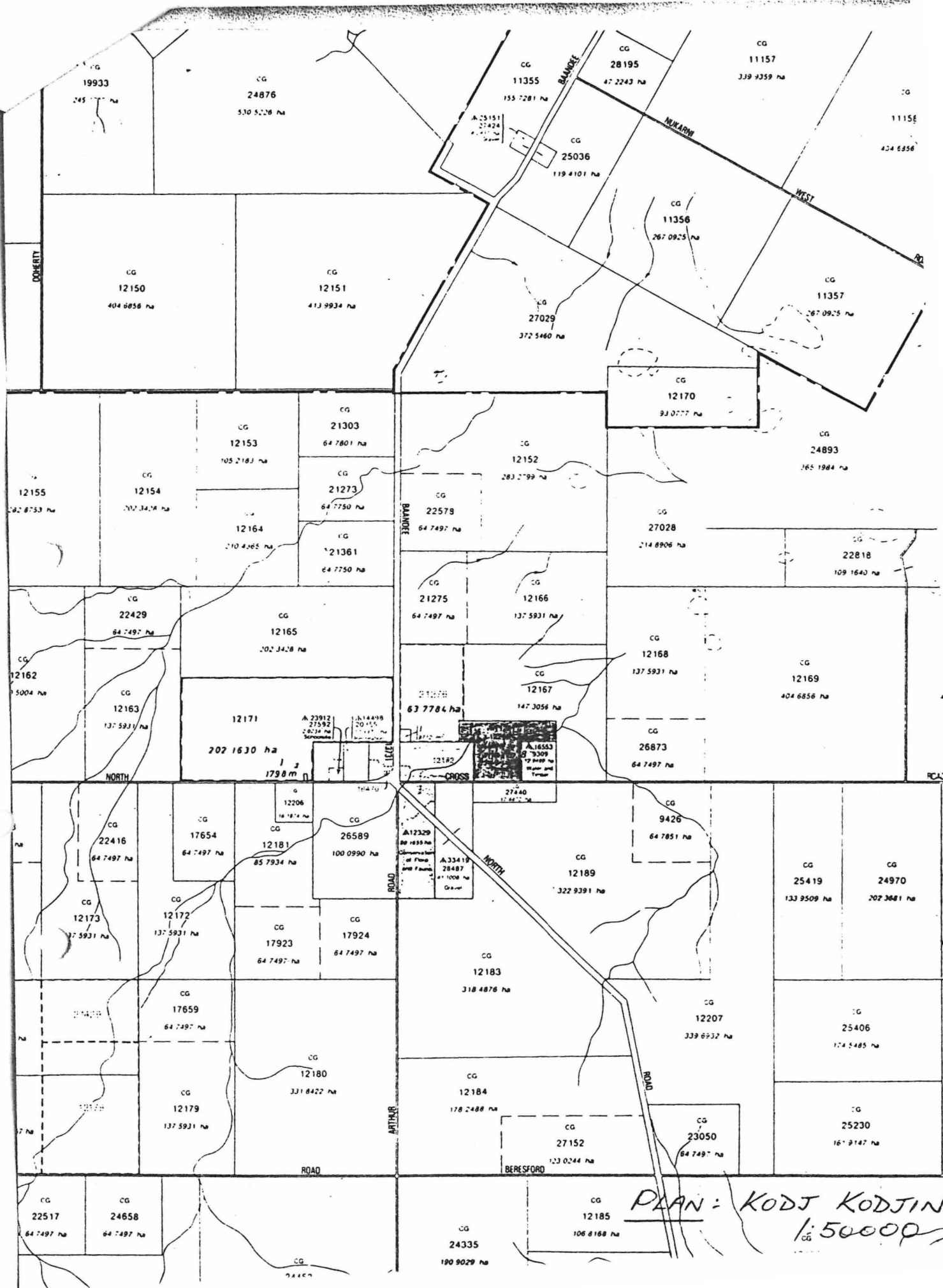
