CLASS 'A' RESERVE 25872 AT HINES HILL

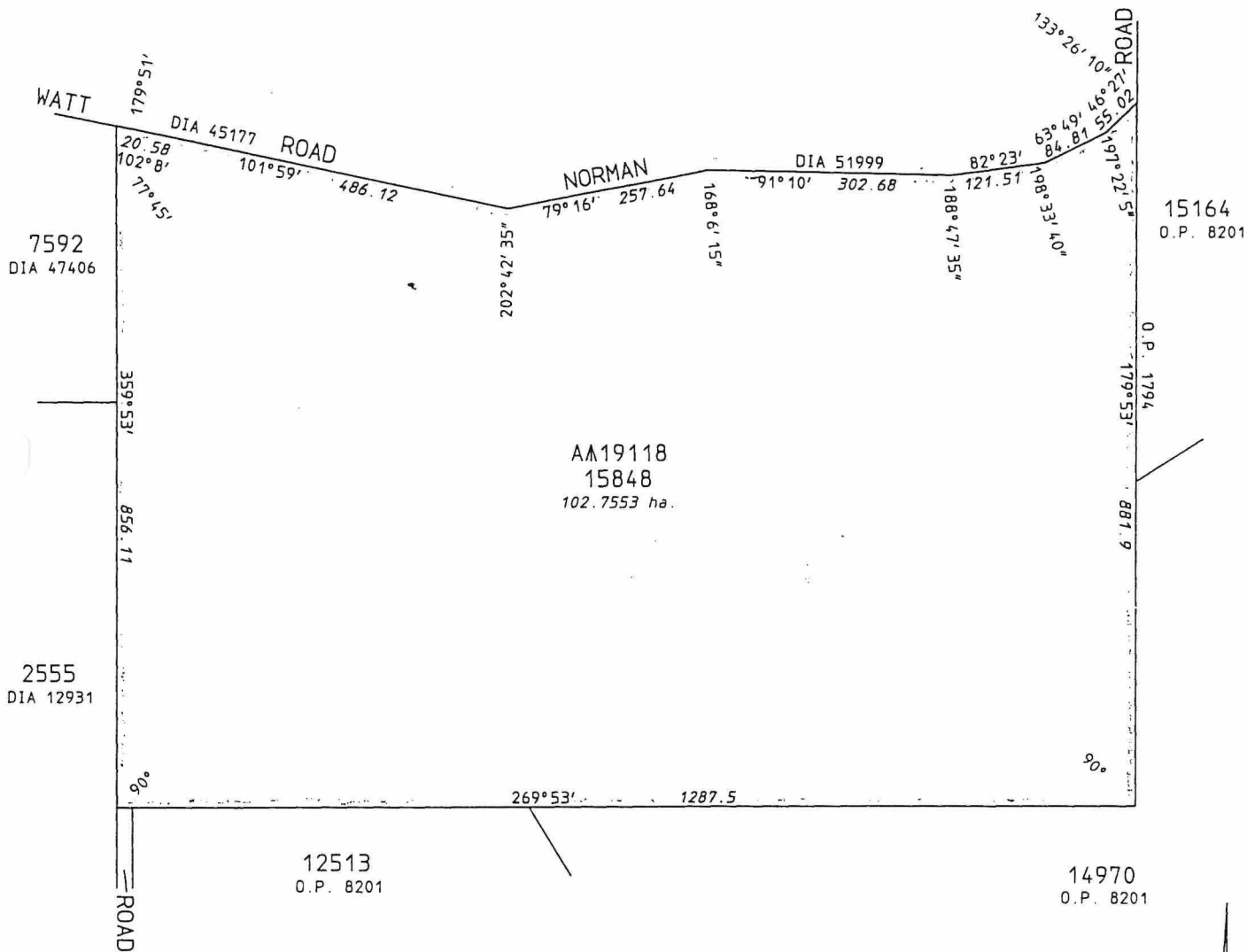
Thank you for your memorandum dated 22 November, 1996 concerning the amendment of the abovementioned reserve. Subsequent to my advice dated 14 February 1995, Crown Solicitors Office advice (July 1995) indicated that Reserves Bill action was not necessary where changes to Class 'A' reserves will simply reflect area re-calculations, allocation of land parcel identifiers and compiled graphical support, where the reserve's purpose and external boundaries remain unaltered. These actions were considered in-house maintenance tasks.

Acting on this advice the following reserves were identified as meeting the abovementioned criteria.

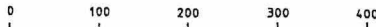

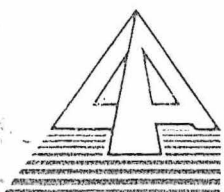

WHEREAS by section 31 (1) (a) of the Land Act 1933, the Governor may by Proclamation and subject to such conditions as may be expressed therein classify as of Class "A" any such lands of the Crown reserved to Her Majesty for any purpose; and whereas it is deemed expedient that the Reserves listed in the attached schedule for the purpose of "Conservation of Flora and Fauna" as described, should be classified as of Class "A"; now, therefore I, the Governor, with the advice and consent of Executive Council do by this my Proclamation classify as of Class "A" the reserve described in the attached schedule.

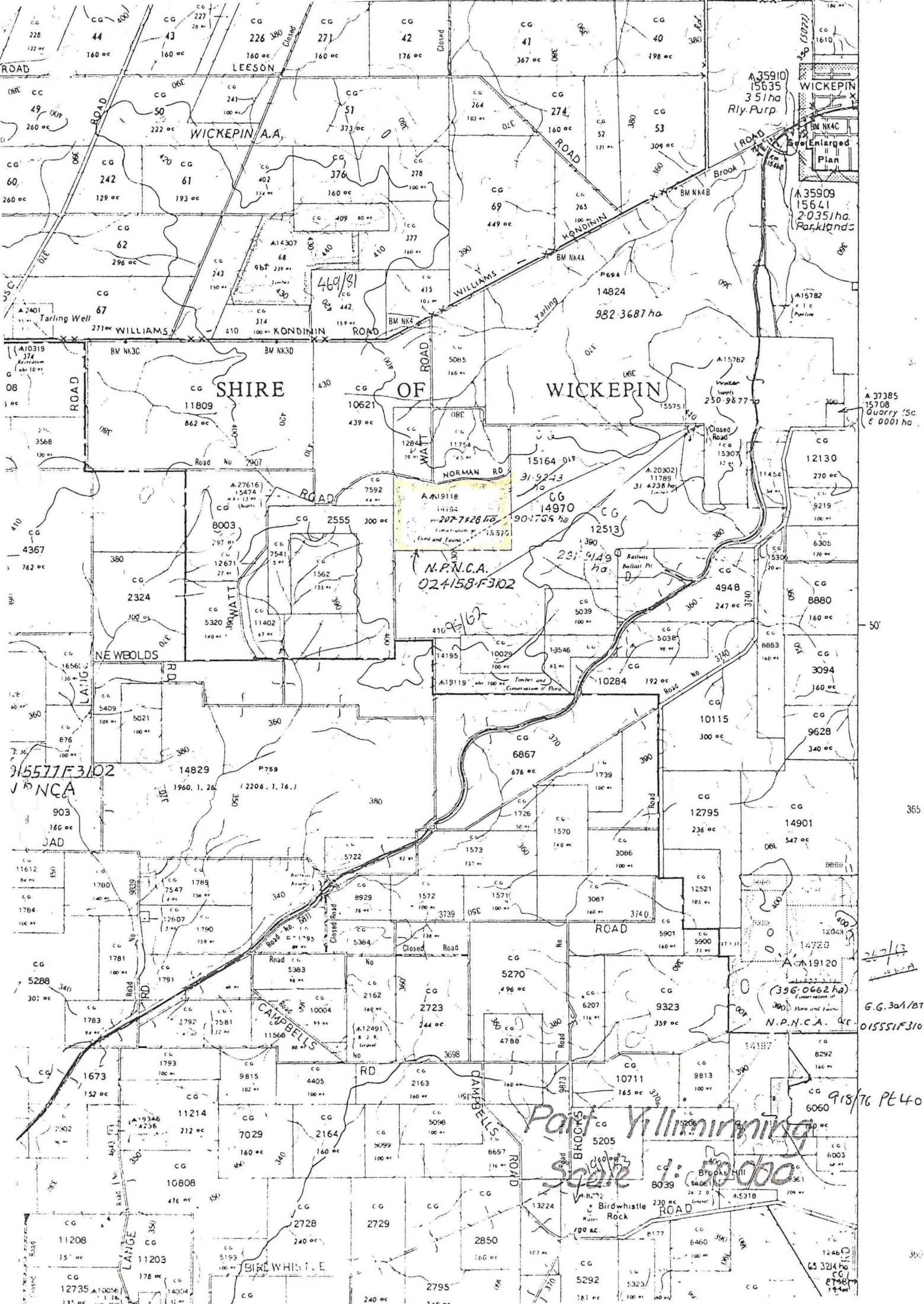
