#### PROCLAMATION

WESTERN AUSTRALIA GORDON REID, Governor. [L.S.]

By His Excellency Professor Gordon Reid, Companion of the Order of Australia, Governor of the State of Western Australia.

WHEREAS by section 31 (1) (a) of the Land Act 1933, the Governor may by Proclamation and subject to such conditions as may be expressed therein classify as of Class "A" any such lands of the Crown reserved to Her Majesty for any purpose; and whereas it is deemed expedient that the Reserves listed in the attached schedule for the purpose of "Conservation of Flora and Fauna" as described, should be classified as of Class "A": now, therefore I, the Governor, with the advice and consent of Executive Council do by this my Proclamation classify as of Class "A" the reserve described in the attached schedule.
