1. approved of:-
 - a) the amendment of Reserve No. 20571 (Avon District) "Water (Country Water Supply)" to comprise Avon Location 28891 in lieu of Avon Location 25363 and of its area being reduced to 378.0653 hectares.
 - b) the purpose of Reserve No. 20571 (Avon Location 28891) being changed from "Water (Country Water Supply)" to "Conservation of Flora and Fauna".
2. issued a Proclamation classifying as of Class 'A' Reserve No. 20571 "Conservation of Flora and Fauna" and issued an Order in Council directing that Reserve No. 20571 shall vest in and be held by the National Parks and Nature Conservation Authority in trust for the purpose of "Conservation of Flora and Fauna".

Notice to this effect will be published in the Government Gazette of November 14, 1986 and I enclose a print showing the said amendment and the relevant Vesting Order.

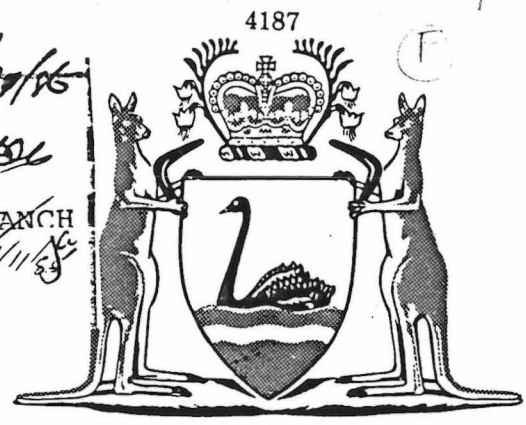

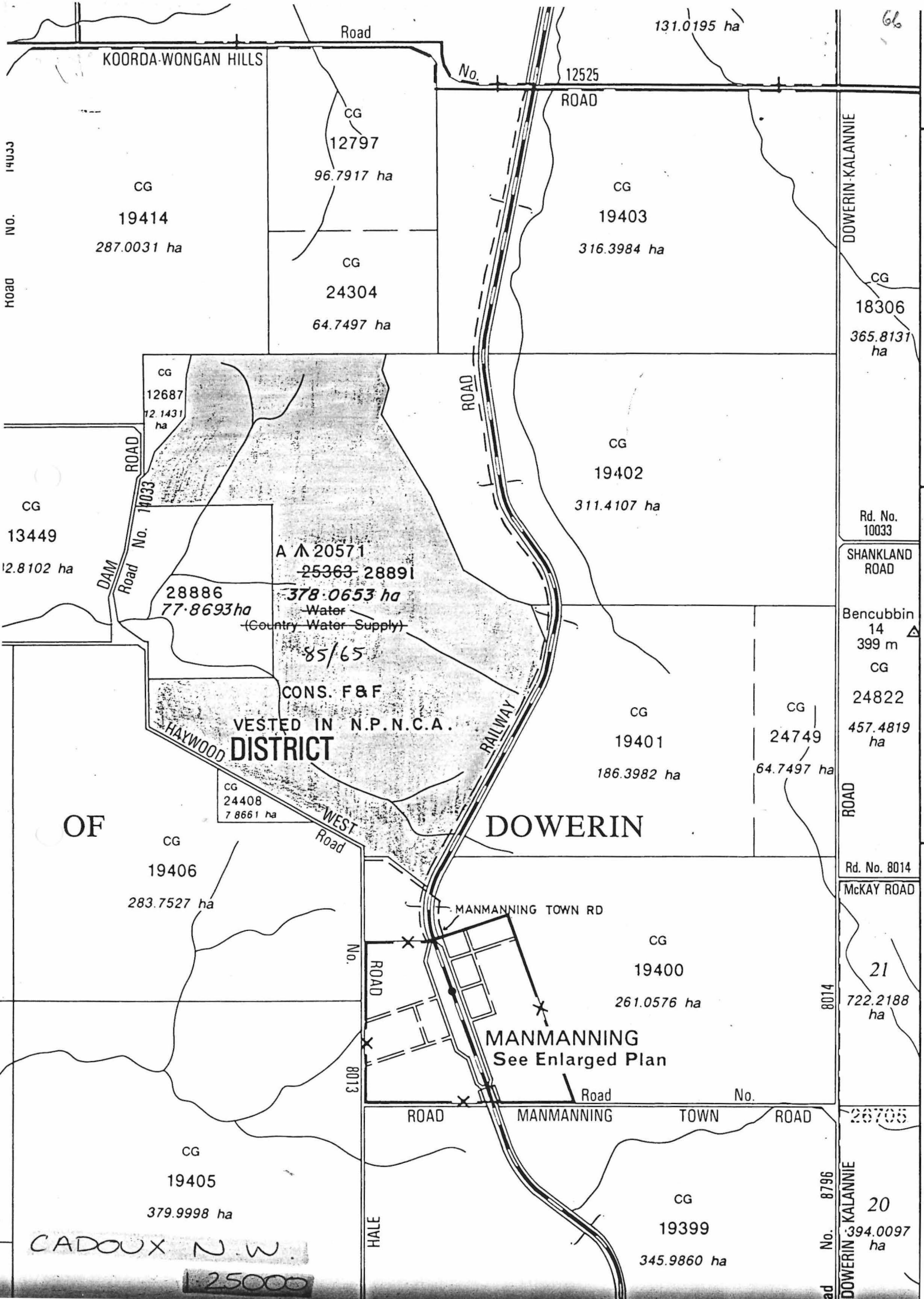
