Creation of a CALM Act section 5(1)(h) reserve.

**Total Area:** 40.4686 ha

**REASON FOR ACTION**

Reserve 20961 was an unvested (unmanaged) reserve with a purpose of "Timber Sandalwood". The reserve had been subject of a Land Administration Act lease to the adjoining land owners for grazing. A Department of Conservation and Land Management officer first assessed the reserve in 1991 and found that it contained significant vegetation remnants that warranted a recommendation that the reserve be vested as a nature reserve with the purpose of "Conservation of Flora and Fauna". Due to concerns over access to the large sandalwood seed source, it was decided in 2007 to amend the reserve purpose to "Timber" and issue a Management Order in favour of the Conservation Commission of W.A.

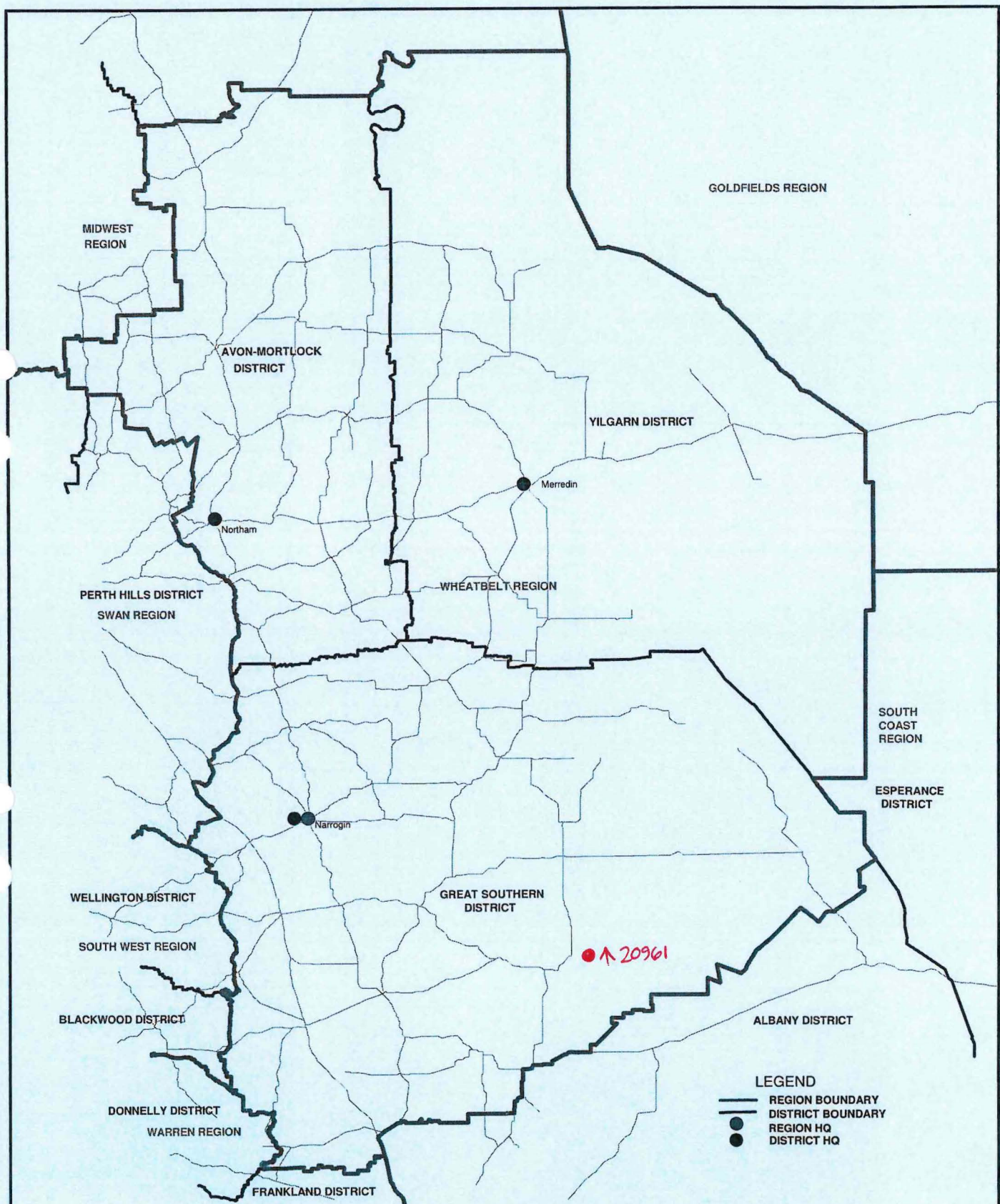

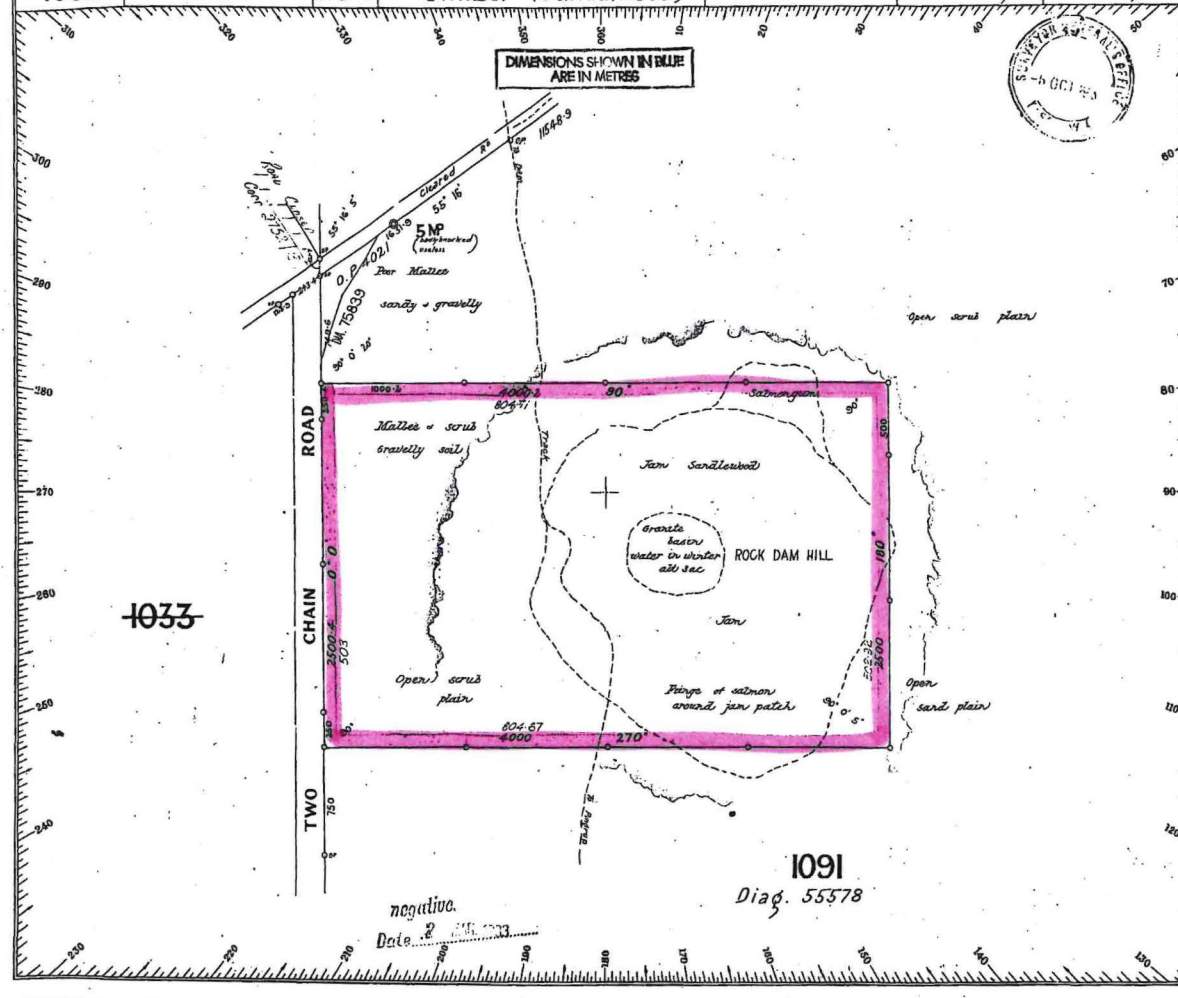
