

## RESERVE ACTION SHEET - CONSERVATION RESERVES

### RESERVE 21745, SHIRE OF KULIN

#### REASON FOR ACTION

Amendment of Reserve 21745, located in the Shire of Kulin, to excise Jitarning Refuse Site. The refuse site has been set aside as Reserve 46839 and is vested in the Shire of Kulin for the purpose "*Refuse Rehabilitation Site*". Reserve 21745 is vested in the Conservation Commission of WA for the purpose "*Conservation of Flora and Fauna*".

Area (C↑21745): 48.3596 hectares

The refuse site was mistakenly included in the adjoining Reserve 21745 when this previous water reserve was set aside as a nature reserve in 2001. It has subsequently been an administrative process to excise the *refuse rehabilitation site* Reserve 46839 and amend Reserve 21745 accordingly.

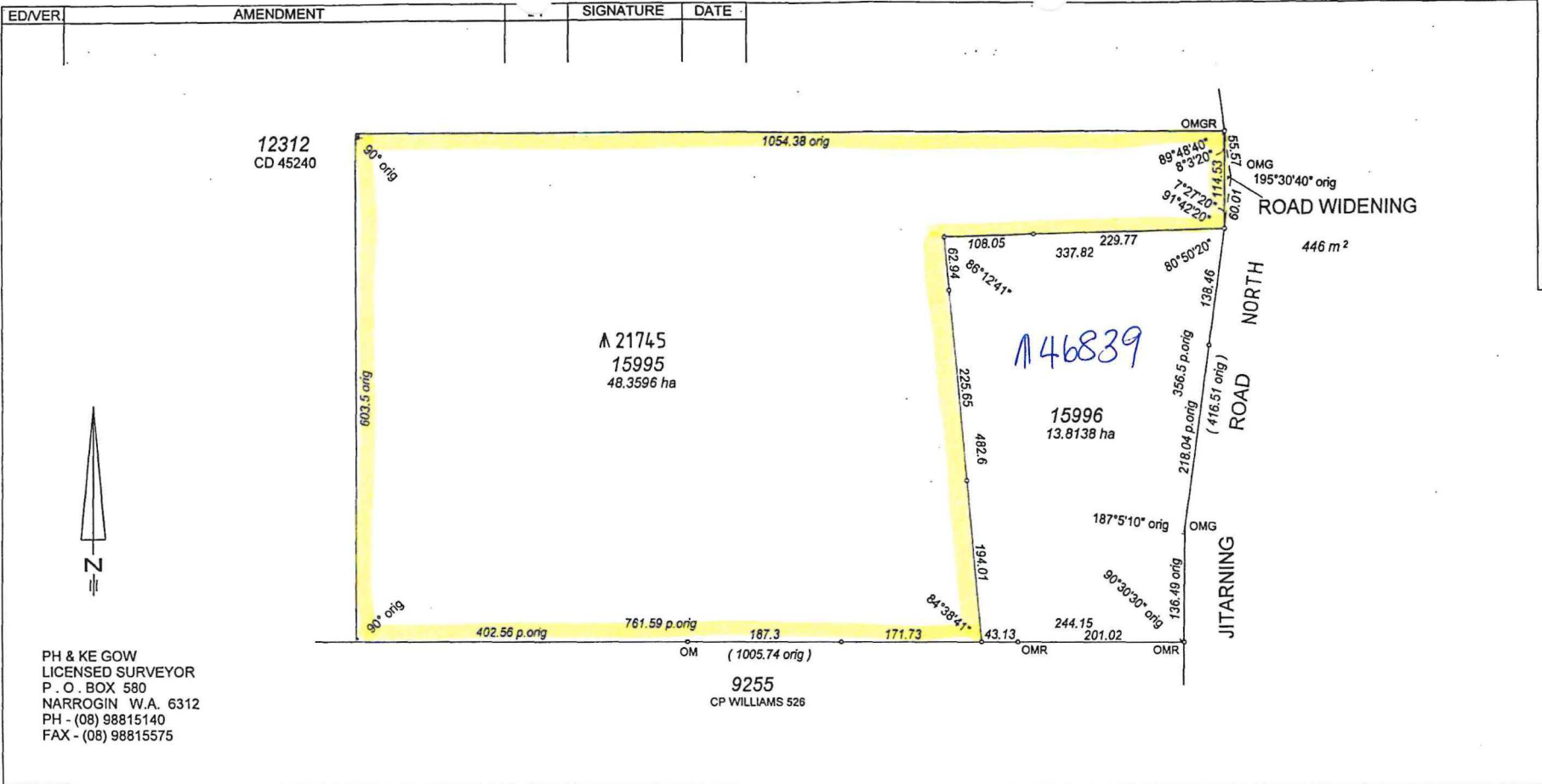

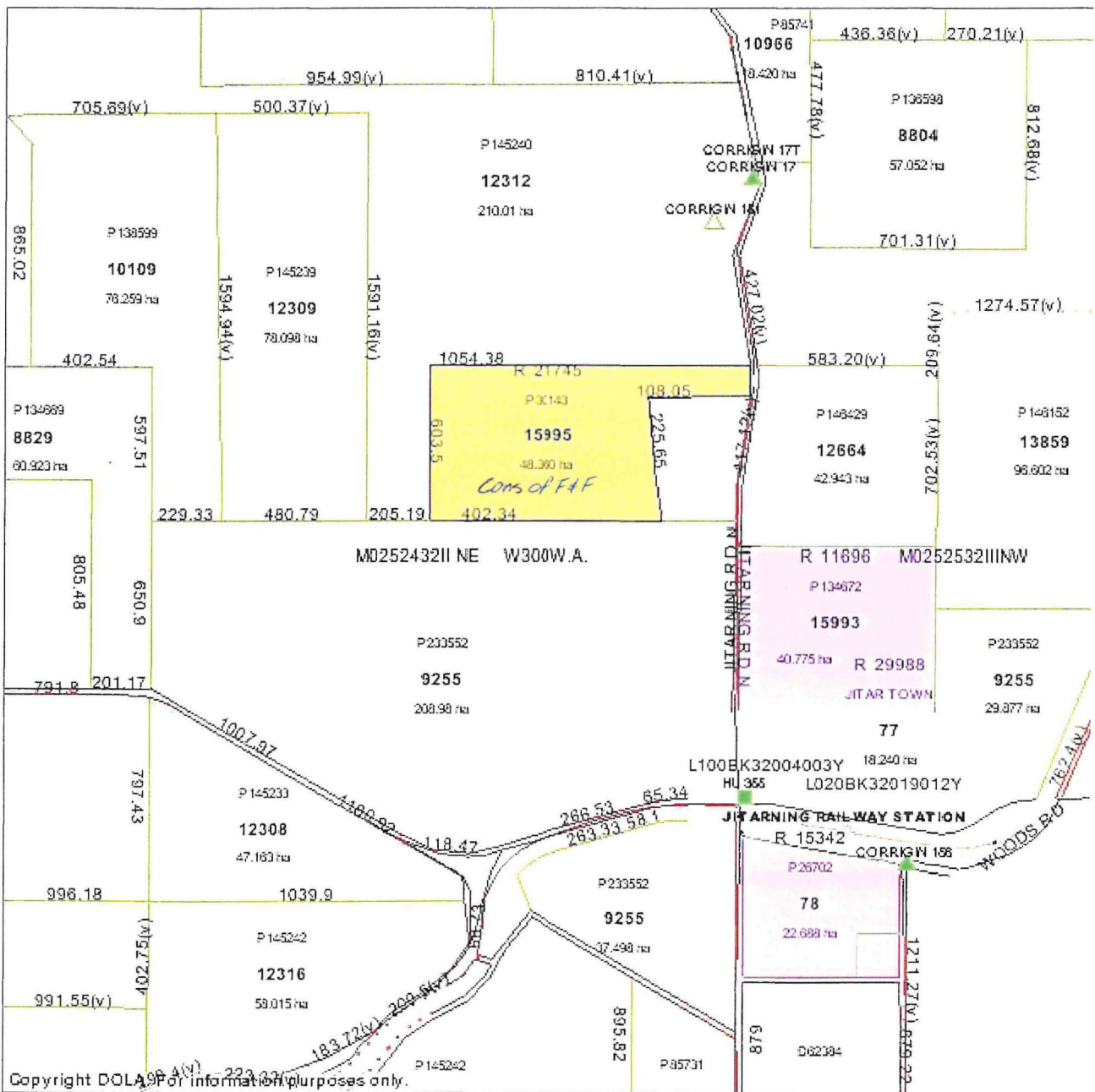

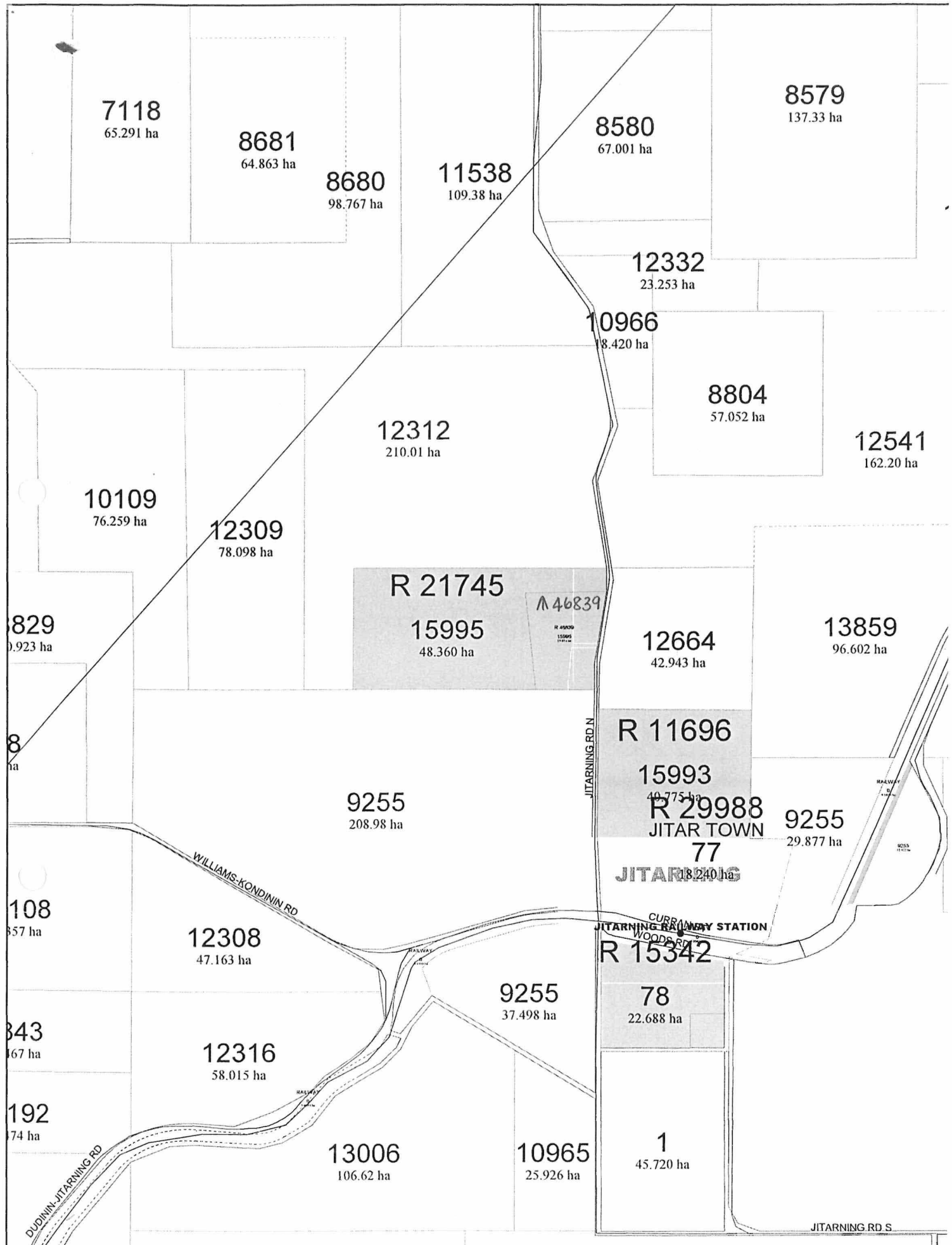
