 - a) the amendment of Reserve No. 21906 (at Kockatea Estate) "Conservation of Flora" to comprise Kockatea Estate Lot 22 in lieu of Kockatea Estate Lots 13 and 21 and of its area being increased accordingly.
 - b) the purpose of Reserve No. 21906 (Kockatea Estate Lot 22) being changed from "Conservation of Flora" to "Conservation of Flora and Fauna".
2. issued an Order in Council under Section 33 of the said Act directing that Reserve No. 21906 (Kockatea Estate Lot 22) shall vest in and be held by the National Parks and Nature Conservation Authority in trust for the purpose of "Conservation of Flora and Fauna".

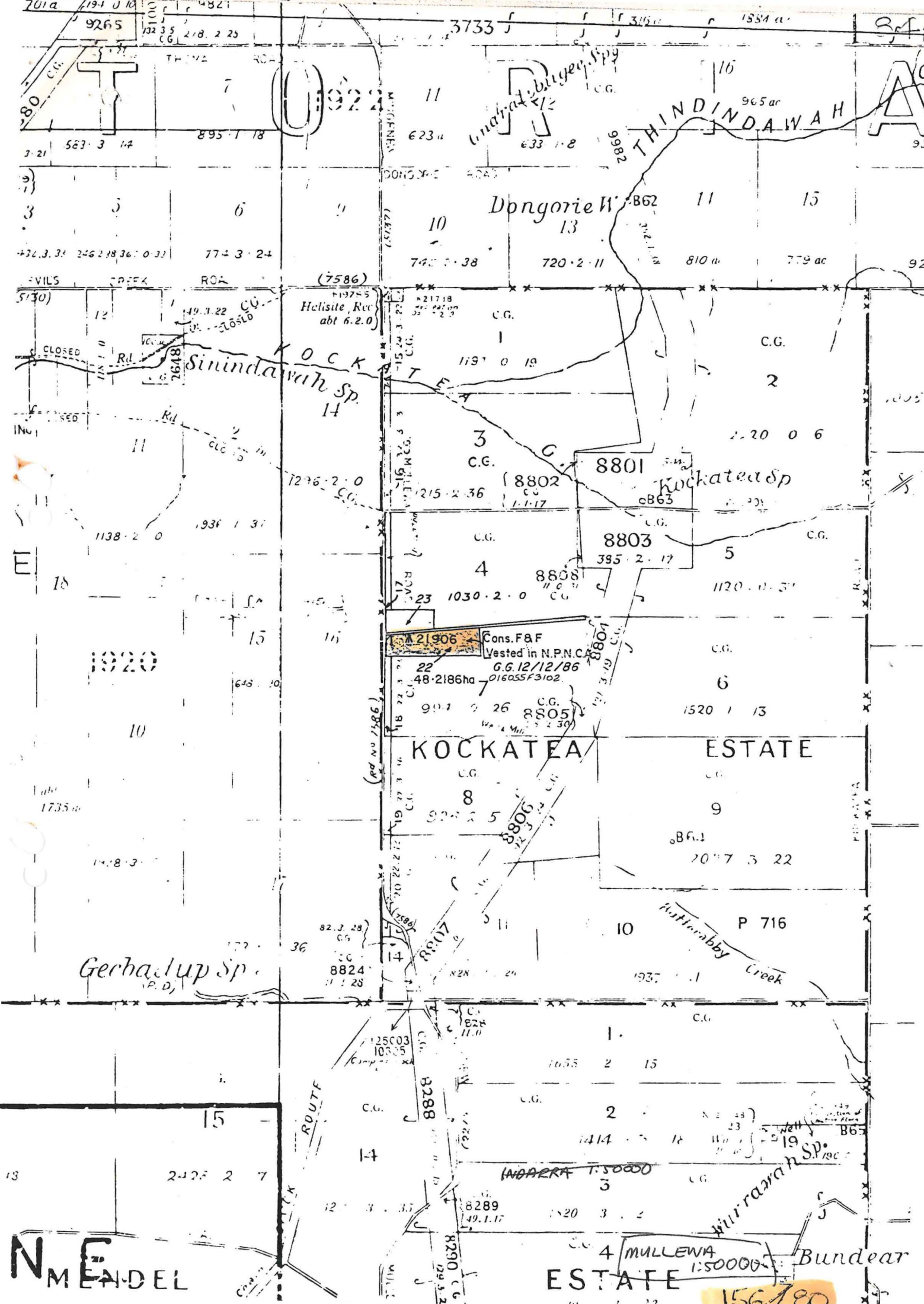
