The area excised is composed of minimal degraded vegetation and was previously used for gravel extraction.

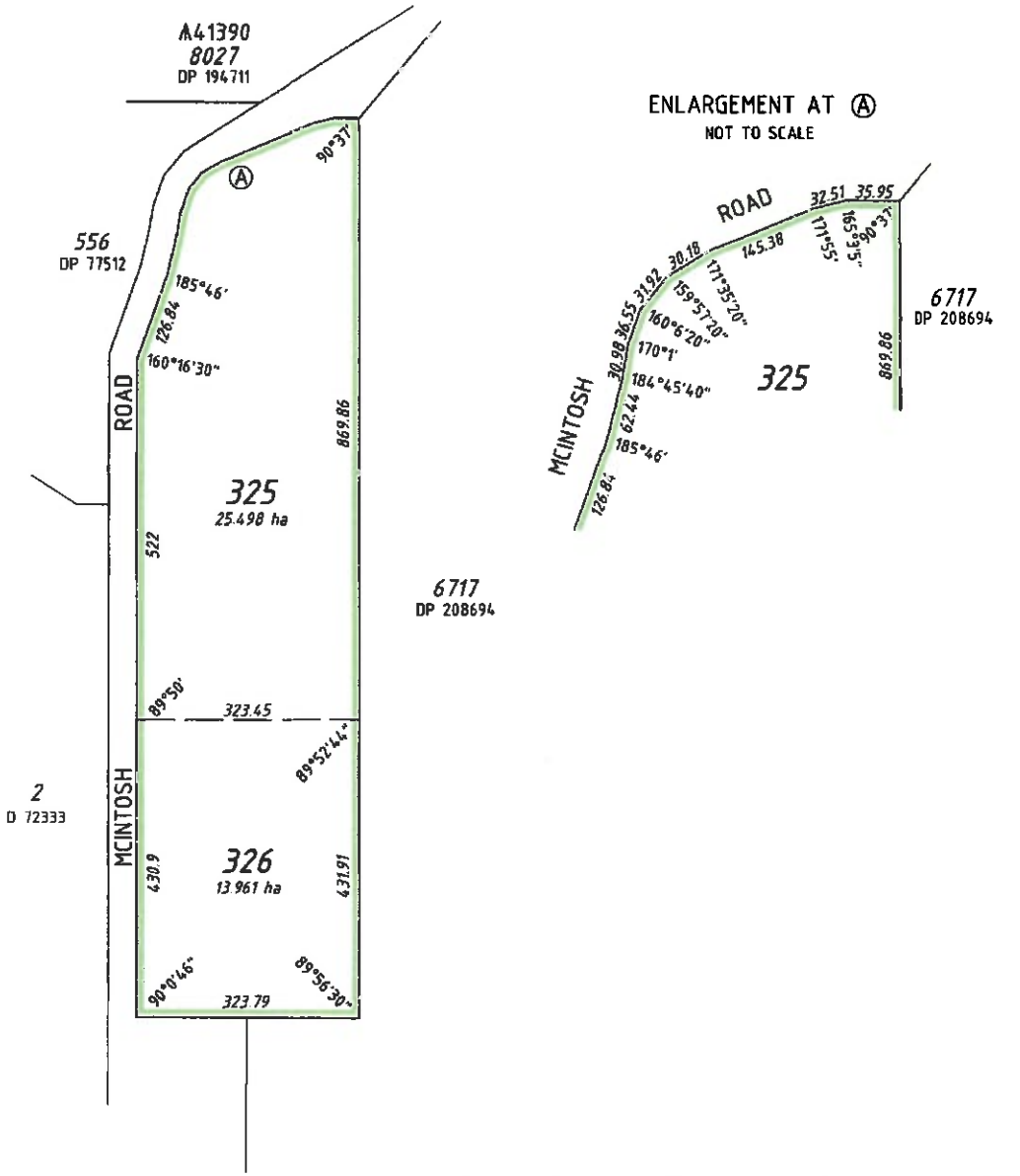

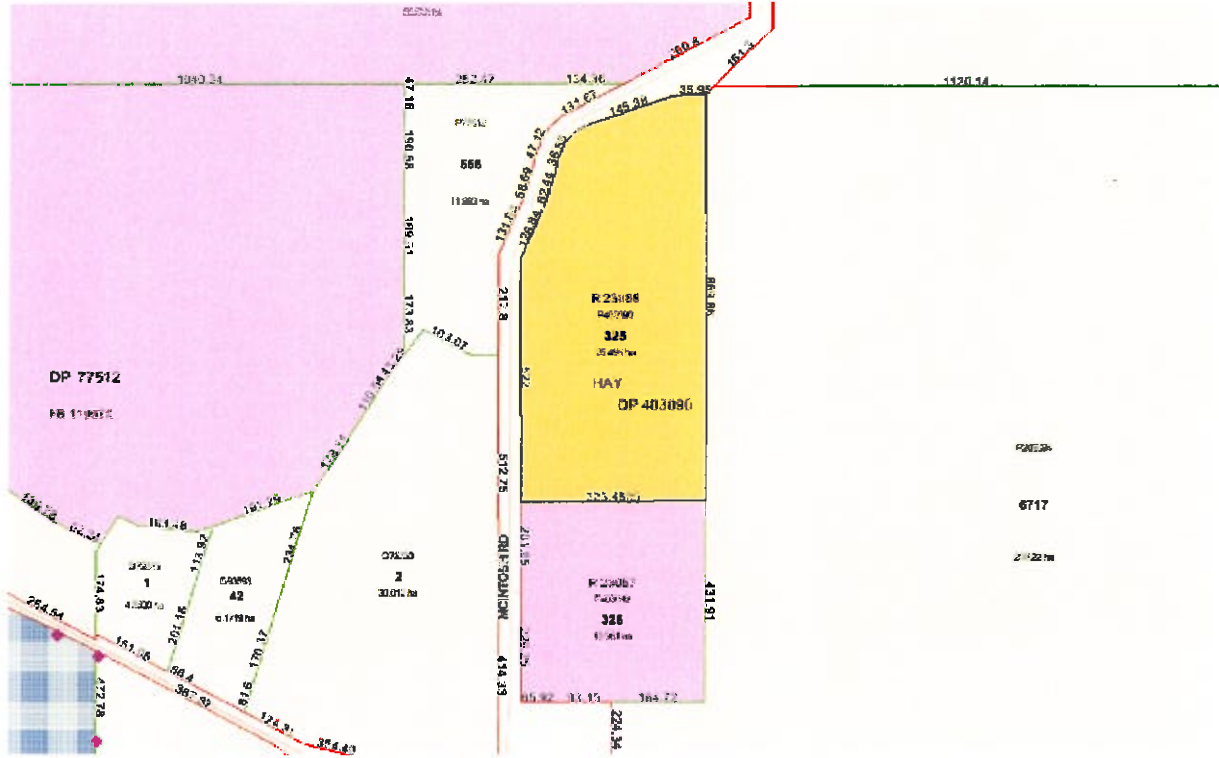
