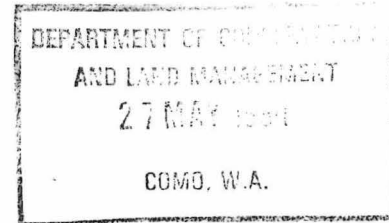

5. REPORT OF THE DIRECTOR OF NATURE CONSERVATION

5.1 Proposed re-vesting of Reserve 24439 in the Shire of Cuballing.

Mr McNamara spoke to the tabled briefing paper.

Mr Rundle moved the Authority agree to the re-vesting of Reserve 24439 in the Shire of Cuballing with a change in purpose to 'Landscape Protection' and that the Department suggest to the Shire of Cuballing that consideration be given to fencing the area on all sides. Seconded Mr Paterson. Carried.

POSITION PAPER

Reserve 24439 of about 2.3 hectares was previously unvested and set aside for the purpose of "Gravel and Protection of Flora". It is located approximately 12 kilometres west of Popanyinning within the Shire of Cuballing. The reserve was the result of a closed road and is therefore linear in shape, being just over a kilometre long and about 20 metres wide.

As a result of the CALM Amendment Act 1991 reserve 24439 was automatically vested in the NPNCA by way of its purpose including 'protection of flora'.

On inspection, the reserve was found to have suffered a high degree of disturbance. For most of its length it is fenced only on one side with the understorey being totally destroyed due to grazing by stock. Moreover parts of the vegetation have been removed along the entire length of the reserve and the strip of vegetation that remains is on average only 10 metres wide. The remaining vegetation comprises of rock sheoak (*Allocasuarina huegeliana*) in the eastern half and wandoo (*Eucalyptus wandoo*) in the western half with occasional specimens of jam (*Acacia acuminata*) and harsh hakea (*Hakea prostrata*). The only other native species recorded from the reserve is the mistletoe (*Amyema miguelii*).

Reserve 24439 is unsuitable as a nature reserve. Its main value is to serve as a corridor between timber reserve 20358, proposed as a nature reserve and the Wandering-Narrogin road reserve.

The Shire of Cuballing has been approached and would be prepared to accept the vesting of reserve 24439 for a suitable purpose (e.g. landscape protection) to allow for the revegetation to serve as a future wildlife corridor.

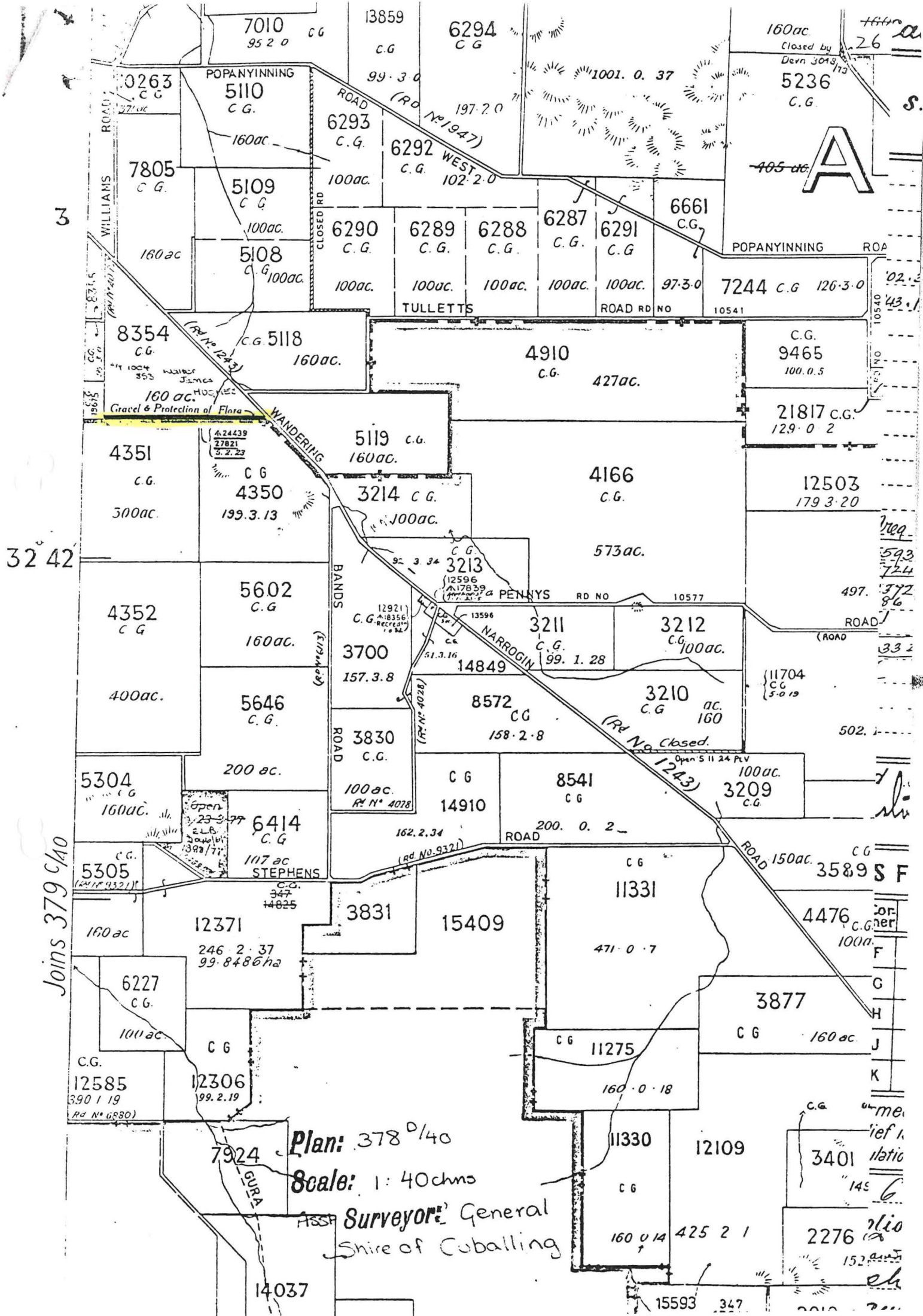
RECOMMENDATIONS
