## Clause 16 amended

- 8. Clause 16 of the principal notice is amended-
  - (a) in subclause 1 by deleting the passage beginning with "the owner or person in charge" and ending with "of snapper taken" and substituting the following—
    - "the person in charge of the boat shall complete details of any snapper landed ashore in the catch and disposal record book provided by the Department"; and
  - (b) by repealing subclause (2) and substituting the following subclause-
    - " (2) The person in charge of the boat shall submit the original copy of the catch and disposal record to the Inspector at the time and place of landing. ".
