



#### CARNAC ISLAND - CHANGE OF PURPOSE OF RESERVE

I refer to your instructions of 24 June 2004 and confirm your instructions as follows:

- 1. The Carnac Island Nature Reserve is a Class "A" Reserve 26646 which was set aside for the purpose of "Recreation and Conservation of Fauna" vested in the WA Wildlife Authority consistently with the provisions of s33(2) of the *Land Act 1933* in June 1967.
- 2. By force of s7(4) of the *Conservation and Land Management Act 1984* ("the CALM Act") the reserve is now vested in the Conservation Commission.
- 3. The reserve is not merely a Class "A" reserve for the purpose of s42 of the Land Administration Act 1997 ("LAA") but is also a "Class "A" Nature Reserve" for the purpose of s45 of the LAA and also s6(5) of the CALM Act.
- 4. It is proposed to vary the purpose of the reserve to delete recreation as a function of the reserve so that it is limited to "Conservation of Flora and Fauna".
- 5. Notwithstanding that it is not the intention of the Conservation Commission to modify the purpose of the reserve to derogate from its function in the preservation of the natural qualities of the reserve, it would appear that s45(3) prevents the deletion of the "Recreation" component of the reserved purpose without a special Act of Parliament.
