Change in purpose of the reserve from "Timber" to "Conservation of Flora & Fauna". The reserve was previously a class C unvested reserve. The reserve is automatically vested in the Conservation Commission of W.A. as a result of Section 7(2) of the *Conservation and Land Management Act 1984*.

Area: 33.3638 hectares

The reserve contains seven different vegetation communities and a priority two flora *Grevillea spinosissima*.

**RESERVE 30427 – SHIRE OF QUAIRADING, 'CONSERVATION OF FLORA
AND FAUNA'.**

I refer to your letter of 13 November 2000.


In the aforementioned correspondence DOLA requested that the proposal for vesting of Reserve 30427 in the Conservation Commission as a nature reserve be referred to the native title claimants for consideration.

The proposal had previously been referred to the registered claimants in 1999. I enclose a copy of the response from the Noongar Land Council, in which they objected to the proposal. Enclosed is a copy of the response from this Department to the Noongar Land Council.

This Department had not notified DOLA of the outcome of discussions with the native title claimants, as there was no resolution. The Department was surprised when notified through the October 2001 Customer Advice that action to amend the purpose of the reserve to 'Conservation of Flora and Fauna' had been completed. It was this Department's understanding from your Department's Mr Ron Pumphrey that following the election of the current Government actions to create or amend previously vested reserves, with no previous freehold history, were to be suspended. You may wish to discuss this issue with your Department's Mr Trevor Ramsden.

Additionally, when the purpose was changed on 9 May 2001 the automatic vesting in the Conservation Commission as per Section 7(2) of the *Conservation and Land Management Act* did not appear to occur. Will you ensure your Departments records include reference to the automatic vesting, please?

I have now informed the District office that the purpose of the reserve is 'Conservation of Flora and Fauna' and should be managed as such.
