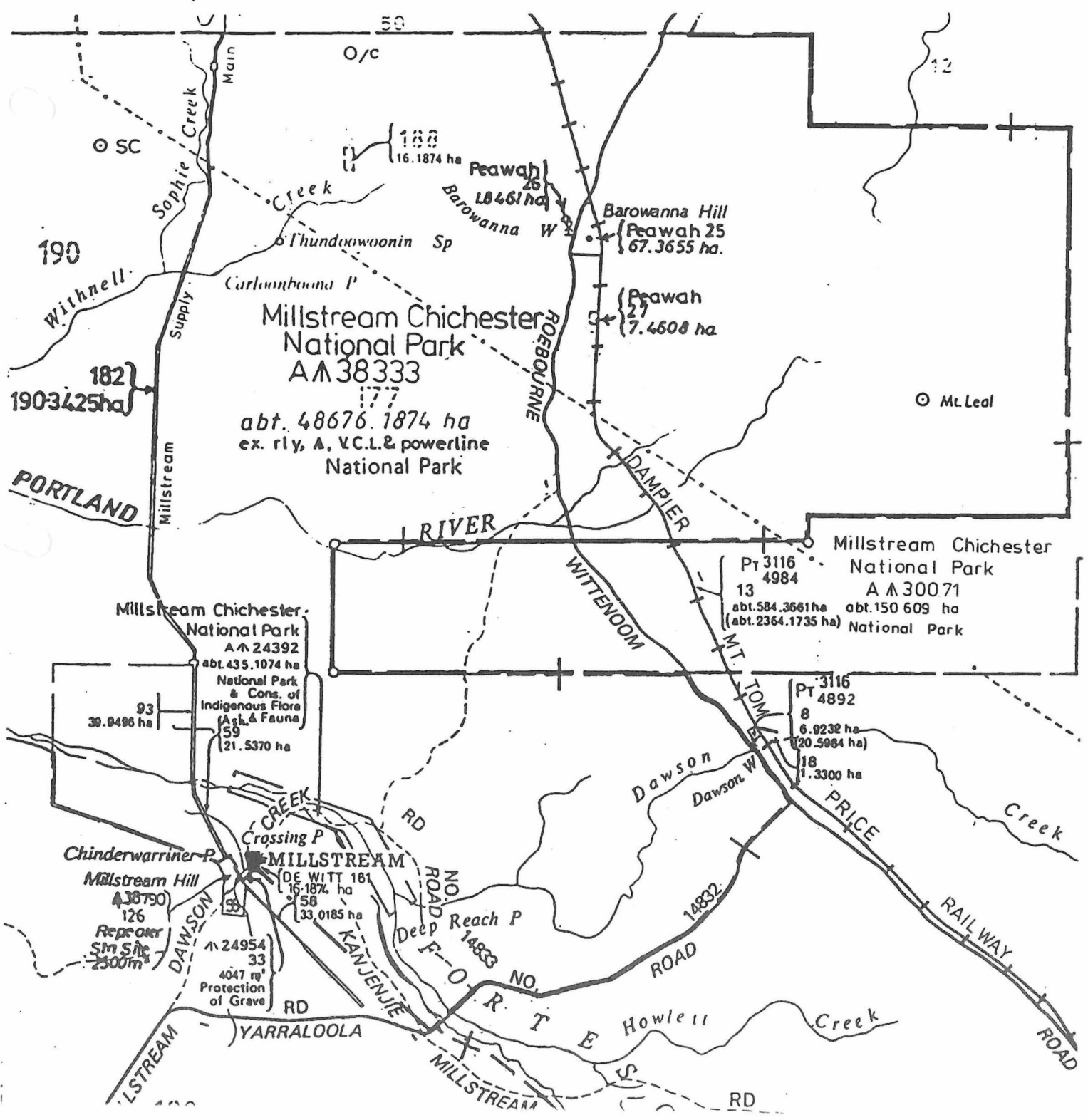

PURCHASE OF NORTH LOCATION 24 (NOW DE WITT LOCATION 188) AND  
INCLUSION INTO "MILLSTREAM CHICHESTER NATIONAL PARK" CLASS 'A'

that Executive Council has issued Orders in Council:-

- 1) revoking the Order in Council dated May 31, 1983 whereby  
Class 'A' Reserve No. 38333 was vested in the National  
Parks Authority of Western Australia in trust for the  
purpose of "National Park".
- 2) directing that Reserve No. 38333 (De Witt Locations 177  
and 188) shall vest in and be held by the National Parks  
and Nature Conservation Authority in trust for the purpose  
of "National Park".

Notice to this effect will be published in the Government Gazette of  
September 20, 1985 and I enclose the relevant Vesting Order. Would  
you please return the superseded Vesting Order dated May 31, 1983  
for cancellation.
