WHEREAS by section 34B (1) of the Land Act 1933, it is made lawful for the Governor to revoke the Orders in Council issued pursuant to section 33 of that Act.

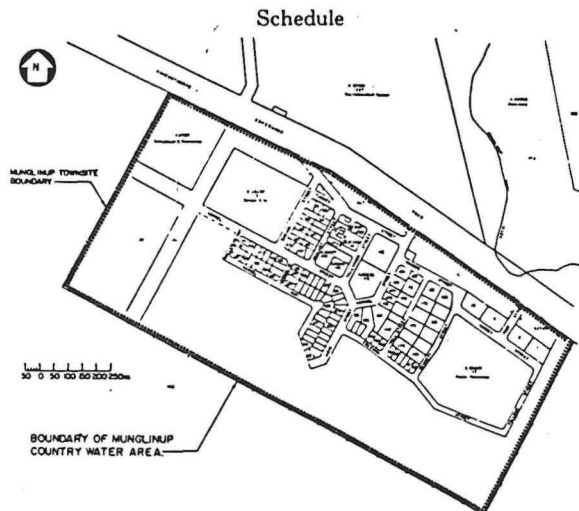
