REASON FOR ACTION: In 2011 the Department of Water deemed Reserve 20529 surplus to their requirements and offered management to the Shire of Mount Marshall and the Department of Biodiversity, Conservation and Attractions.

The majority of Reserve 20529, being 468.31 hectares was added to the adjacent class A nature reserve to consolidate management and protect a known population of threatened flora *Boronia adamsiana* and the underrepresented vegetation complexes found within the reserve.

Management of a 77.96ha was transferred to the Shire of Mount Marshall, to facilitate the Shire's management of the historic Datjoin Well. A 0.40ha portion which contained water infrastructure was transferred to the Water Corporation.






