Restricted Speed Area—All Vessels

Department of Marine and Harbours,

ACTING pursuant to the powers conferred by section 67 of the Western Australian Marine Act the Department of Marine and Harbours by this notice limits the speed of all vessels to that of five knots within the following area—

Private Taxi Licence Applications

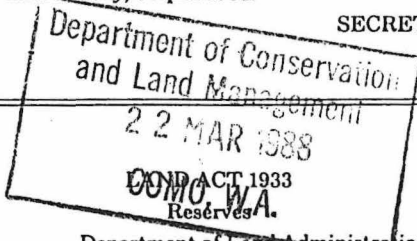
