

# **PURCHASE OF PORTION OF YILGARN LOCATION 583**

I wish to advise that the Department of Conservation and Land Management has recently purchased a 194 ha portion of Yilgarn Location 583, so that it can be set aside as an "A" class nature reserve.

The area was transferred to the Crown on 19 October 1994, and is now designated as Yilgarn Location 1579 (see attached survey diagram and locality plan). The area will be gazetted as a nature reserve in due course by the Department of Land Administration.

As you will be aware, the area that has been acquired became non-rateable upon transfer to the Crown. Could you please adjust your records accordingly, and in particular make any adjustment that may be necessary to the rates account for Yilgarn Location 583.




