**RESERVE No. 44676**

### REASON FOR ACTION

The creation of a 5(1)(h) reserve with a Management Order issued to the Conservation Commission for the purpose "Navigation, Communication, Meteorology, Survey and Conservation".

Area: 0.0405 hectares

Due to increasing use of satellite-aided navigation and AMSA's desire to rationalise its property holdings the Commonwealth has been divesting properties containing lighthouses and marine navigational aids. Reserve 44676 on Foul Bay is a former AMSA property which will be leased back to AMSA to permit continued operation of lighthouse facilities.
