REASON FOR ACTION

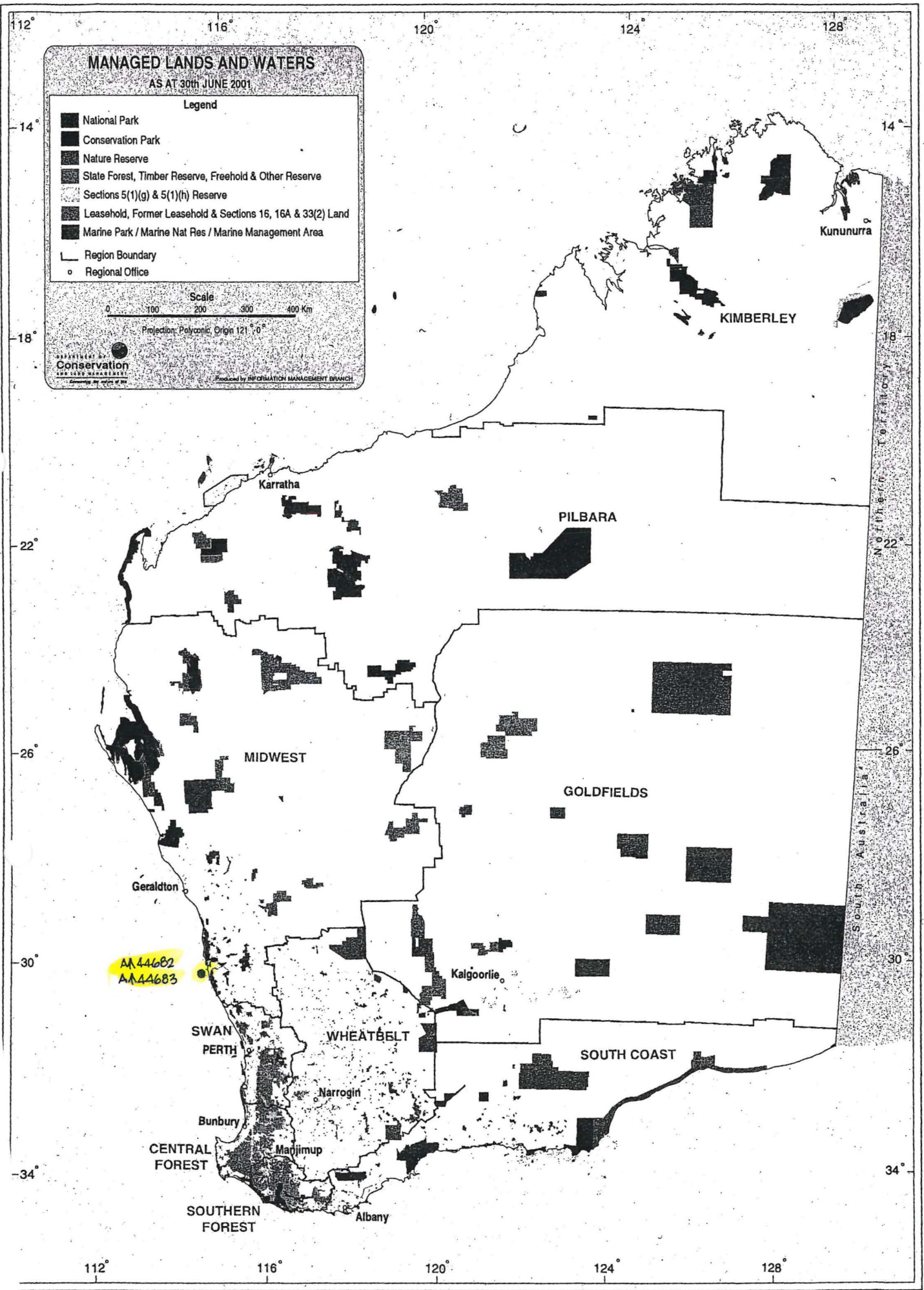
The creation of a 5(1)(h) reserve for the purpose 'Conservation, Navigation, Communication, Meteorology and Survey' and the creation of a new nature reserve for the purpose 'Conservation of Flora and Fauna', both vested in the Conservation Commission.

Area: 0.19 & 27.33 hectares

Due to increasing use of satellite aided navigation and AMSA'S desire to rationalise it's property holdings the Commonwealth has been divesting properties containing lighthouses and marine navigational aids. Reserve 44682 on Escape Island is a former AMSA property which will be leased back to AMSA to permit continued operation of lighthouse facilities. Reserve 44683 on Escape Island is a former AMSA property, which will now be managed as a nature reserve.

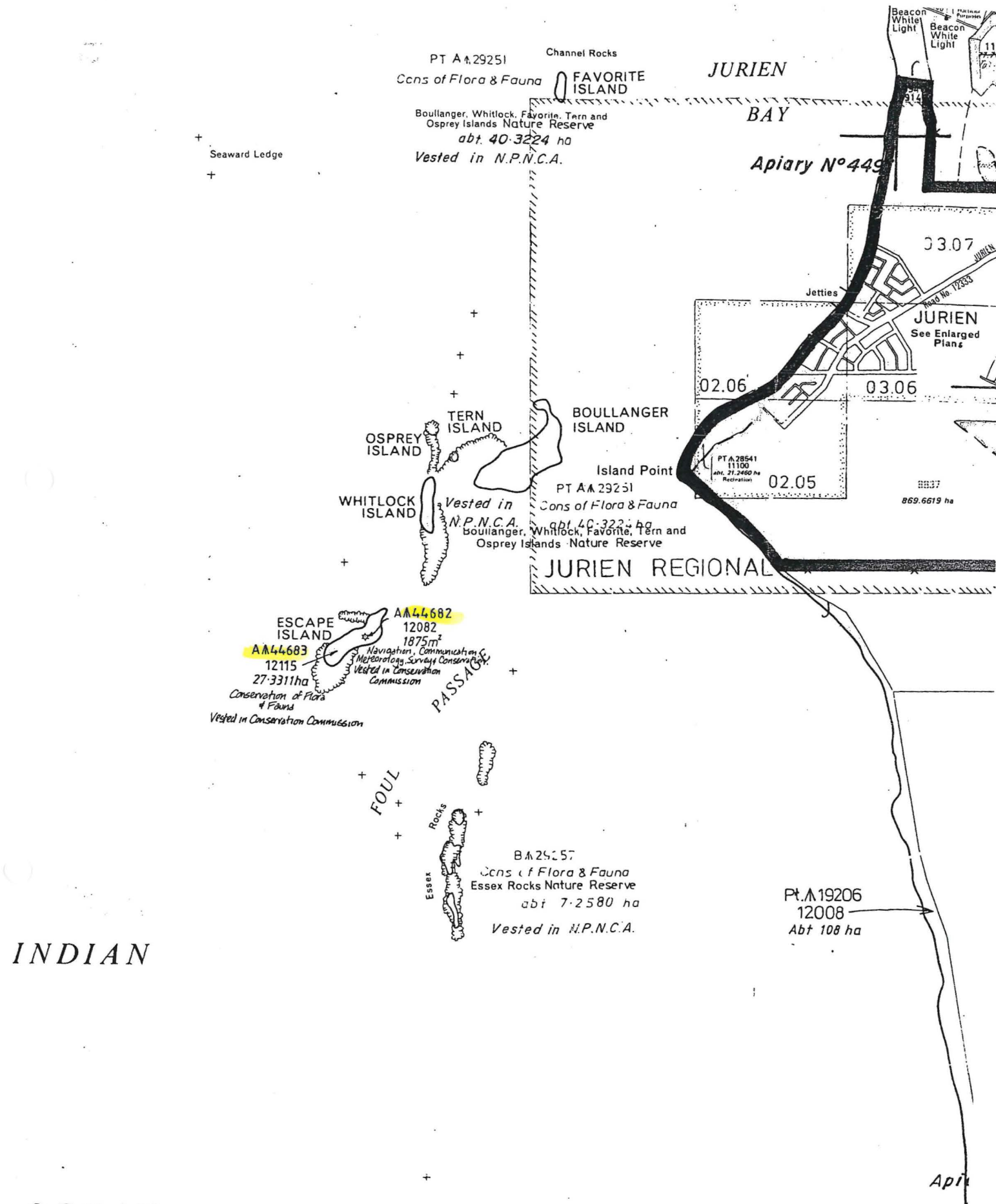

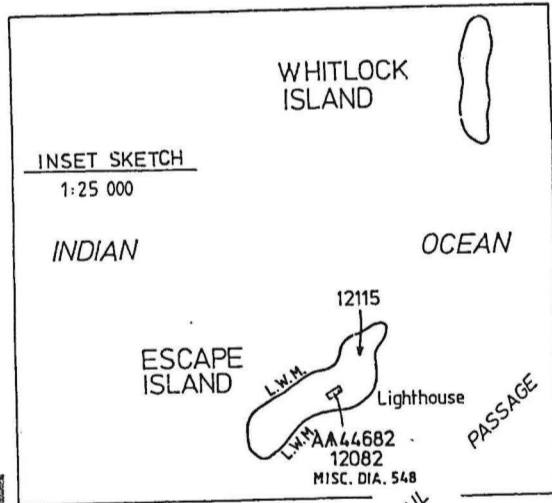
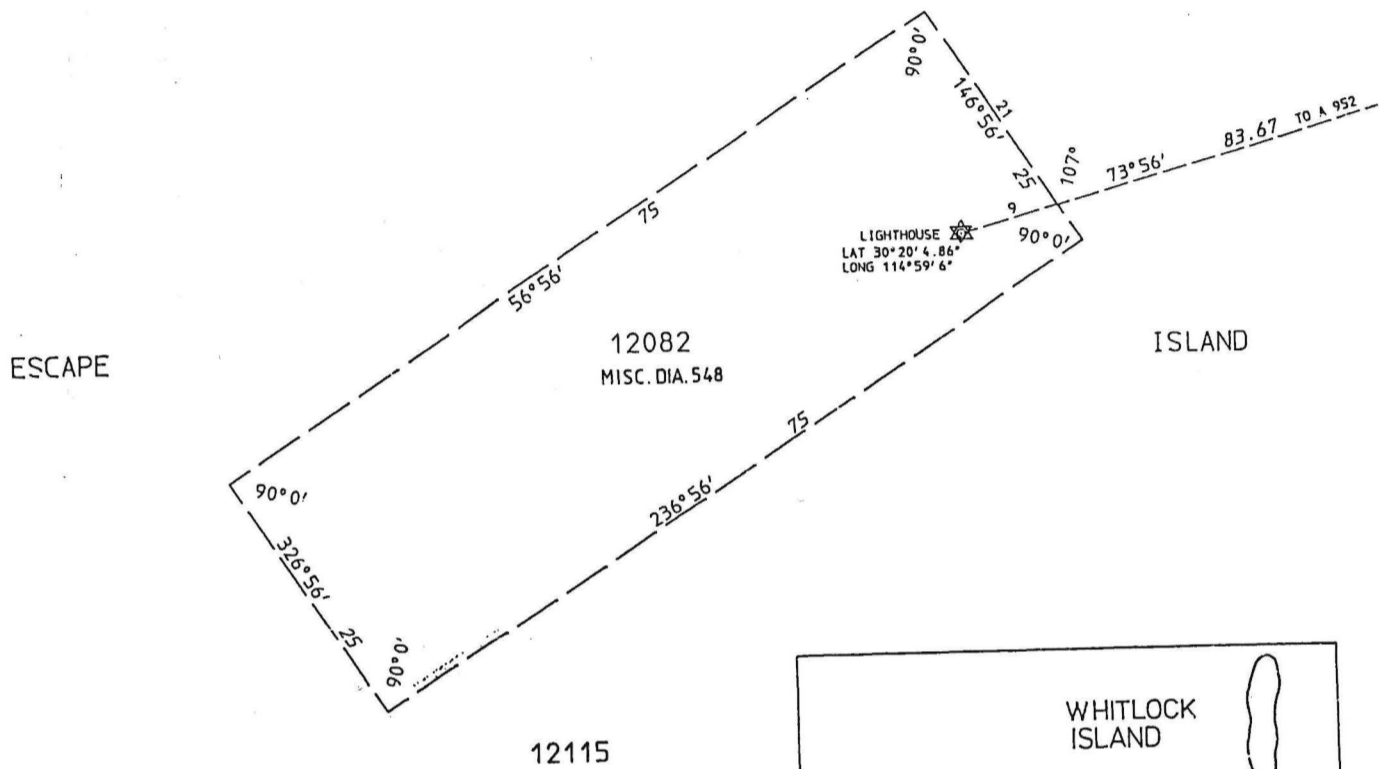
