**REASON FOR ACTION**

Avon Location 29429 on Deposited Plan 220601 has been reserved for the purpose "Conservation of Flora and Fauna". The Reserve is automatically vested in the Conservation Commission pursuant to Section 7 of the *CALM Act 1984*.

The area was purchased as part Avon Location 23456, under a Contract of Sale, on 9 September 1999. The purchase was funded from the Salinity Action Plan funds, with assistance from the National Reserve System Program of the Natural Heritage Trust.

The Reserve supports a wide range of soil types and associated plants, including two species listed on CALM's priority flora list: *Acacia arcuatis* and *Dryandra cynaroides*.

Area: 524.397 hectares

Note: the reserve should have been class A, the matter is being pursued with DPI.



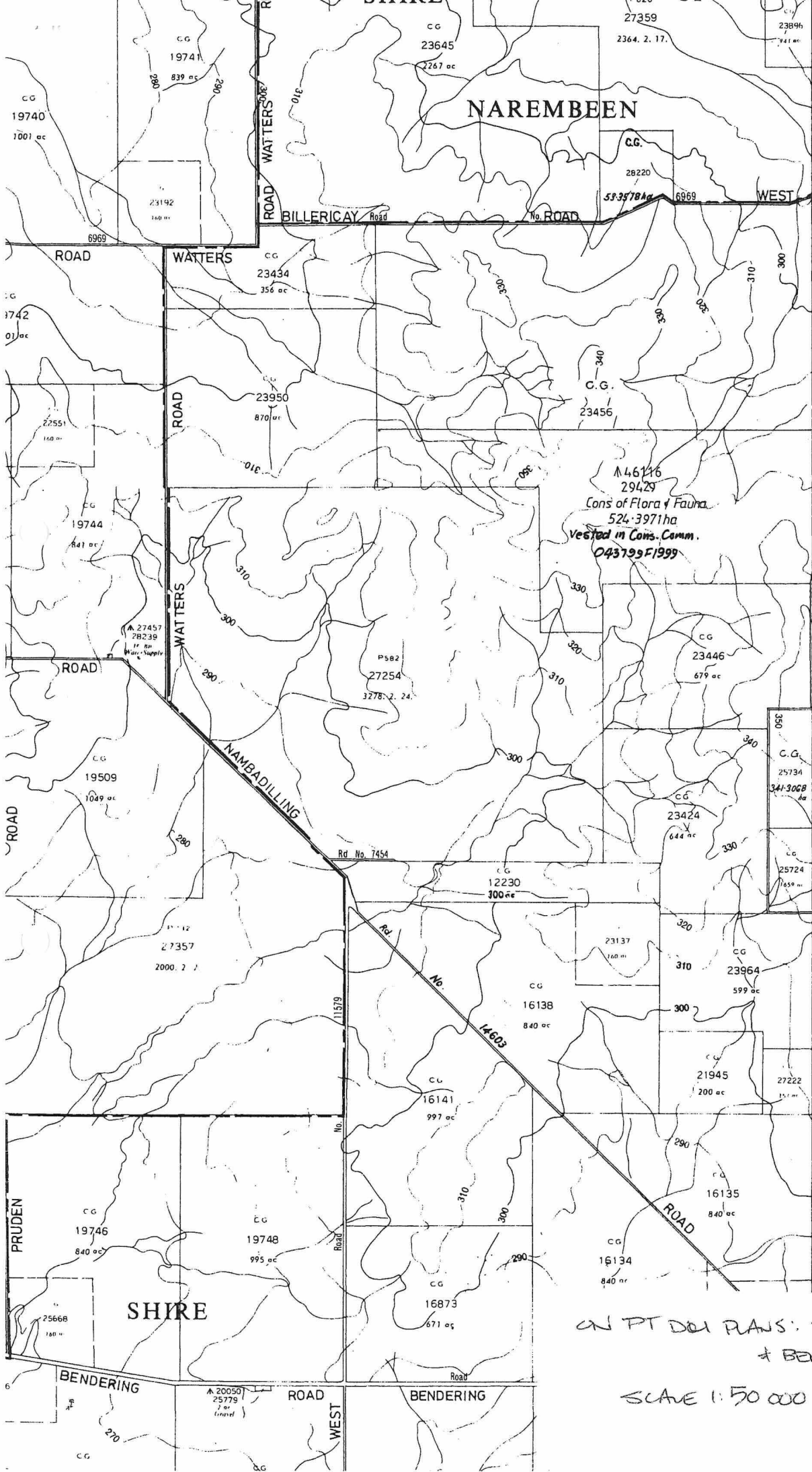
