

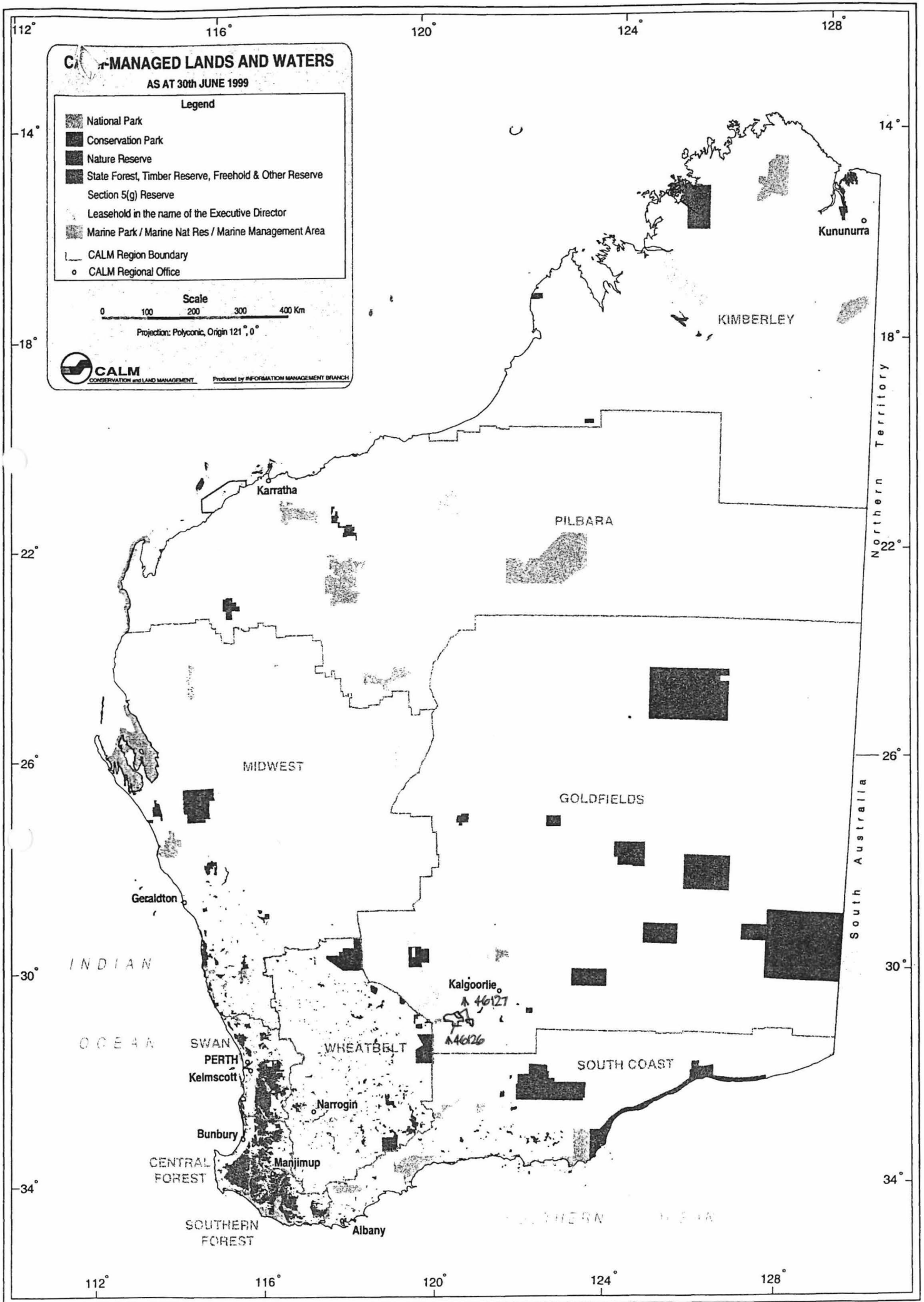

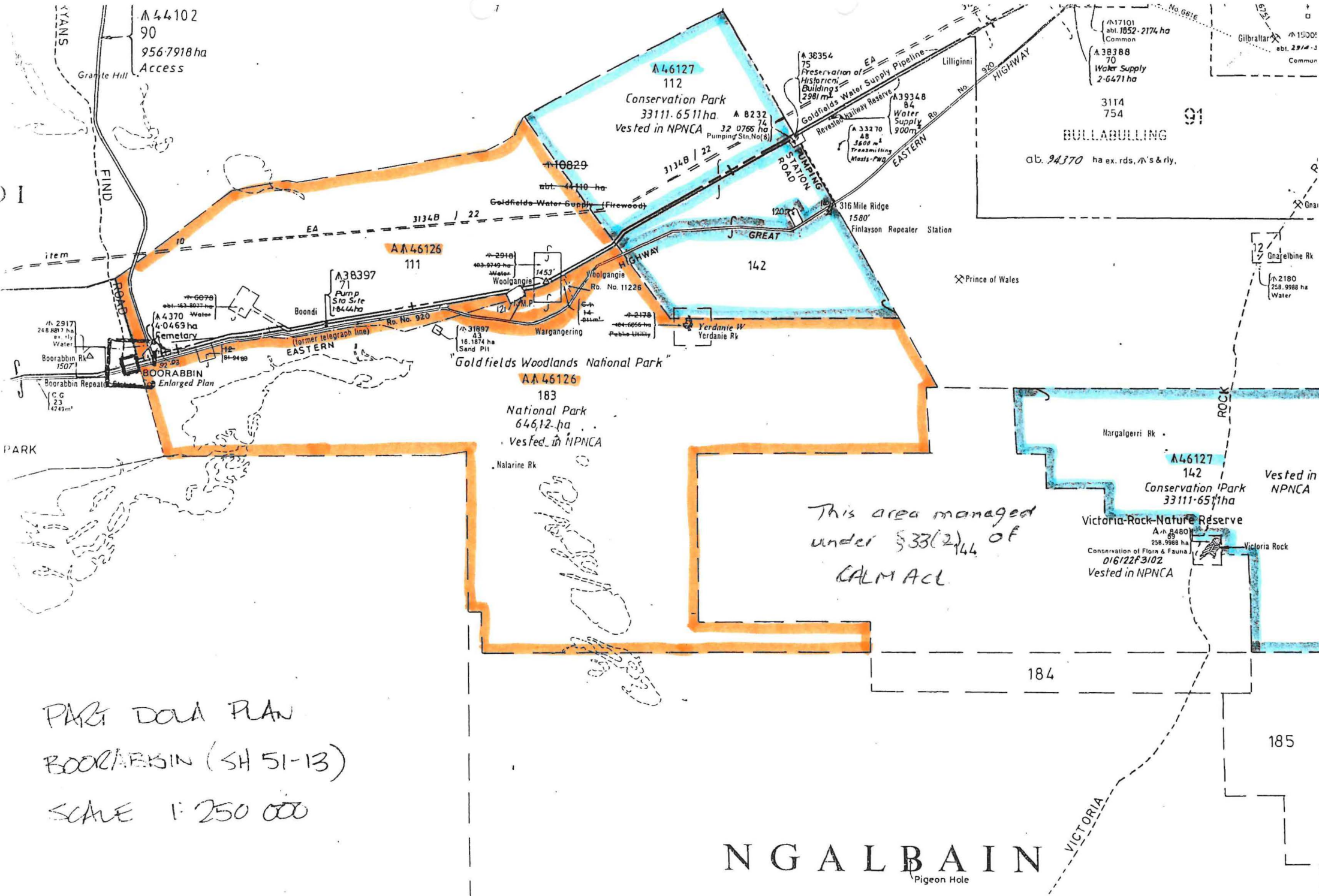
RESERVE No. 46126 (Goldfields Woodlands National Park)

REASON FOR ACTION

- Creation of a new class A national park, with a Management Order issued to the Conservation Commission, for the purpose 'National Park'. Area : 64612 hectares
- The reserve is of very high value to conservation. It contains a diversity of landforms and vegetation types including sandplains, eucalypt woodlands and granite complexes. Biological surveys have recorded the richest assemblage of dragon lizards for the eastern goldfields.
- Reserves 46126 and 46127 have been created as stage 1 in the setting aside of a substantial area as national park and conservation park, arising from recommendations in the Regional Management Plan for the Goldfields Region (see folio 335).
