REASON FOR ACTION

- Creation of a new class C reserve, vested in the Executive Director of the Department of CALM, for the purpose of "Western Australian Herbarium". The 2.32 hectare area has been excised from Agriculture Western Australia Reserve 24727.
- An agreement was reached between Agriculture Western Australia (AgWA) and the Department of CALM to transfer the vesting of this portion of land (↑46230) to NPNC since the infrastructure, staff and budget, for the operation of the Herbarium, was transferred from AgWA to CALM in 1988.

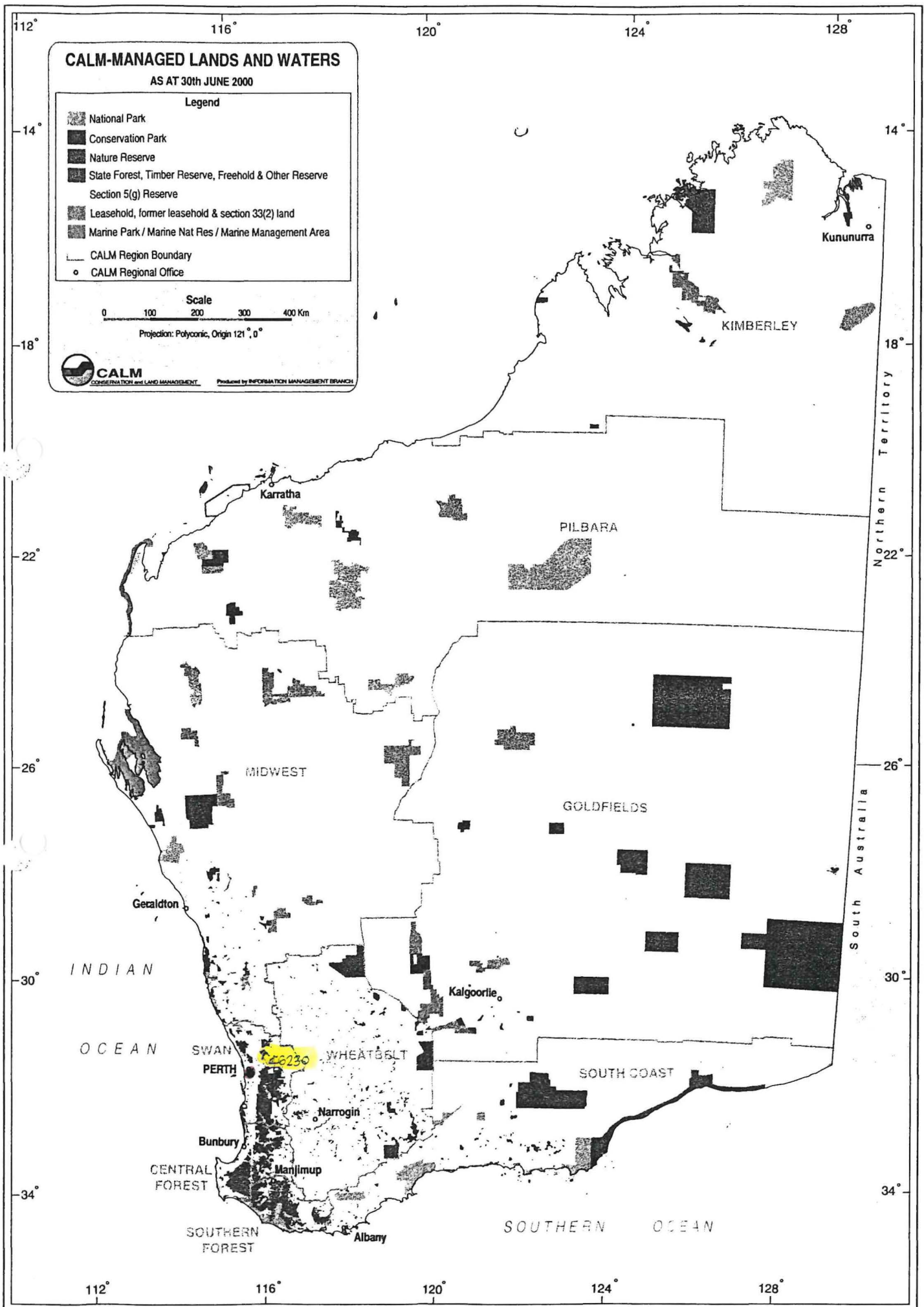
