

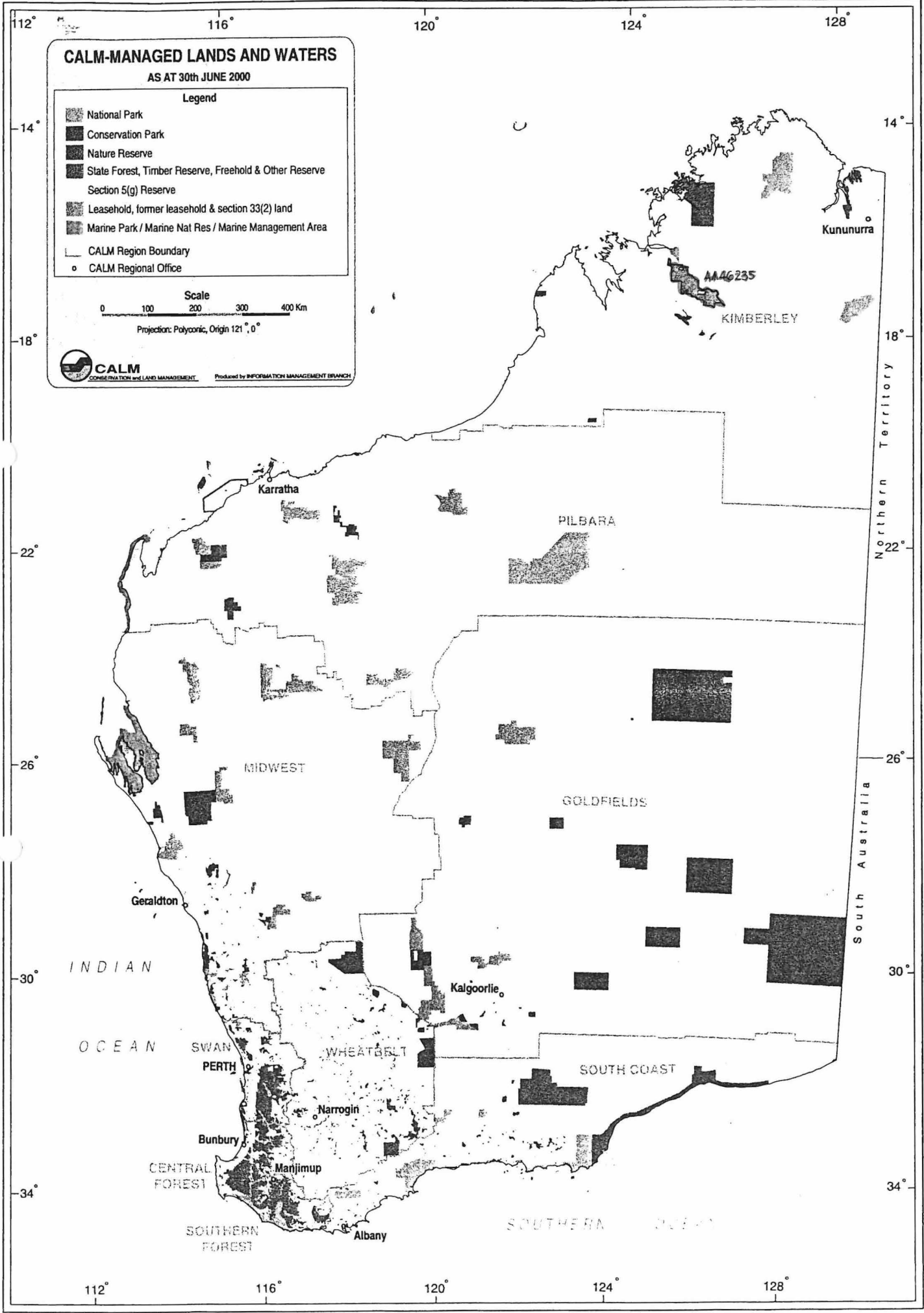
## RESERVE ACTION SHEET - CONSERVATION RESERVES

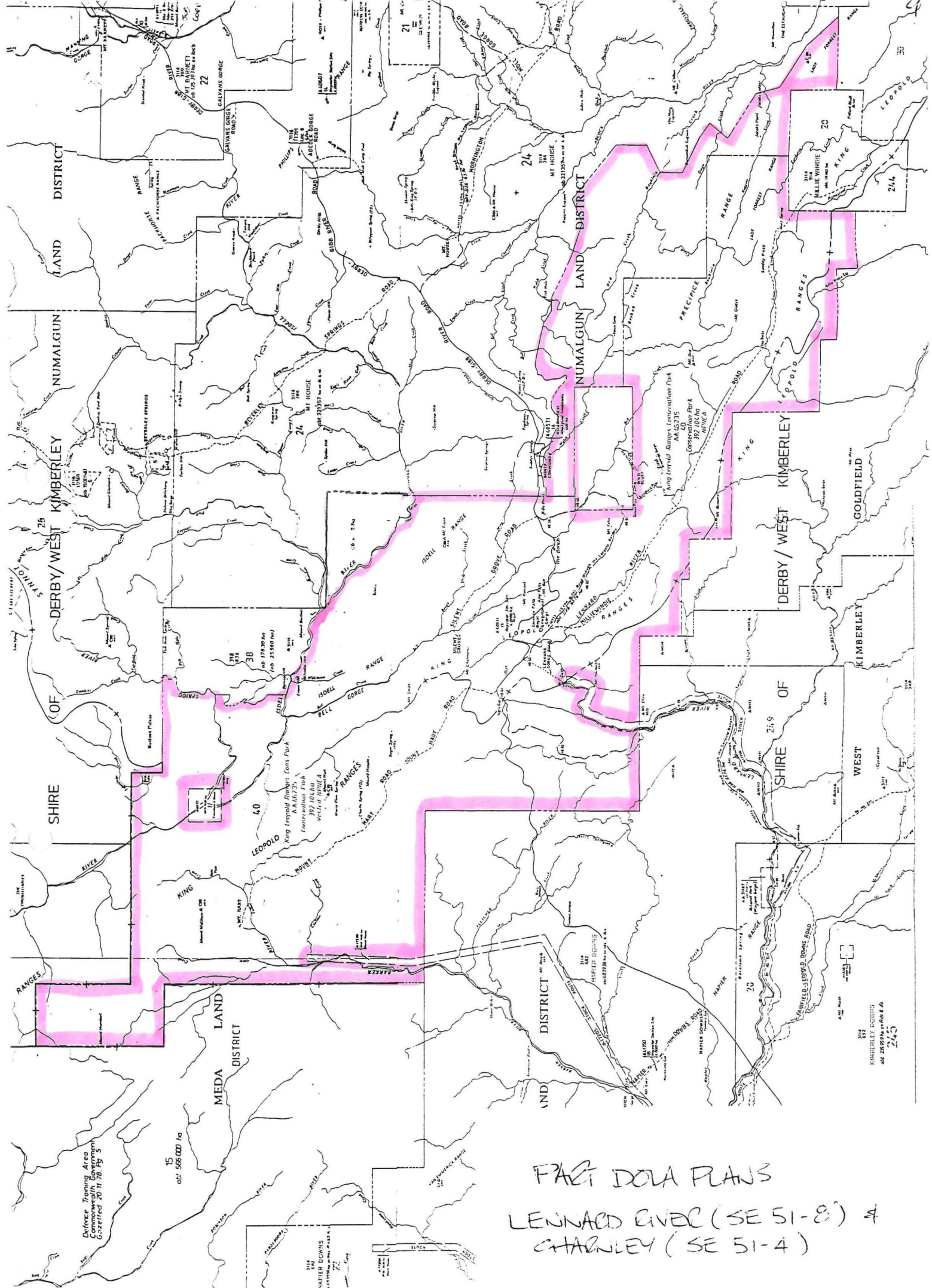
**RESERVE No. 46235**

### REASON FOR ACTION

- Creation of a new class A reserve with a Management Order issued to the Conservation Commission for the purpose 'Conservation Park'. Area: 392,104 hectares.
- This Conservation Park contains among the most complete suite of native flora and fauna in Australia and is thought to be one of the only mainland parts of the State from which there has been no species extinctions since the coming of Europeans. The creation of the park will also enable the area to be managed to conserve the region's distinctive Aboriginal heritage and culture.
