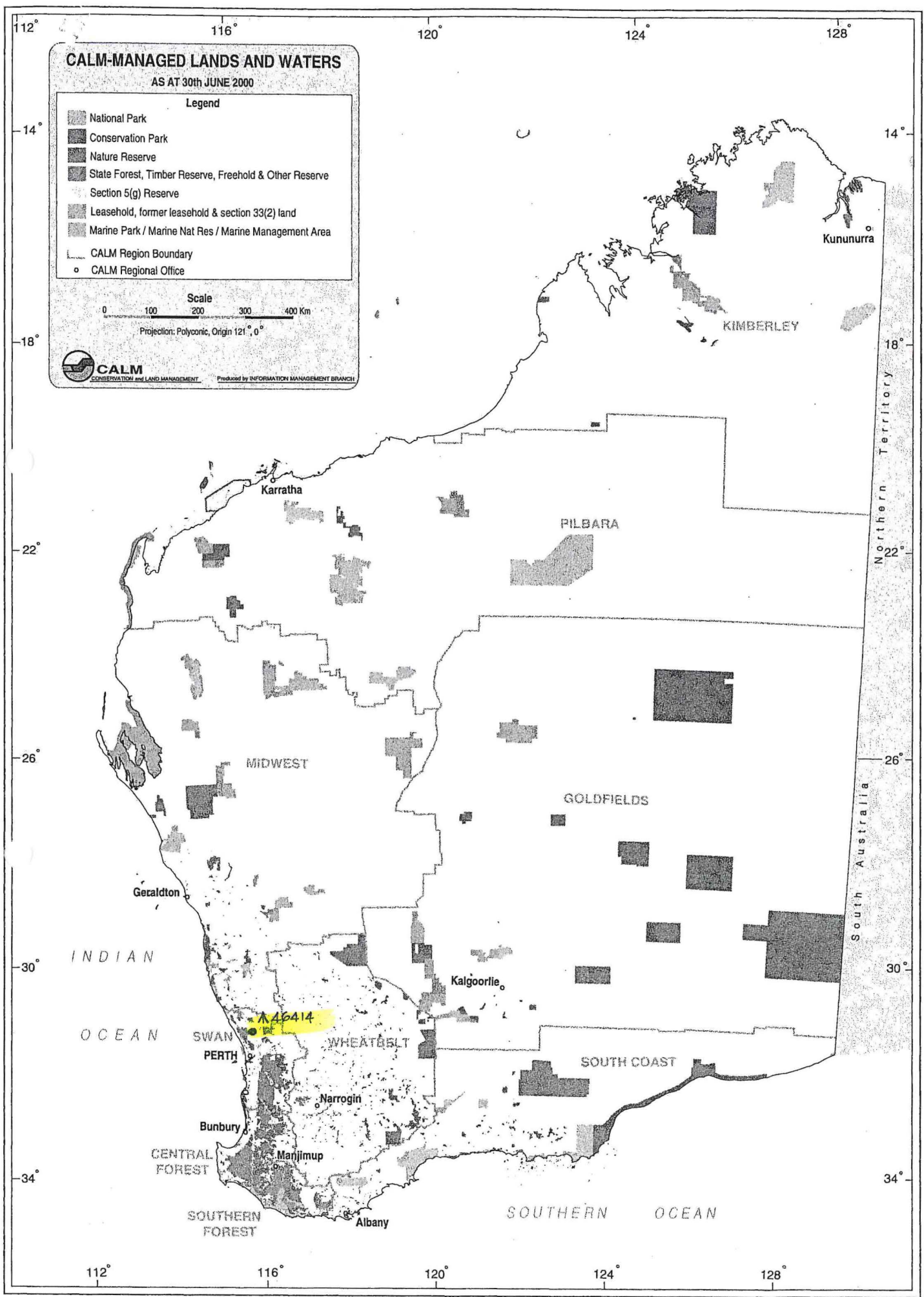
The creation of a nature reserve with a management order issued to the Conservation Commission for the purpose 'Conservation of Flora and Fauna'.

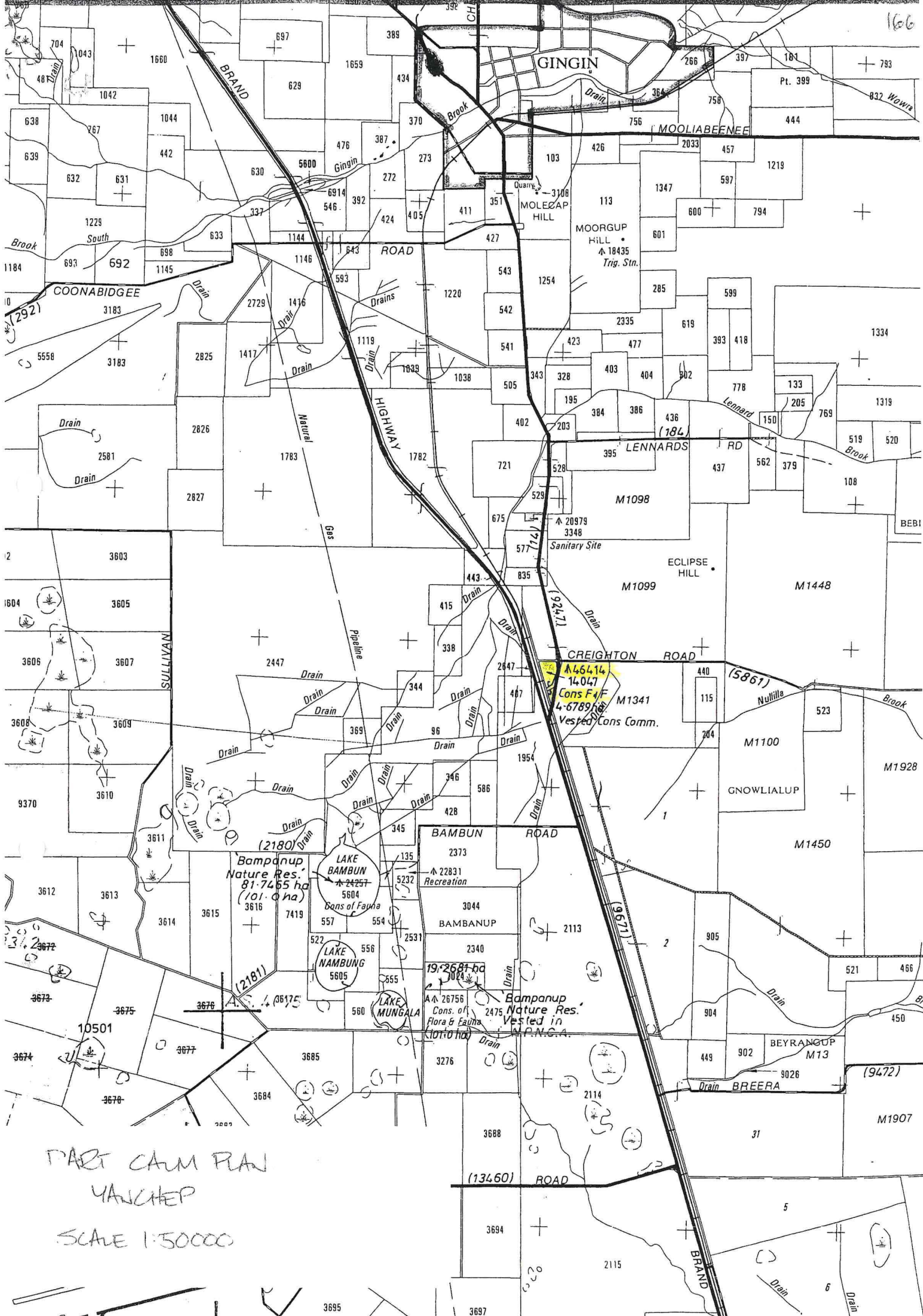
Area 4.68 hectares

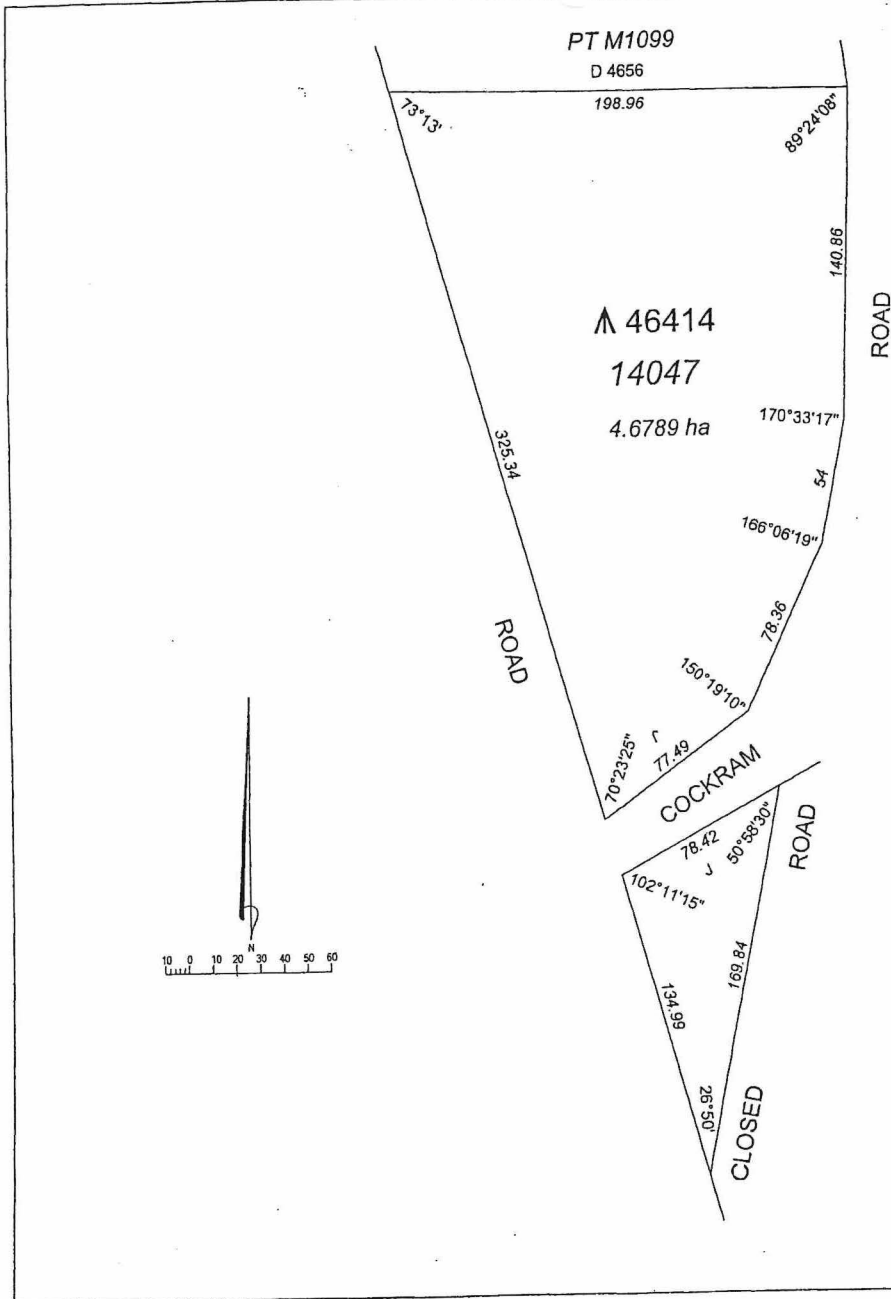

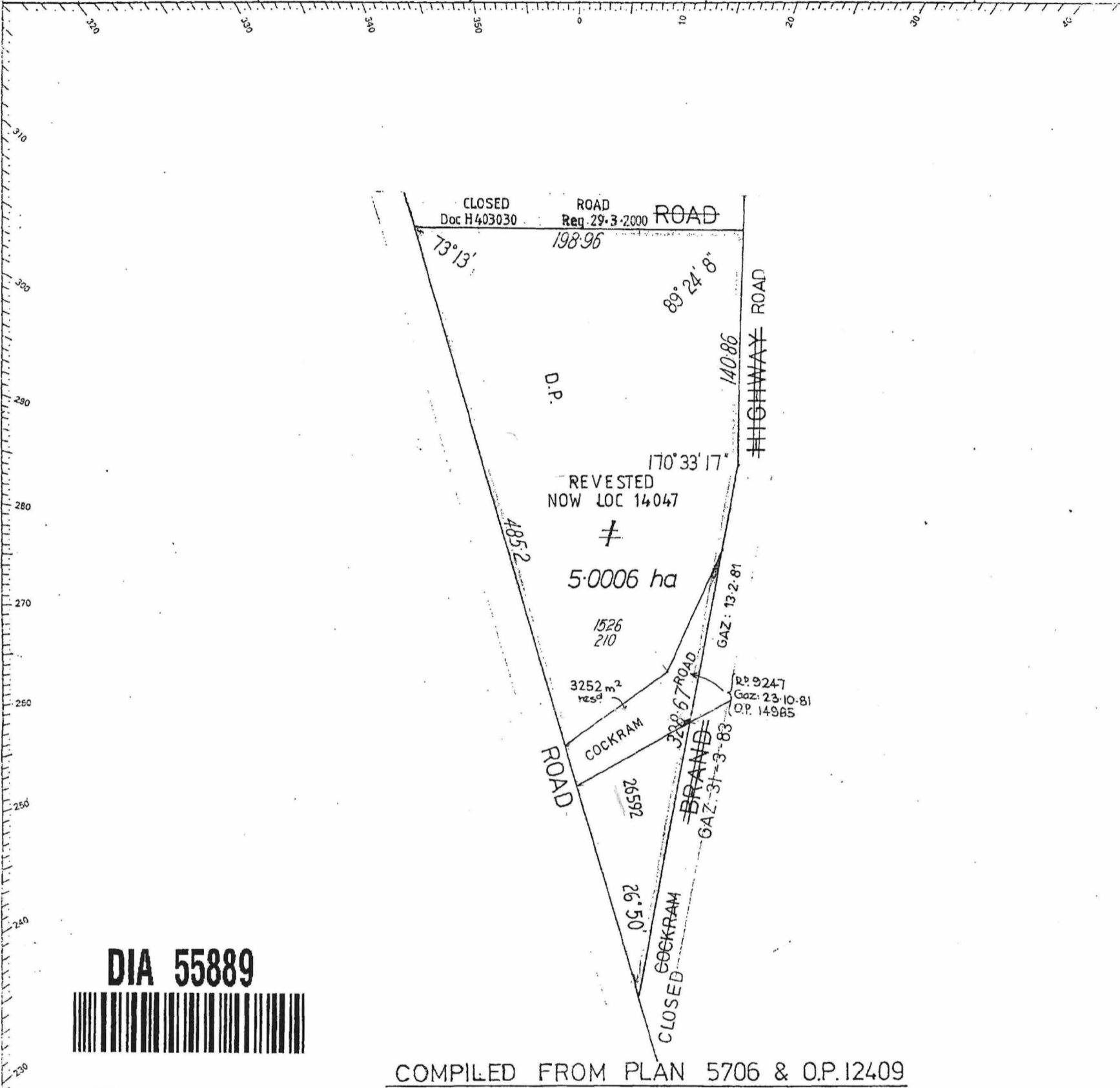
