RESERVE No. 46838

SHIRE: Dumbleyung

REASON FOR ACTION

Lot 15973 on Deposited Plan 221296 has been reserved for the purpose "Conservation of Flora and Fauna". Reserve 46838 is vested in the Conservation Commission of Western Australia.

Area: 270.6059 ha

The area was purchased from the Wheatbelt Salinity Strategy funds, with assistance from the Commonwealth Government through the National Reserve System Program of the Natural Heritage Trust.

The Reserve supports four vegetation types, represented by 240 taxa from 33 families. Five species of priority flora have been recorded: *Astroloma microphyllum*, *Daviesia tortuosa*, *Jacksonia tarinesis*, *Gastrolobium densifolium* and *Eucalyptus depauperata*. The threatened Baudin's Cockatoo has also been recorded on the reserve.

Note:

- The former Department of Mineral and Petroleum Resources opposed class A classification, at least until the current mining tenement expires (p. 223).
- It is proposed to vest the adjoining Reserve 18254 with the Conservation Commission. CALM is currently liaising with the Water and Rivers Commission in this regard.

I refer to your letter dated 23 November 2001 requesting a review of our previous opposition to the "A" classification for the above land.

The main tenement affected, Exploration Licence 70/2209, was granted on 21 February 2000 for a period of five years after which it may be renewed.

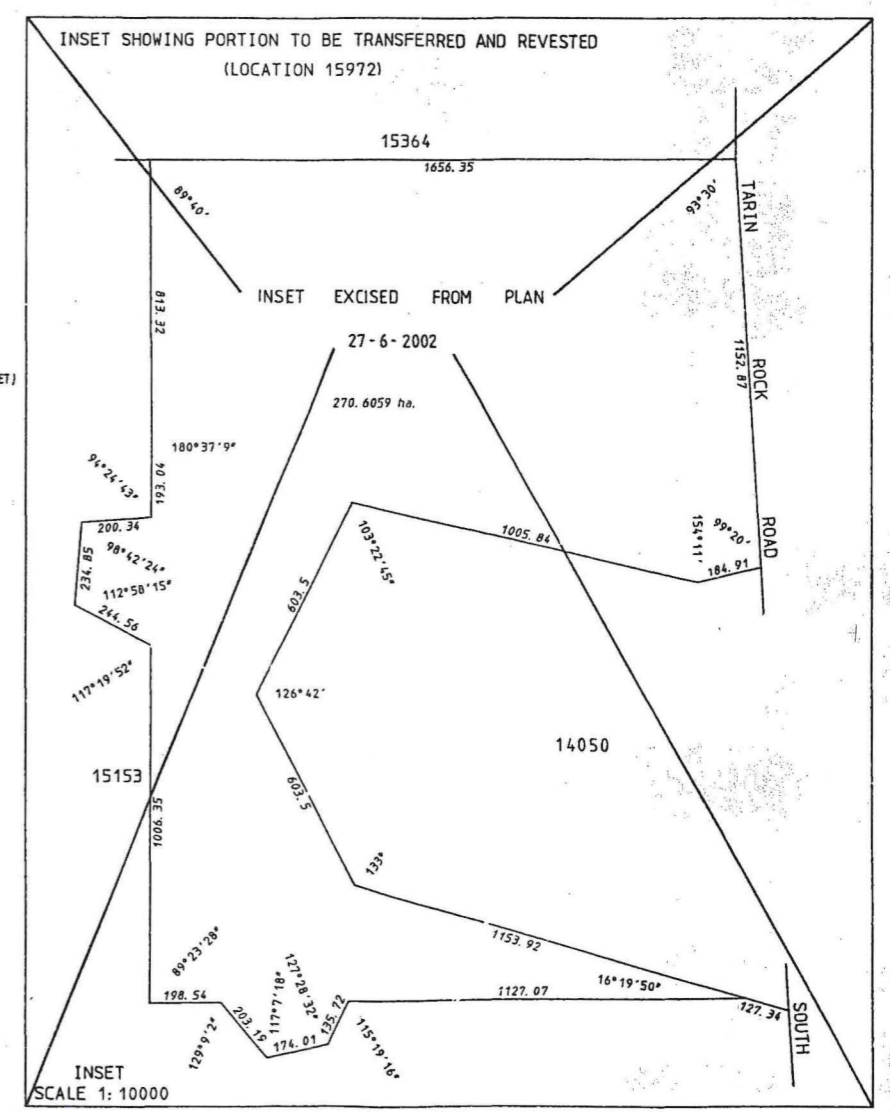
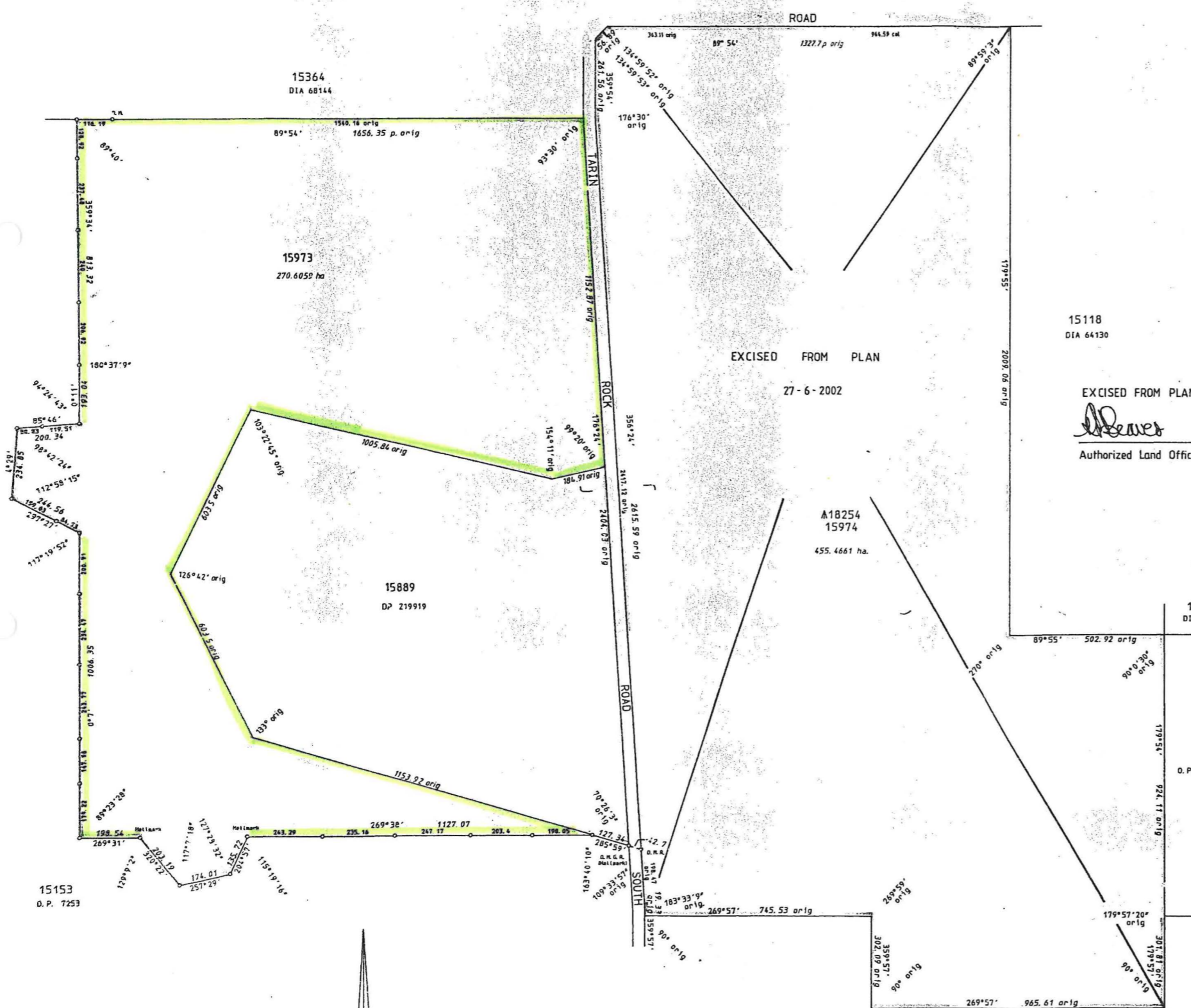
