

RESERVE ACTION SHEET - CONSERVATION RESERVES

RESERVES 46875, 46919 & 46920: LEXIA WETLANDS, CITY OF SWAN

REASON FOR ACTION

These reserves were created from land acquired by the former Ministry for Planning following a Cabinet Decision of 4 October 1994 regarding the Ellenbrook Land Exchange. The land exchange involved the Government selling an area of State Forest No. 65, identified as suitable for urbanisation, to the Ellenbrook Joint Venture (EJV), at Ellenbrook. In exchange, the government acquired an area of EJV land, that was transferred to the Crown from the Ministry for Planning under section 37A(4) of the Metropolitan Region Town.

Separate reserves were created for each area as their formal naming and management depends on the development of Gngangara Park and progress with DPI's acquisition of other Lots for addition to the reserves. The long-term plan is that the 3 reserves will be amalgamated.

The class A nature reserves are vested in the Conservation Commission of WA for the purpose *Conservation of Flora and Fauna*.
