REASON FOR ACTION

Lot 10 on Deposited Plan 33545 has been gazetted as a class A reserve for the purpose of "Conservation of Flora and Fauna". The reserve is automatically vested in the Conservation Commission of Western Australia pursuant to section 7 of the *CALM Act*.

Area: 9.1253 hectares

The land was purchased as part of freehold title Swan Location 1546 under a Contract of Sale on the 18 July 2001. The area was purchased because of the presence of the critically endangered community of tumulus (organic mound) springs of the Swan Coastal Plain. The reserve also contains remnant banksia forest which buffers the springs, and has significant influence on the springs' hydrology.

The National Reserve System Program provided 2/3rd of the funding for the purchase with the remainder allocated from the Central Land Acquisition Fund.

The area is part of Bush Forever site 97 – Kirby Road Bushland, Bullsbrook.
