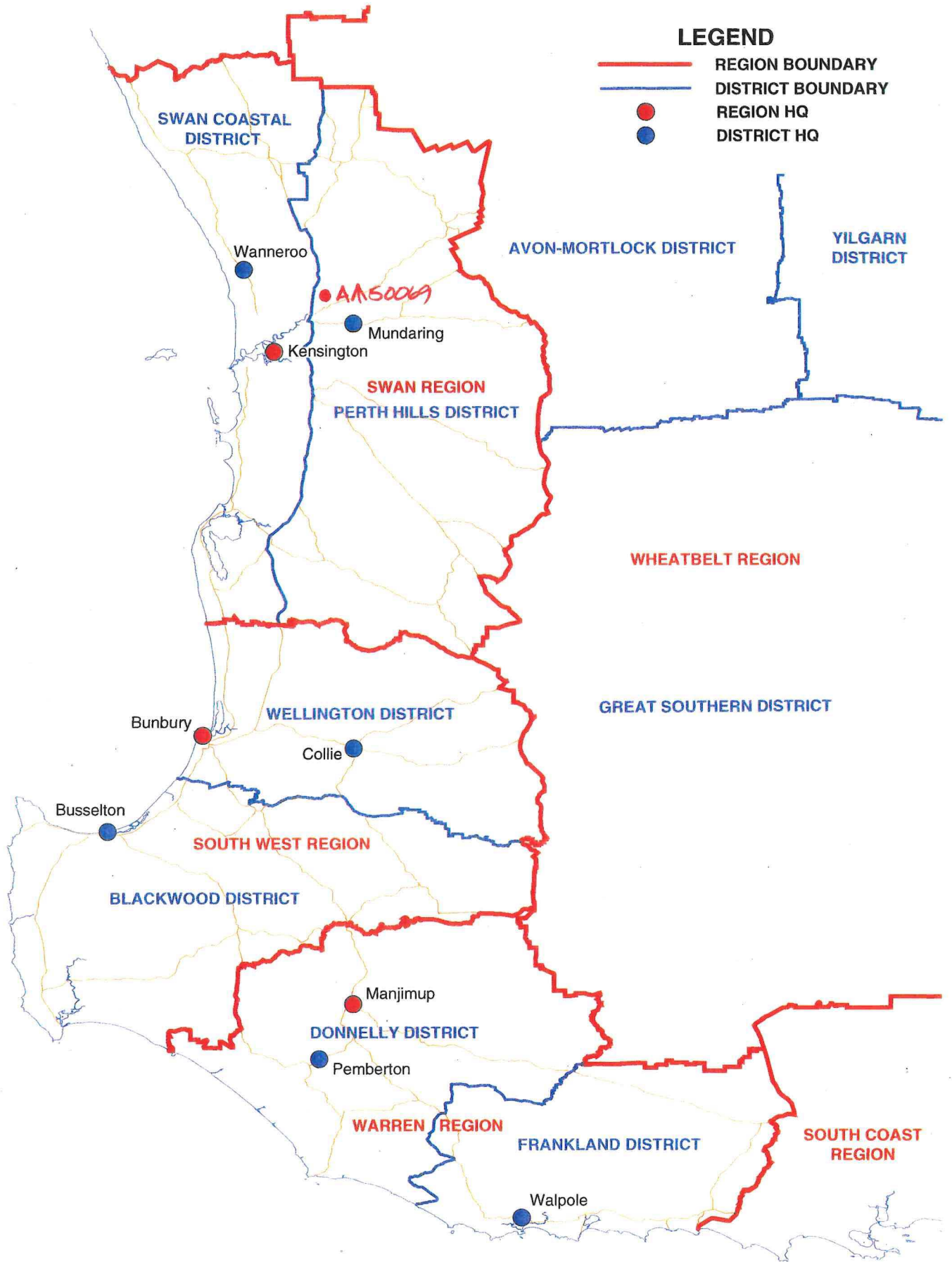
REASON FOR ACTION

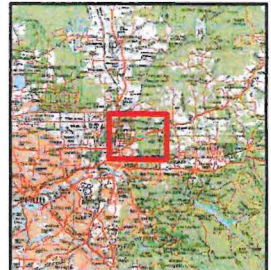
