REASON FOR ACTION: Main Roads WA ceded a portion of class 'C' Reserve 37296, for addition to Reserve 31030, as an offset for the widening of a section of the Brand Highway.

DPaW requested the entire Reserve 37296 (about 35 hectares), however the Department of Mines and Petroleum objected. Thus the hectares required for road widening equates to the 15.092 hectares added to the nature reserve.

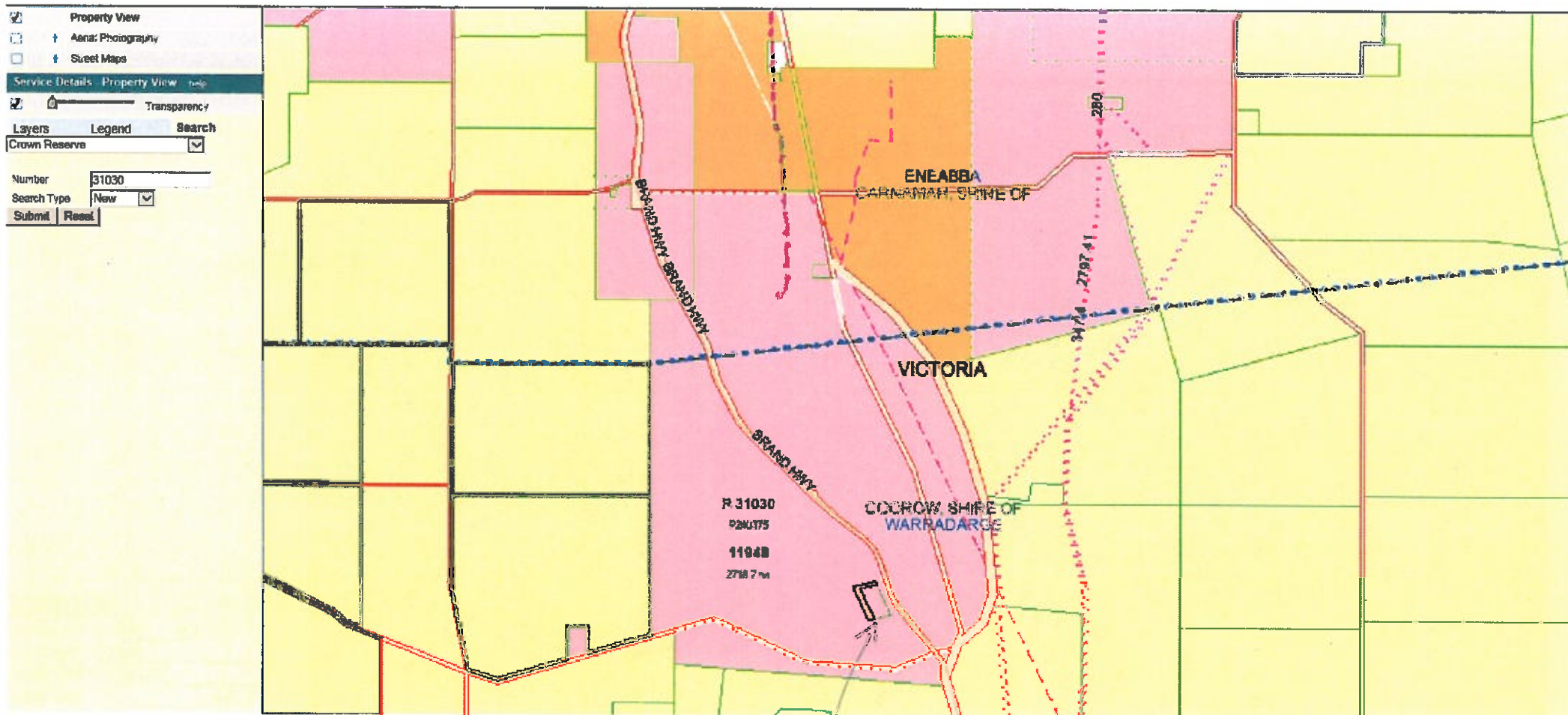
