**ACTION**

Cancellation of Reserve 35858 for freehold purchase by the Shire of Pingelly.

**Total Area:** 0.24 hectares

**REASON FOR ACTION:**

The Pingelly Depot was decommissioned in 2014/2015 when wheatbelt region operations were consolidated to the Narrogin office. In 2016 the Shire of Pingelly approached the Department regarding the future of the depot within Reserve 35858 and requested management of the site. The site was initially part of the adjacent Shire reserve and was transferred to the Department in the 1970s to provide a depot site in this area.

The CALM Executive Body approved the transfer of Reserve 35858 on an as is basis in February 2017. At the Shire's request the reserve has been cancelled by DPLH to facilitate freehold purchase of the site by the Shire.



**SUBJECT: PROPOSED TRANSFER OF RESERVE 35858 TO SHIRE OF PINGELLY**

**BACKGROUND**

Reserve 35858 located within the Pingelly town site is vested in the Executive Director of the Conservation and Land Management Body for the purpose of 'depot site'. Reserve 35858 was in use as the Pingelly depot since the late 1970s when a work centre for the Department of Fisheries and Wildlife was established in Pingelly. Since about 2006, the use of Pingelly as a work centre has significantly decreased with a consolidation to Narrogin as an outcome of two restructures. The depot has not been used following the latest Wheatbelt Region restructure.

Reserve 35858 is adjacent to the Shire of Pingelly Reserve 26413 which has a purpose of 'Government Requirements' and is used as a depot by the Shire. In 1977/78 the Department of Fisheries and Wildlife requested a 1000m<sup>2</sup> portion of the Shire's reserve to create the Pingelly depot. Reserve 35858 was created in 1982 but the Department had access to the site from the time the Shire agreed to the transfer in 1977/78. In 1987 an additional 1436m<sup>2</sup> were excised from Shire's reserve and added to Reserve 35858 to facilitate the storing of additional vehicles at the depot. A map of Reserve 35858 (which has an area of 2436m<sup>2</sup>) is provided at Attachment 1.

Parks and Wildlife no longer uses the Pingelly Depot. Wheatbelt Regional Manager Greg Durell advises that the Pingelly Depot was decommissioned about two years ago and that services previously located in Pingelly depot have now migrated to the Narrogin office.

The Shire of Pingelly has approached the Department seeking management of Reserve 35858 (Attachment 2). The Wheatbelt Region and Land Unit support the transfer of Reserve 35858 to the Shire of Pingelly on an 'as is' basis with no costs of the transfer to be borne by the Department. Reserve 35858 is fenced and currently contains a few minor structures of little value. The Shire of Pingelly will be responsible for any required upgrades or the removal of structures and any works associated with contamination that may be located on the site.

If Reserve 35858 is transferred to the Shire of Pingelly there will be a small cost saving to the Department as we will no longer pay water rates for this site.

## CURRENT STATUS

Reserve 35858 is held in the name of the Executive Director of the Conservation and Land Management Body and requires the approval of the Director General to facilitate the transfer.

If approved a letter has been provided for your signature requesting the Department of Lands to facilitate the transfer of Reserve 35858 to the Shire of Pingelly.
