ACTION

Transfer of a Reserve 36763, being Lot 10102 on Diagram 7133, Lot 11 on Plan 23291 and Lot 580 on Deposited Plan 246213 to the Conservation and Parks Commission as a reserve with the purpose of 'Conservation and Recreation'.

Total Area: 210.183 hectares

REASON FOR ACTION:

Forest Management Plan 2014-2023 recommends the creation of a *Conservation and Land Management Act 1984* section 5(1)(h) reserve over a portion of the Avon Valley located between the Avon Valley National Park and two other section 5(1)(h) reserve, managed for 'Conservation, Recreation and Tourism'.

The transfer of Reserve 36763 to the Conservation and Parks Commission as a reserve for 'Conservation and Recreation' meets the recommendation of the Forest Management Plan and assists to rationalise DBCA management in the Avon Valley.

Reserve 36763 was transferred to the Commission on 1 May 2020.

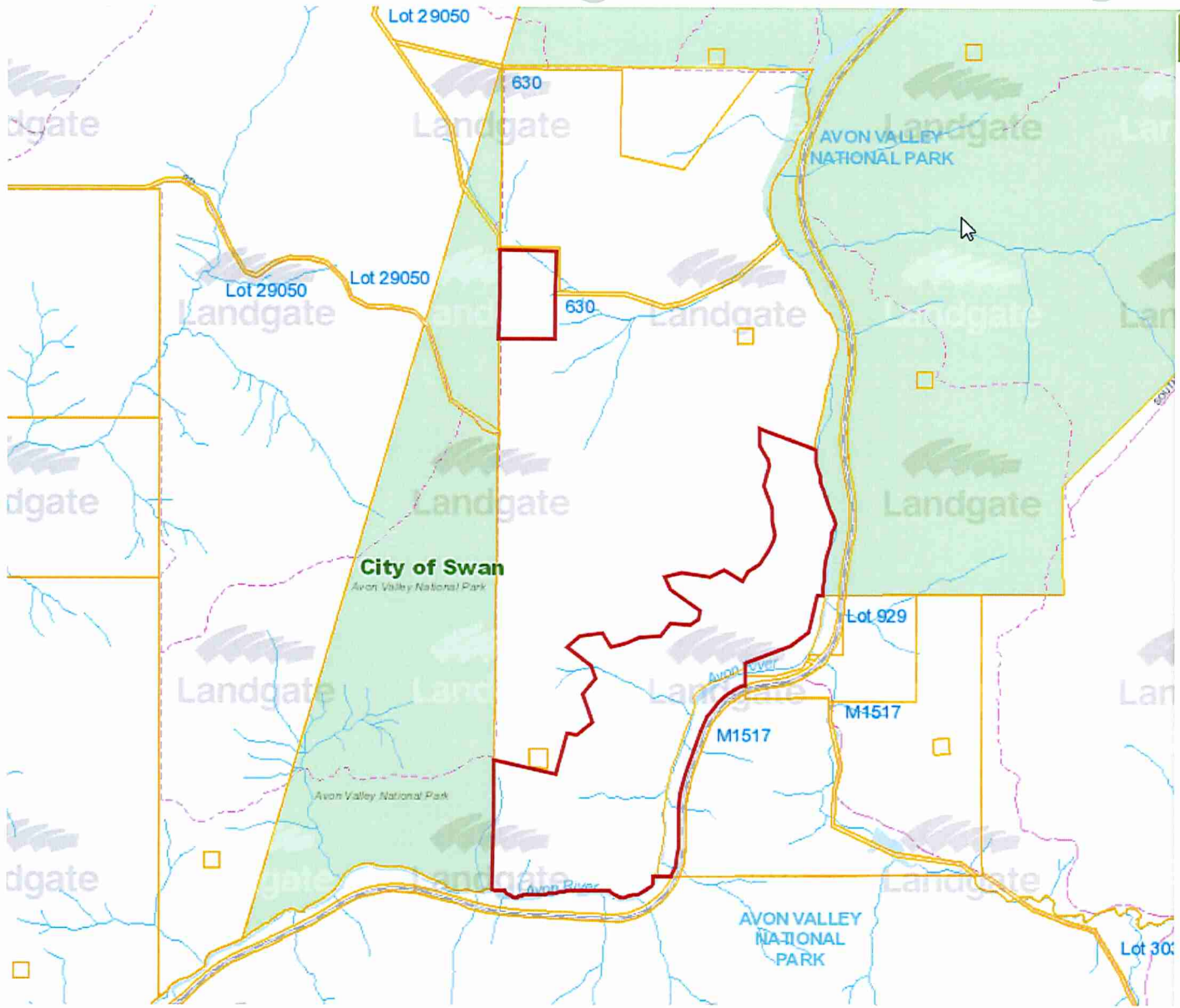

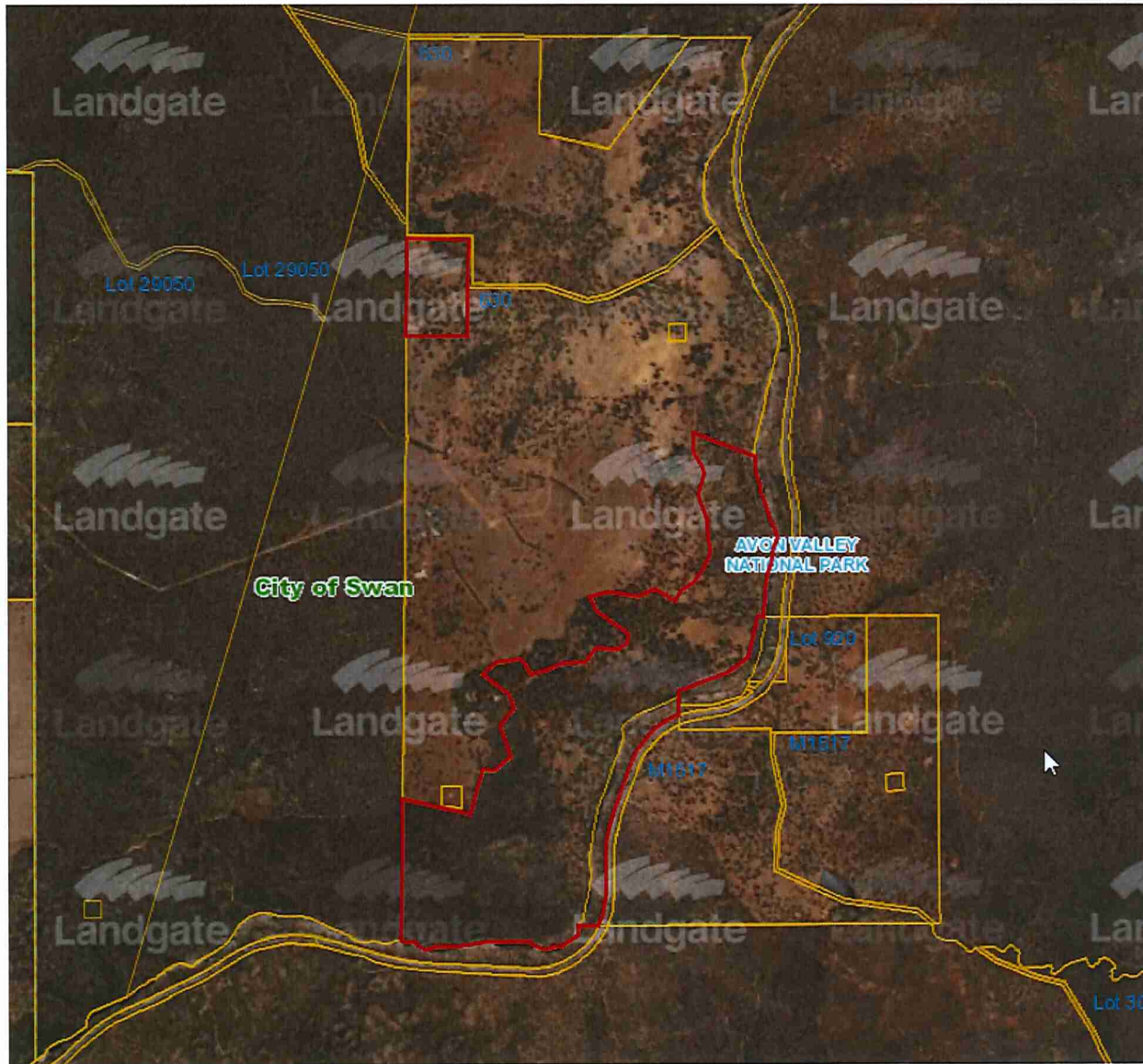
