PURPOSE: Conservation of flora and fauna

VESTING: Conservation and Parks Commission

ACTION:

Addition of 468.3098 ha, being Lot 700 on Plan 416481, to class A Nature Reserve 39703.

PREVIOUS AREA: 8.117 hectares

CURRENT AREA: 476.4268 hectares.

REASON FOR ACTION:

Department of Water and Environmental Regulation identified Reserve 20529 with purpose of 'water' as surplus to requirements. DBCA and the Shire of Mount Marshall expressed interest in management of Reserve 20529.

Reserve 20529 was known to contain populations of threatened flora *Boronia adamsiana* and four district vegetation types. Three of these vegetation types were under-represented in the conservation reserve system in the Wheatbelt Region. The conservation values of Reserve 20529 made it suitable for addition to the conservation reserve system. Lot 700, being the majority of Reserve 20529 was added to the adjacent class A Nature Reserve.

The Shire of Mount Marshall accepted management of Lot 701, being 77.96ha, which contains a historic site known as Datjoin Well, which the Shire manage for recreation.

The Water Corporation accepted management of 0.40 ha of reserve 20529, which contained existing water infrastructure.

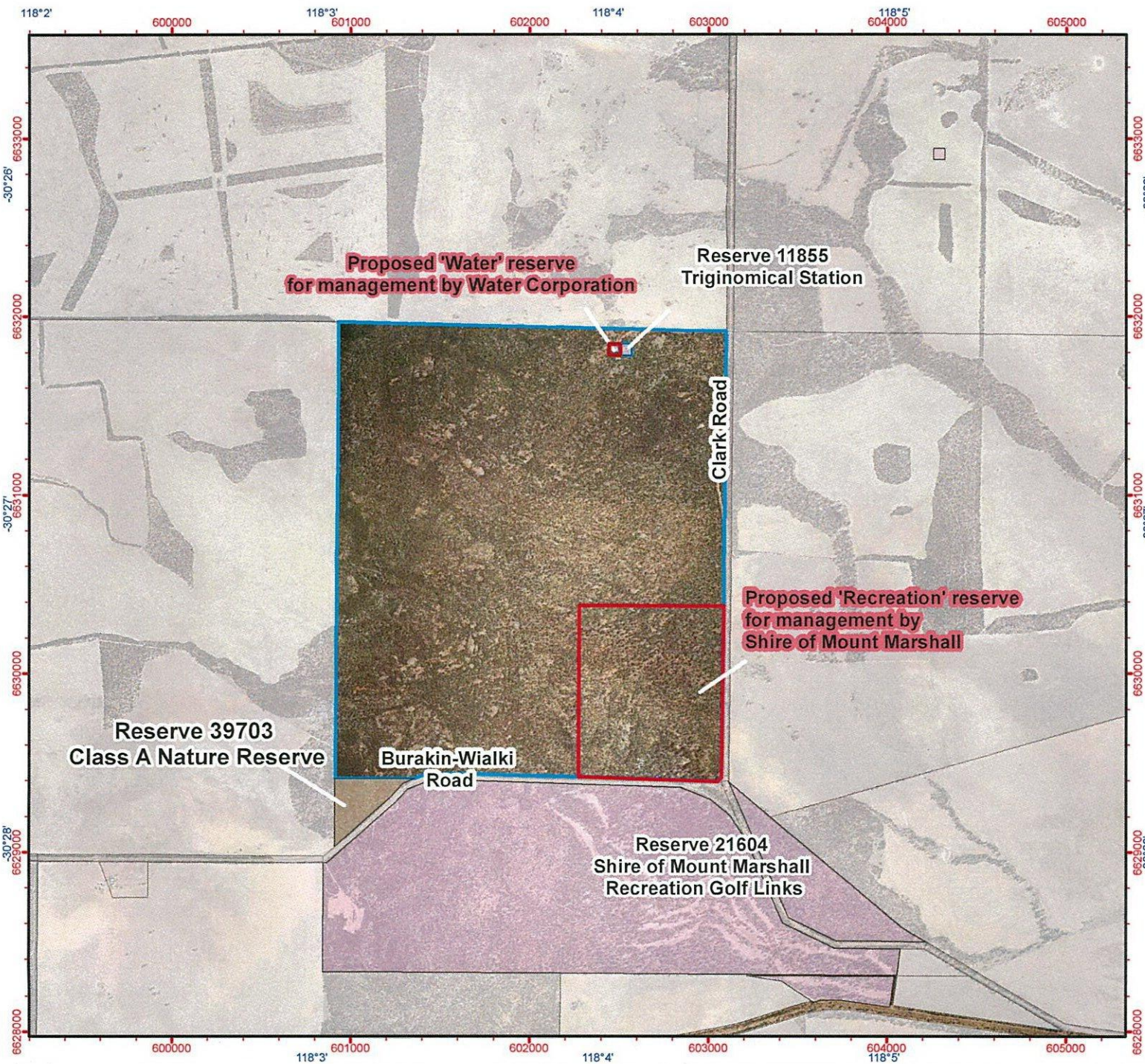

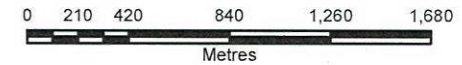
