**Total Area:** 0.0433 ha

**REASON FOR ACTION:**

This action is part of a statewide project to allow for enclave lighthouse and meteorological reserves contained within conservation estate areas to be transferred to the Conservation and Parks Commission (CPC), so that they could be managed in a way consistent with the surrounding estate area. The CPC will then negotiate a lease with the Australian Maritime Safety Authority over the areas. The result is consolidated tenure boundaries that provide for more efficient DBCA management of conservation estate areas.



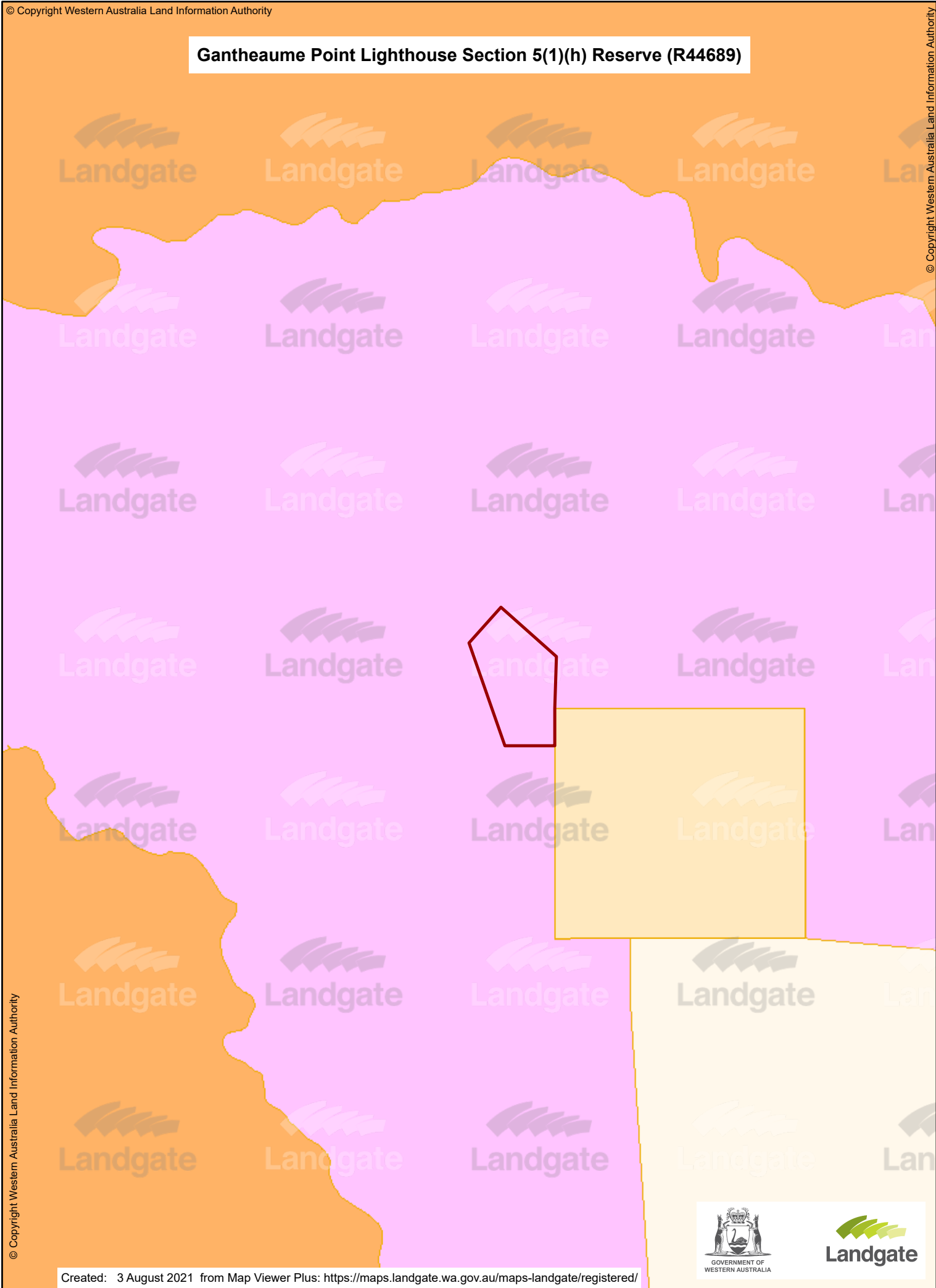
