REASON FOR ACTION: Excision from the Wooditjup National Park (formerly named Bramley National Park) to allow for the construction of the Margaret River perimeter road, or Margaret River bypass road, east around the Margaret River townsite. The road provides an alternative route for those travelling through Margaret River and reduces congestion in Margaret River. The excision was requested by Main Roads Western Australia, excisions from Timber Reserve 60/25 and State Forest 56 were also required to compelete the project.




