Ultimately, the department's intention is for WAPC freehold to be transferred to the department for the purpose of Conservation Park and the amendment of the land use for R51963 ensures consistency with the department's plans for the proposed "Wungong Regional Park".

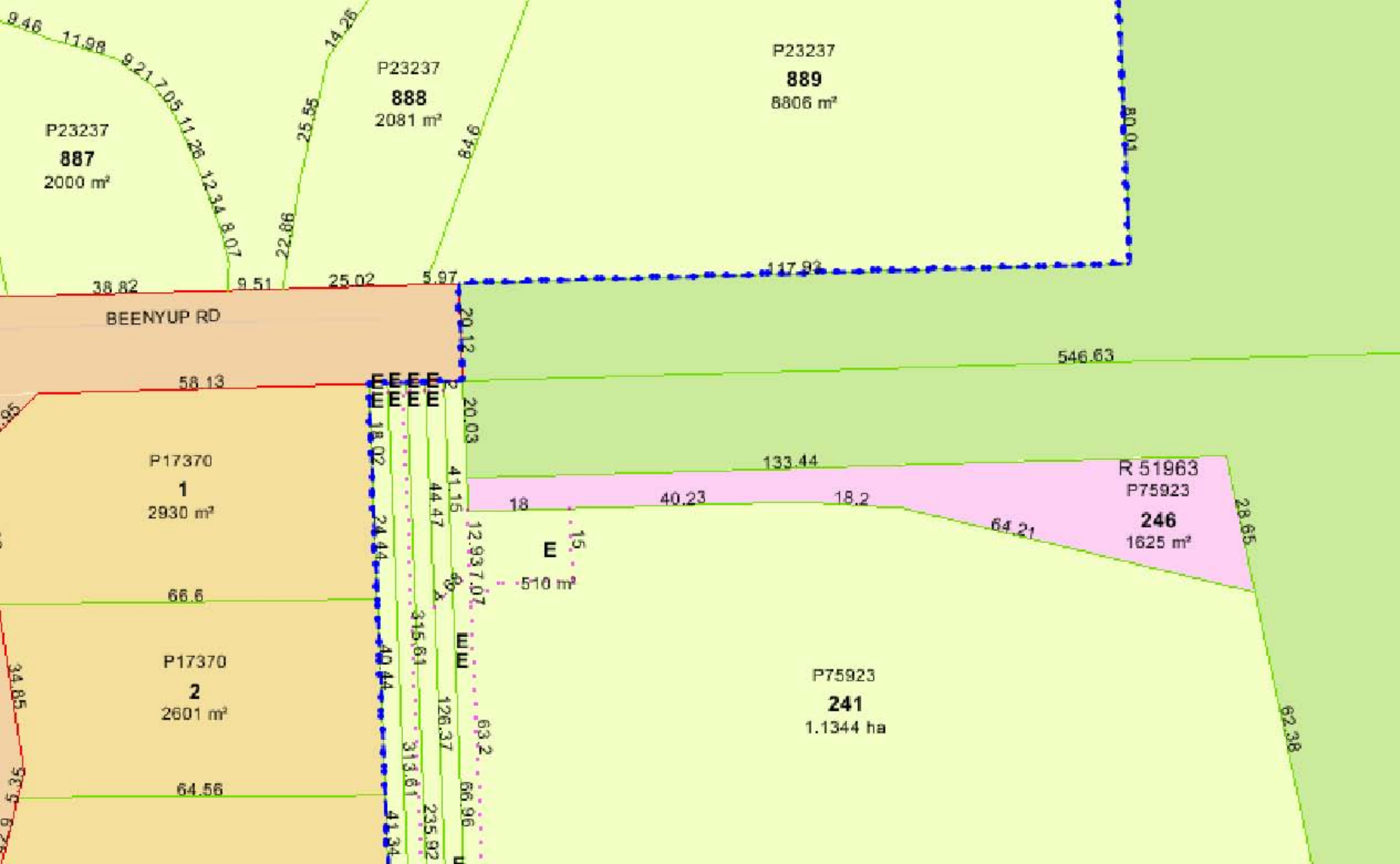

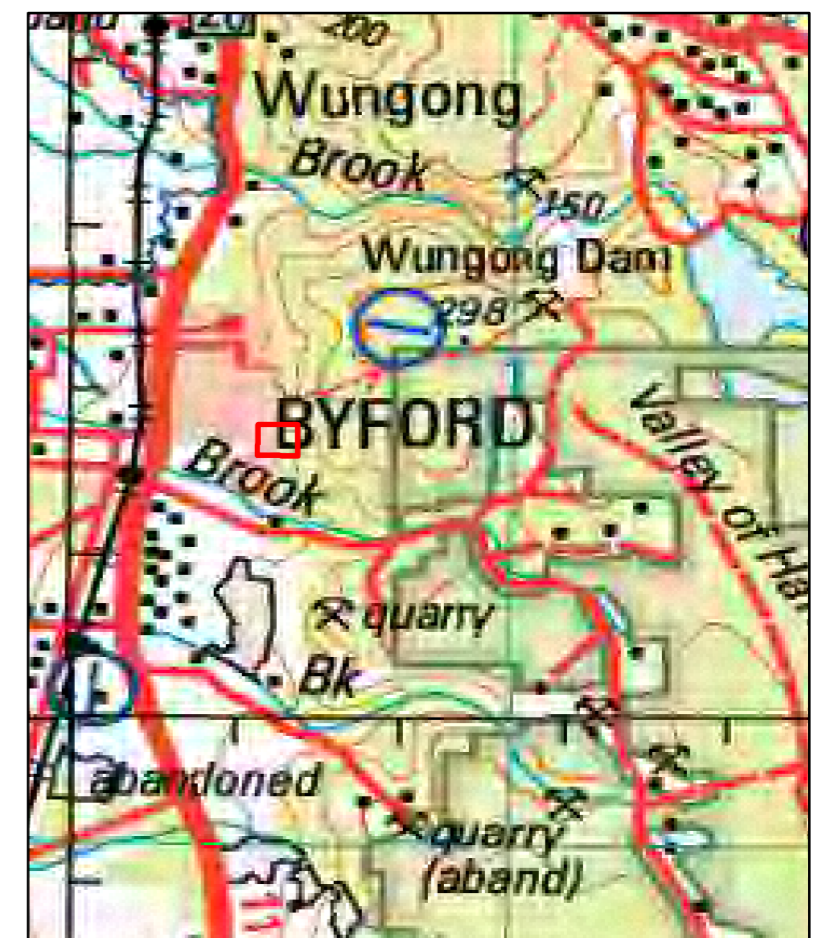
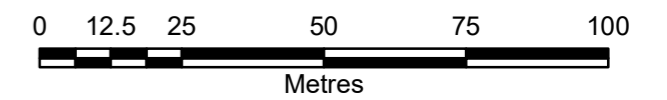
R51963 BEENYUP ROAD KARRAKUP

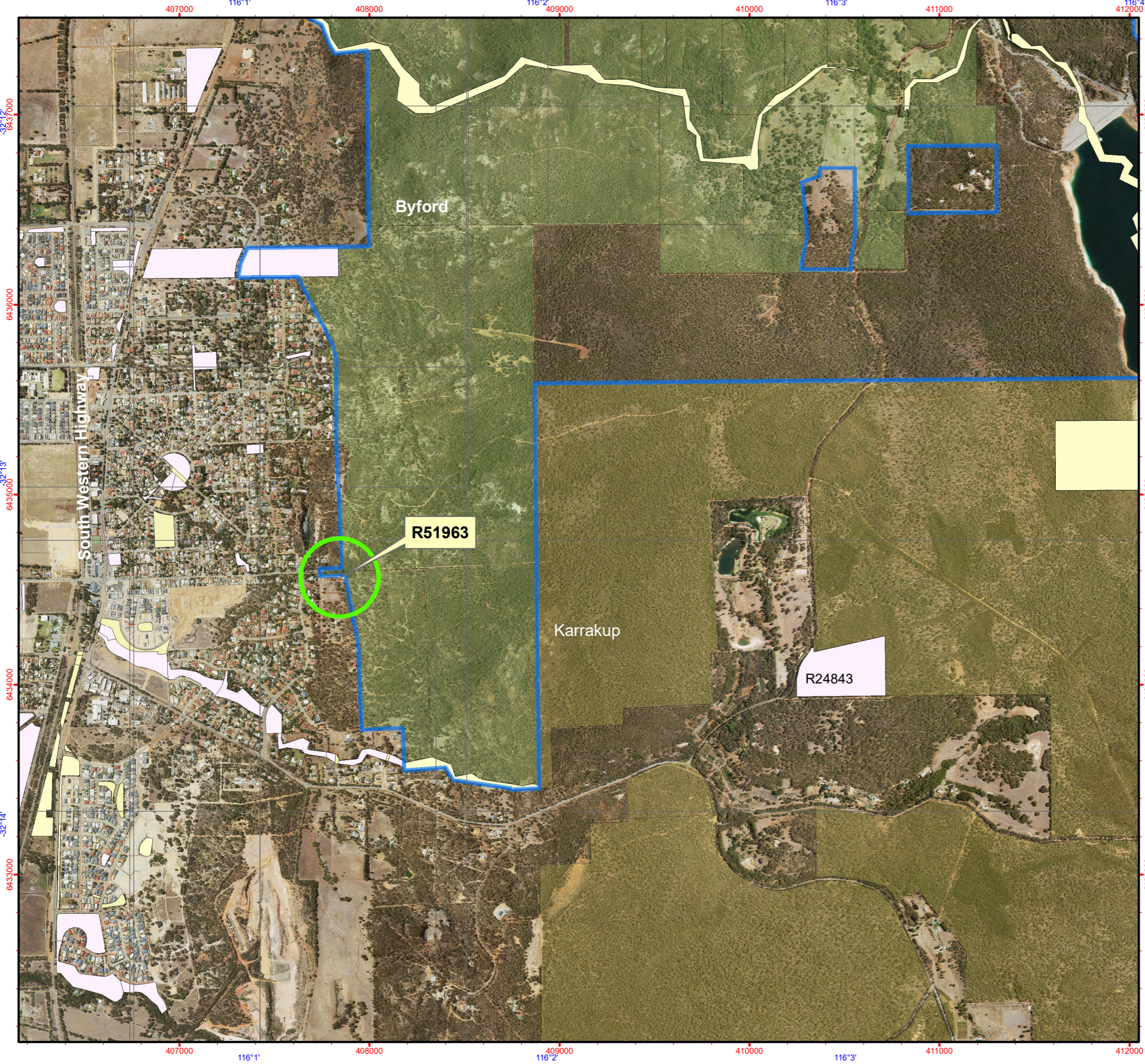

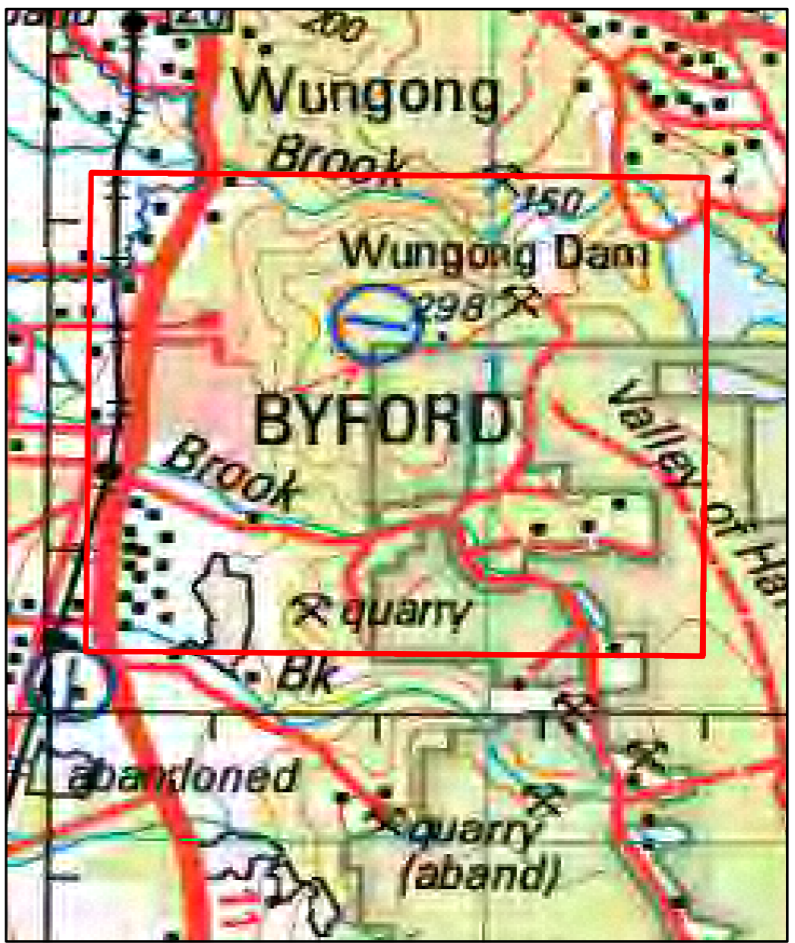
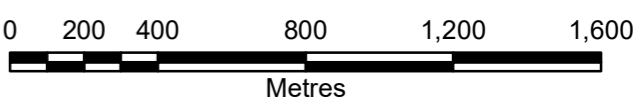
