REASON FOR ACTION:

The Herdsman Lake Regional Park Management Plan states that the City of Stirling has resolved not to retain management of Reserve 28763, and that CALM (now the Department of Parks and Wildlife) is prepared to accept future management of the eastern (bushland) portion of the reserve. In order for this to occur the area was surveyed and subdivided into Lots 500 and 501 on Deposited Plan 406639 so that the department manages the woodland area (Lot 501, Reserve 52237) and the City of Stirling continues to manage the Perth Horse and Pony Club (Lot 500, Reserve 28763).
