ACTION

Creation of Conservation Park over Lots 1940 – 1943 on Deposited Plan 203465.

Total Area: 669.8736 hectares

REASON FOR ACTION:

Reserve 24734, previously vested in the Water Corporation as a 'Waterway' reserve, has been of interest to the Department for a number of years. The reserve contains four main vegetation types, including the significantly under represented Perillup vegetation type and known occurrences of priority two flora *Pentapogon quadrifidus*. The reserve also contains suitable habitat for *Diurus drummondii* (DRF), *Dasyurus geofroi* (VU), *Phascogale tapoatafa* (VU) and *Cacatua pastinator pastinator* (EN), all of which have been recorded within one kilometre of the reserve.

In June 2017 a 669 hectare portion of Reserve 24734 was excised and created as a new reserve. Reserve 52970 is vested in the Conservation and Parks Commission with a purpose of 'Conservation Park'.

The Department of Environment Regulation supported the transfer of Reserve 52970 as part of an environment offset for clearing works that the Water Corporation were undertaking. The Department of Biodiversity, Conservation and Attractions does not support the use of Crown reserves for environmental offset purchases as they are not owned by the management body. In this instance the Department of Environmental Regulation and the Water Corporation had already reached agreement on the use of Reserve 52970 as an environmental offset, as such the Department was not able to oppose this deal. The Department of Mines and Petroleum also required a depth limit on this area and did not support reservation as a class 'A' nature reserve. An unclassified Conservation Park with a 200 metre depth limit was created as a compromise.

The Land Unit will work toward reservation of this area as an class 'A' nature reserve without a depth limit when the Department of Mines, Industry Regulation and Safety are more supportive of the proposal.

Reserve 52970 was created on 22 June 2017.

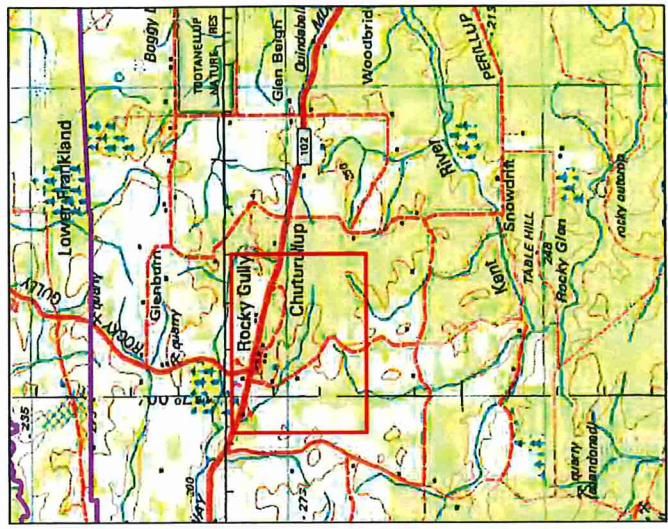
