ACTION: Creation of class A reserve over Lots 13472-13474 on Deposited Plan 240416 and Lot 100 on Deposited Plan 73871.

Total Area: 548.52ha

REASON FOR ACTION:

In 1996 areas of D'Entrecasteaux National Park were excised to facilitate the proposed development of the Jangardup South Mining Project. The project did not progress, and under Plan for Our Parks the Government committed to the reinstatement of these areas as national park.

Due to timeframes associated with the State election's caretaker period a new national park was created over Lots 13472-13474, previous national park, and Lot 100, State of WA freehold provided for conservation. Creation of a new park ensured reservation could occur prior to caretaker period.



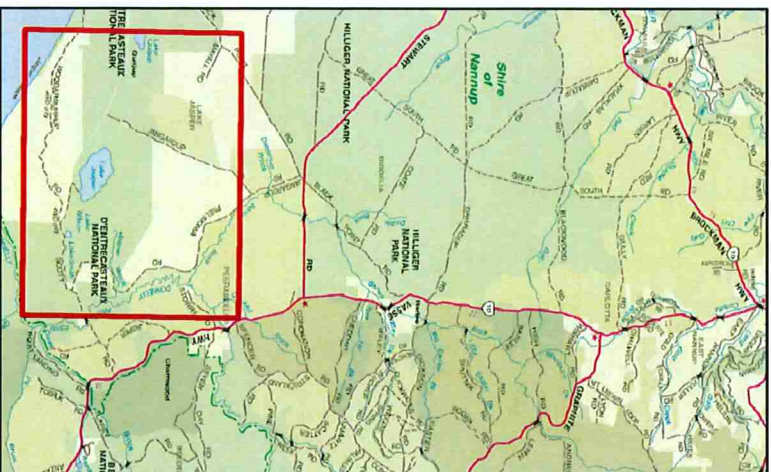

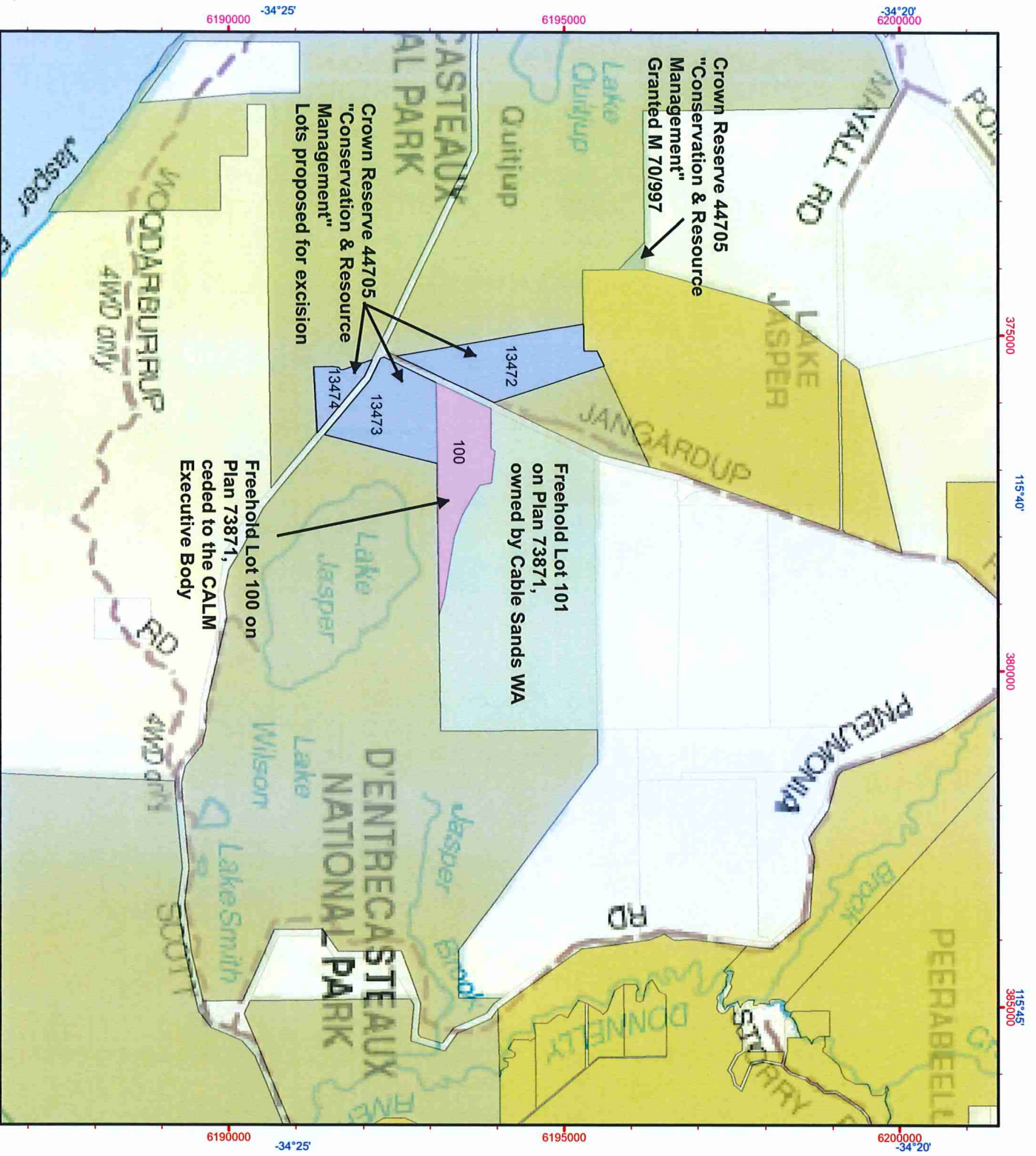
Crown Reserve 44705 and Lot 100 on Plan 73871

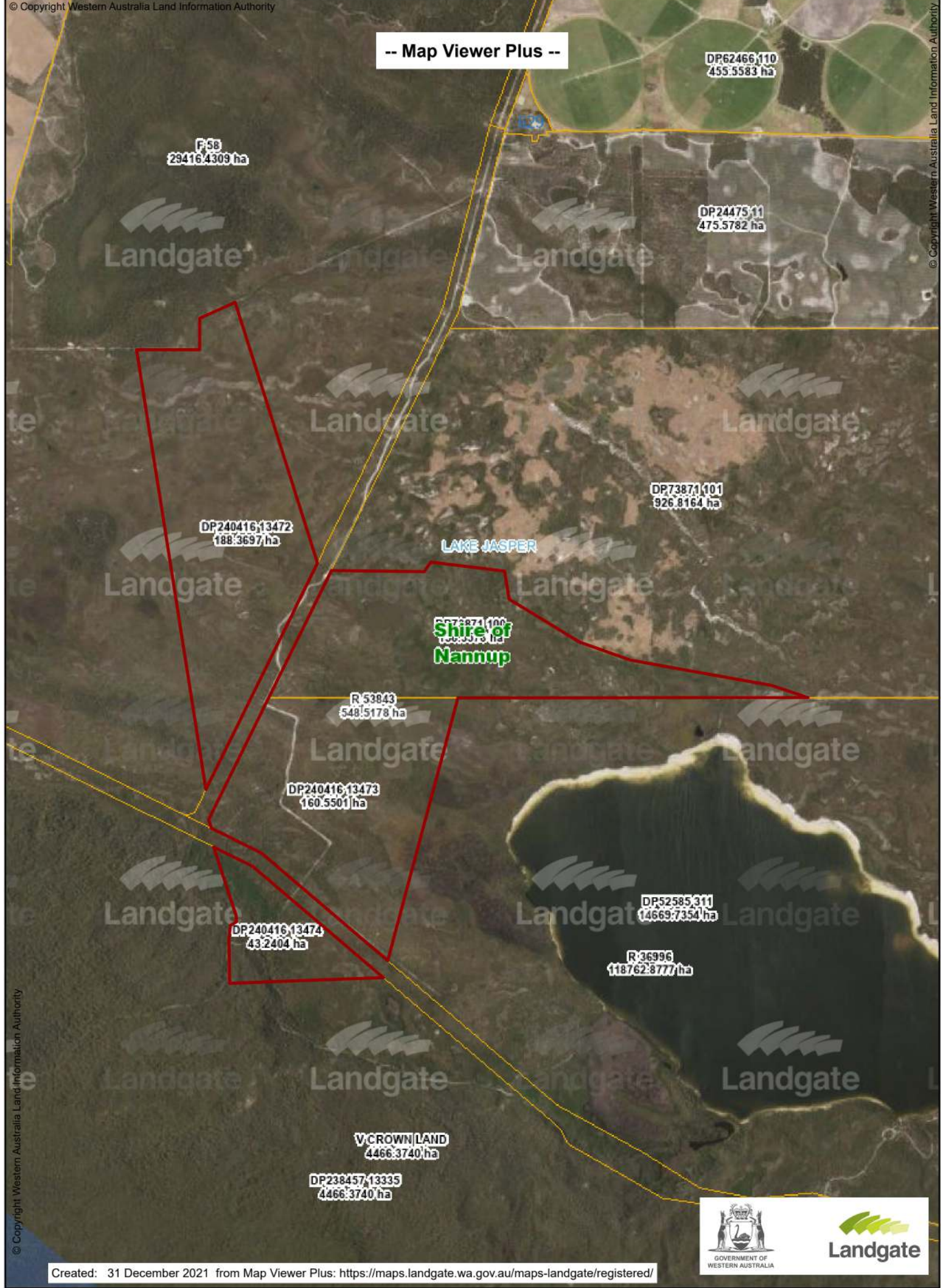
