REASON FOR ACTION The creation of a national park over Helena and Aurora Ranges is proposed under Plan for Our Parks. Lot 705 is required to be part of an Indigenous Land Use Agreement negotiation prior to progressing the development of Helena and Aurora Ranges National Park. Lot 705 was excised from Reserve 36208 to allow the areas not requiring an Indigenous Land Use Agreement to be reclassified as a class A national park.


