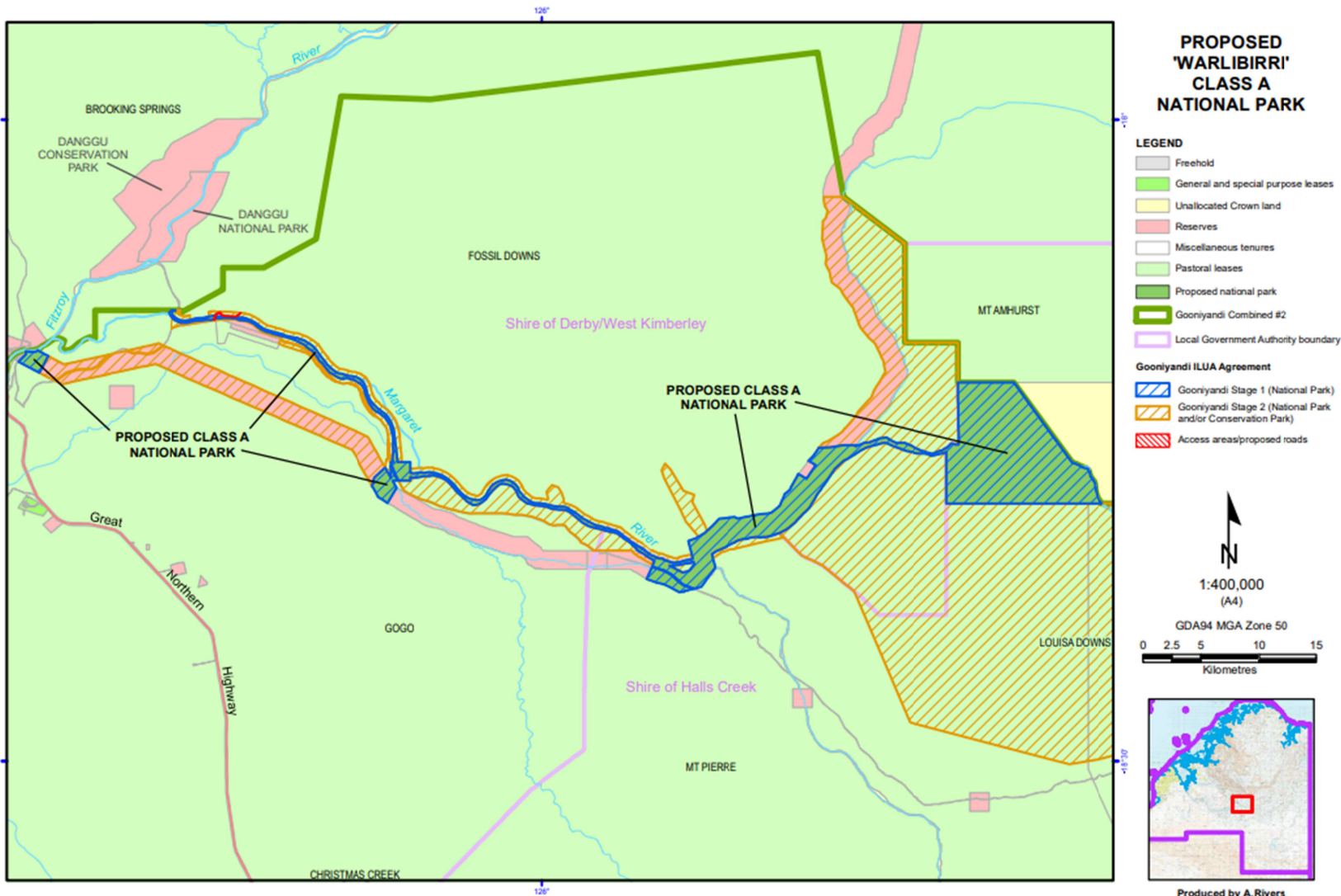

PLAN FOR OUR PARKS - FITZROY RIVER NATIONAL PARK

I write to you to request your consideration and action to create and jointly vest the Warlibirri National Park as part of the Fitzroy River National Park. The creation of the Fitzroy River National Park was a McGowan Government 2017 election commitment.

On 15 June 2021, an Indigenous Land Use Agreement (ILUA) between the State and the Gooniyandi Aboriginal Corporation (GAC) was registered for the creation of the GAC portion of the Fitzroy River National Park known as Warlibirri National Park.

In April 2020, the Fitzroy River Ministerial Council approved stage 1 of the class A national park (Attachment 1). On 14 December 2020, Cabinet approved relevant State parties to execute the GAC ILUA to create, jointly vest and jointly manage a class A national park along the Margaret River.

The areas for inclusion into the Warlibirri National Park are identified in Attachment 2, shown in the map at Attachment 3a and inset map at Attachment 3b. GAC provided a letter confirming its consent to include these areas within Warlibirri National Park (Attachment 4). The Conservation and Parks Commission (CPC) and GAC have also provided consent to the joint vesting of the Warlibirri National Park in the CPC and GAC. As per the requirements of section 8AA(2) of the *Conservation and Land Management Act 1984*, this letter is evidence of my written determination that the joint vesting should be actioned in accordance with section 45(2) and 46(1) of the *Land Administration Act 1997* (Land Administration Act).

In accordance with section 41 and 42(1) of the Land Administration Act, I request that you action the creation of a class A Warlibirri National Park, and the Department of Planning, Lands and Heritage undertake the necessary actions to create the reserve and sundry documents to endorse the Crown Lands Titles to reflect my determination of joint vesting. This letter can be lodged with Landgate's Registrar of Titles as evidence of my determination of joint vesting.

As a further update, the State is finalising ILUAs with the Bunuba and Yurriyangem Taam native title holders to complete the creation and joint vesting of the remaining areas of Fitzroy River National Park.
