NAME: Dryandra Woodland National Park

PURPOSE: National Park

VESTING: Conservation and Parks Commission

ACTION: Creation of a new Class A National Park, comprising Lots 540 to 588 on Deposited Plan 410032, an area of 15553.1076 hectares.

REASON FOR ACTION:

As recommended in the *Dryandra Woodlands Management Plan 2011* a class A national park was created over portions of State Forest No 51 (Lol Gray), No 52 (Highbury) and No 53 (Montague).

The Dryandra Woodland is located about 160 kilometres south-east of Perth in a transition zone between the heavily cleared Avon-Wheatbelt and Jarrah Forrest Bioregions. It is one of the largest and most diverse remnant bushland areas in the Wheatbelt containing populations of numbats. The new park contains existing recreational facilities including walking trails, picnic sites and camping locations.



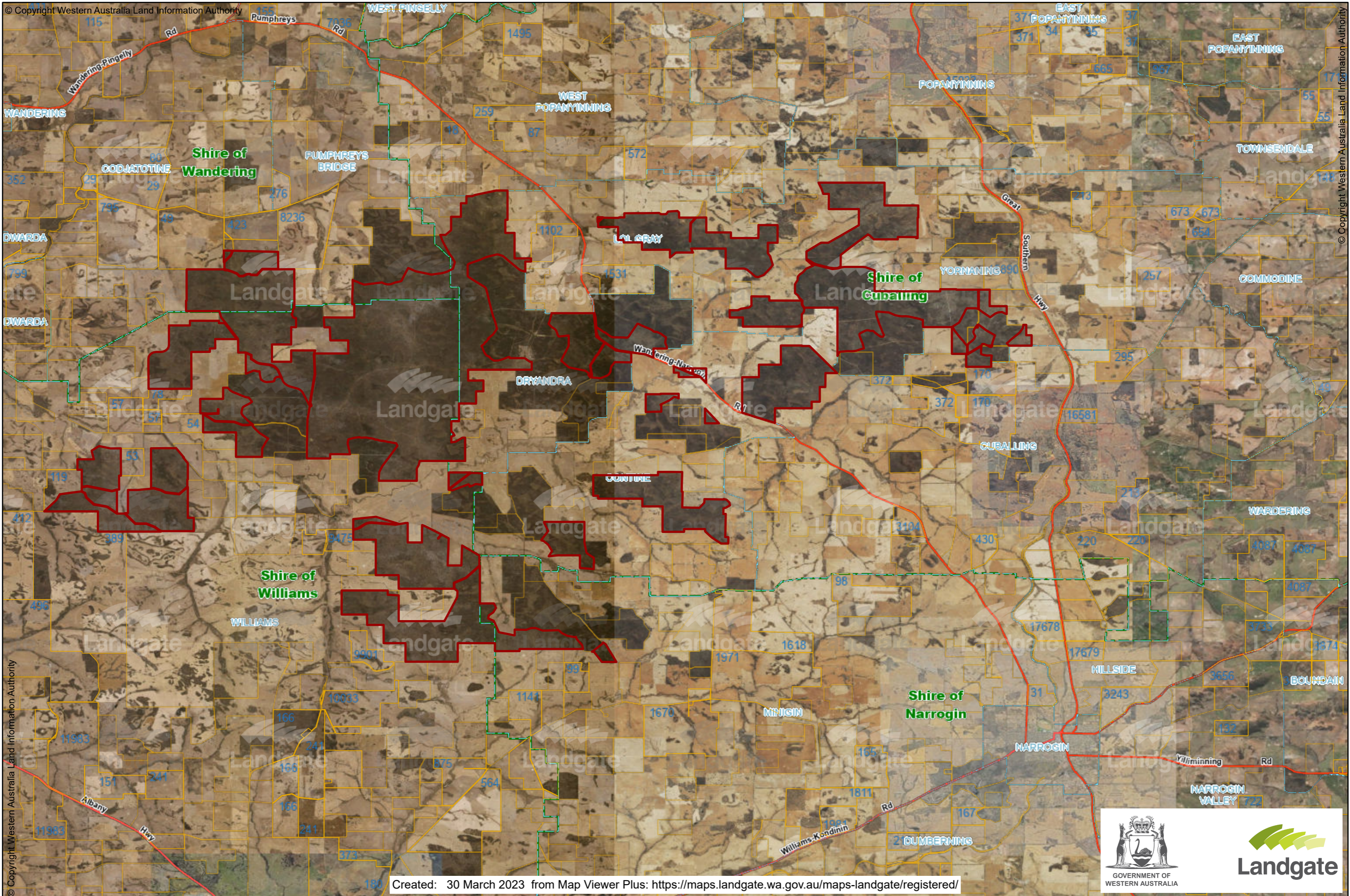

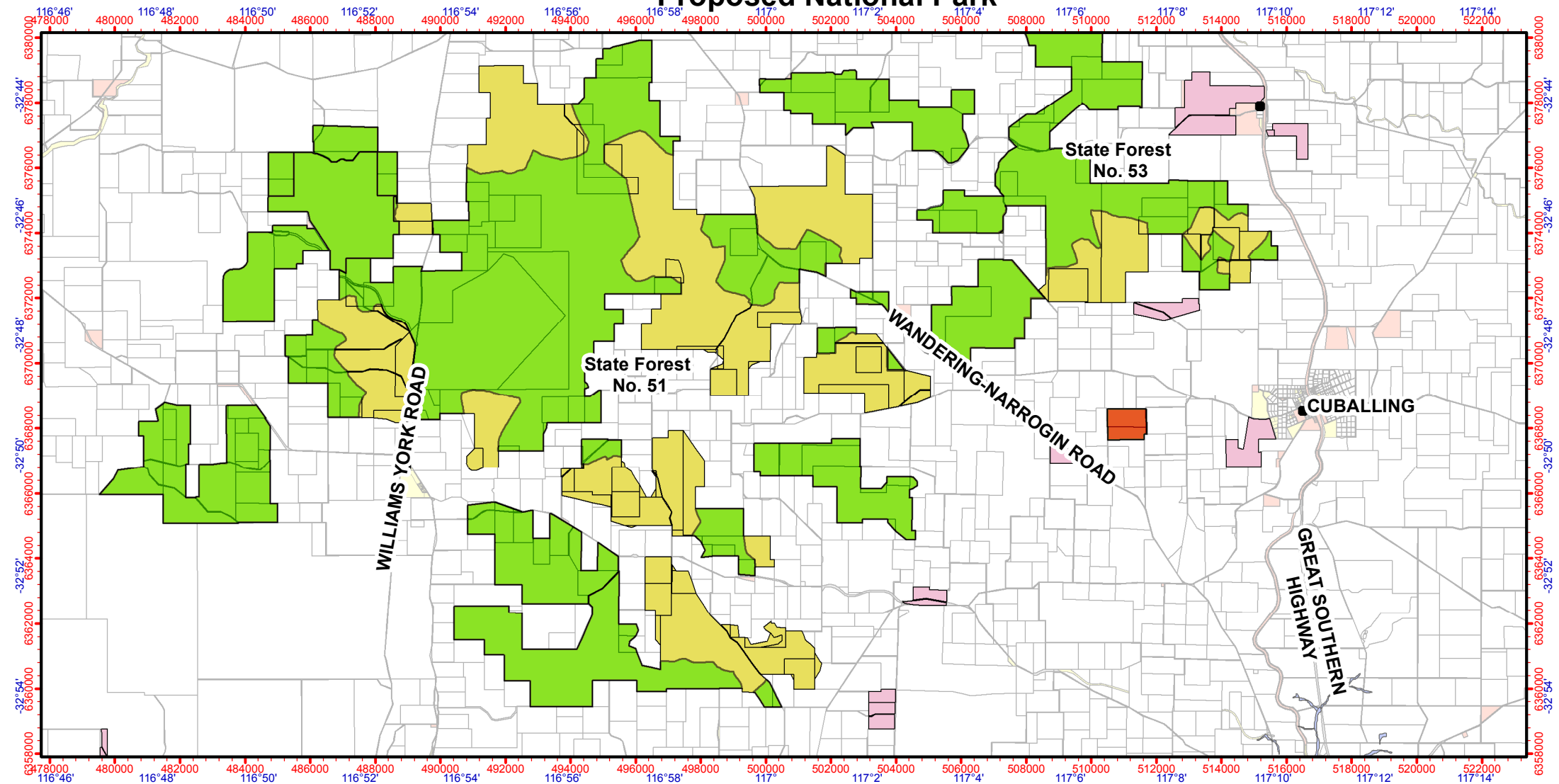

Dryandra Woodlands (1) Proposed National Park

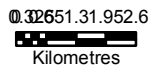

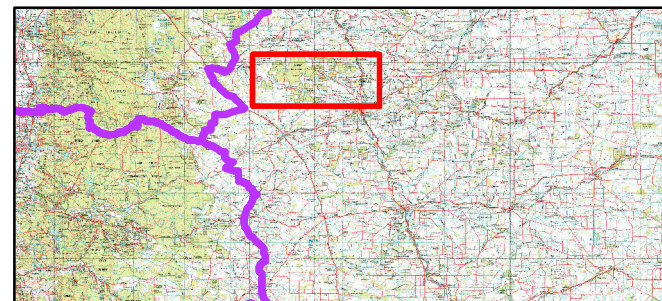
