**RESERVE No. 53912**      **LOCAL GOVERNMENT:** Shire of Kent

**NAME:** Chinocup Dam Nature Reserve

**PURPOSE:** Conservation of flora and fauna

**VESTING:** Conservation and Parks Commission

**ACTION:** Creation of nature reserve on Lot 33 on Deposited Plan 194024, Lot 8406 on Deposited Plan 155561 and Lot 8507 on Deposited Plan 220806, an area of 580.33 hectares.

**REASON FOR ACTION:** Chinocup Dam Nature Reserve A18803 was a 985 hectare reserve held by the Department of Water and Environmental Regulation for the purpose of 'Water and Conservation of Flora and Fauna'. A 580.33 hectare portion was identified as surplus to requirements and offered to the Department for management as a nature reserve. This area, now Reserve 53912, is well vegetated and contains known threatened flora and fauna. A 404.68 hectare portion of Reserve 18803 remains managed by the Department of Water and Environmental Regulation and contains infrastructure associated with water collection and extraction.

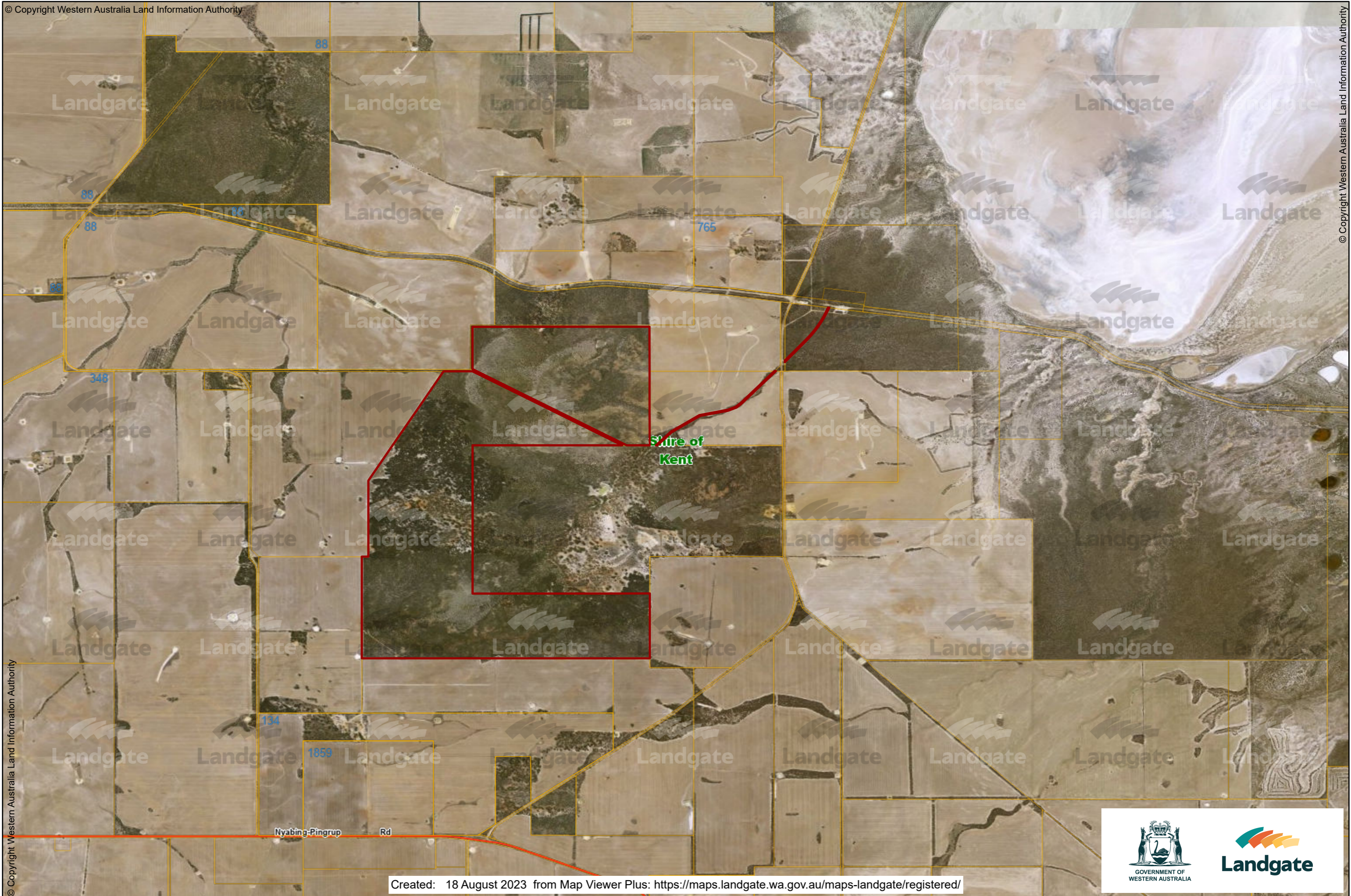
